STATEMENT OF THE ISSUES ON APPEAL

Pursuant to Fed R. Bank. Proc. 8009(a), and Rule 8009-1 of the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court Southern District of New York, Claimant 90610 (90424) ("Claimant" or "Appellant") hereby submits his designation of the record and statement of issues on appeal in connection with his appeal from the Memorandum Opinion sustaining the Debtor's Sixteenth Omnibus Objection to Claims (Dkt. No. 2516) and the related Order on the Debtor's Sixteenth Omnibus Objections to Claims (Dkt. No. 2541):

1. Did the Bankruptcy Court err in sustaining the Debtor's Sixteenth Omnibus Objection to Late Claims as to Claimants 90610 (90424) when: (i) the Debtor objected to Claimant's claims for compensation for childhood sexual abuse claiming the claims do not properly allege that it controlled the alleged abuser or entity with which the abuser was affiliated; (ii) Claimant presented evidence that the Debtor supervised and controlled the entity involved; (iii) Claimant alleged facts

which show the Debtor supervised and controlled the abuser; (iv) Claimant sufficiently alleged facts to withstand a motion to dismiss in New York State Court, where the claim was originally filed; (v) Claimant had no opportunity to conduct discovery regarding the Debtor's supervision and control of the entity; and (vi) Claimant sufficiently alleged facts to withstand a motion to dismiss under a federal pleading standard?
