PLEASE TAKE FURTHER NOTICE that among the Reserved Interests are the real property leases and licenses and right of first refusal identified on <u>Exhibit A</u> attached hereto (the "Reserved Leases/ROFR"). On <u>November 15, 2023, at 10:30 a.m. (Central Time)</u> in Room 644, 219 Dearborn Street, Chicago, Illinois, the Bankruptcy Court shall conduct a further hearing (the "Continued Sale Hearing") to consider the sale of the Sale Assets to OSF free and clear of the Reserved Interests, including any Interests of the non-Debtor parties to the Reserved

Leases/ROFR. The Continued Sale Hearing may be adjourned or rescheduled without notice by an announcement of the adjourned date at such hearing.

PLEASE TAKE FURTHER NOTICE that all objections to the sale of the Sale Assets to OSF free and clear of the Reserved Interests must be raised at or before the Continued Sale Hearing. If you intend to object to the sale of the Sale Assets free and clear of the Reserved Interests, you must appear at the Continued Sale Hearing in person.
