Upon the motion ("Motion")<sup>2</sup> of Akumin Inc., and its debtor affiliates, as debtors and debtors in possession (collectively, the "Debtors"), for entry of an order (a) extending the time within which this Court may order the appointment of a patient care ombudsman under 11 U.S.C. § 333 and (b) granting related relief, all as more fully set forth in the Motion; and upon consideration of the First Day Declaration; and this Court having jurisdiction over this matter pursuant to 28 U.S.C. § 1334; and this Court having found that this matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2); and this Court may enter a final order consistent with Article III of the United States Constitution; and venue being proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found the Debtors' notice of the Motion and opportunity for a hearing on the Motion given were appropriate under the circumstances and no other notice need

due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

1. The U.S. Trustee shall appoint an Ombudsman in these chapter 11 cases pursuant

to section 333 of the Bankruptcy Code only to the extent that the Effective Date of the Plan does

not occur on or before December 6, 2023, without prejudice the Debtors' rights to request further

extensions thereof either by agreement with the U.S. Trustee or by further motion.

2. This Court retains exclusive jurisdiction with respect to all matters arising from or

related to the implementation, interpretation, and enforcement of this order.
