Dear Creditor:

UMB Bank, N.A. serves as trustee (the “Trustee”) appointed by the United States Bankruptcy Court for the Southern District of Texas (the “Bankruptcy Court”) under the *Second Amended Joint Chapter 11 Plan of Serta Simmons Bedding, LLC and Its Affiliated Debtors* (as confirmed, the “Plan”)¹ to administer the Serta Simmons Class 6B Trust (the “Trust”). The Plan was confirmed in the chapter 11 cases of Serta Simmons Bedding, LLC and its affiliates (the “Debtors”)² by order of the Bankruptcy Court that became effective on June 29, 2023, on which date the Trust was established.

The Trust is a grantor, liquidating trust and, as such, needs your taxpayer identification number (“TIN”) to be able to fulfill its tax reporting obligations under IRS Revenue Procedure 94-45, 1994-2 C.B. 684, and U.S. Treasury Regulations sections 1.671-4(a) and 301.7701-4(d). For that reason, among others, the Plan and its ancillary documents provide that the Trustee may require holders of claims under the Plan to complete and return to the Trust an appropriate tax form evidencing such holder’s TIN, which is a prerequisite to any holder of an unsecured claim against the Debtors receiving any distribution from the Trust.

Accordingly, we write to request that you complete the enclosed IRS Form W-9 (or, if applicable, complete an IRS Form W-8 for non-U.S. creditors) supplying your TIN and other relevant information, and send or upload the completed form to the Trust at either the mailing address or secure website set forth on the reverse side of this letter.

If you are unsure of your TIN or need help completing the Form W-9 (or, if applicable, Form W-8), please consult with your tax advisor. Please understand that the Trustee requires your completed Form W-9 (or, if applicable, completed Form W-8), including your TIN, before making any distribution to you. **Also, please be advised that the fact that you are receiving this letter does not mean that your claim has been “Allowed” or is presently entitled to a distribution as the process for reconciling claims is not complete. The Trust does not expect distributions to occur any sooner than the end of calendar year 2024.**

Completing the Form

- Please be sure to use a current IRS form. For Form W-9 (U.S. taxpayers), the latest version was issued by the IRS in October 2018. Older versions of IRS tax forms will not be accepted. Additional copies of IRS forms are available at: (i) for Form W-9, <https://www.irs.gov/forms-pubs/about-form-w9>; and (ii) for Form W-8 (non-U.S. taxpayers), <https://www.irs.gov/forms-pubs/about-form-w8>.
- The deadline under the Plan to respond to this request is **May 15, 2024** (within 180 days of the date of this letter). **If you fail to send the completed form timely, you risk forfeiting your right**

to all distributions from the Trust. Therefore, the Trust urges that you respond to this request at your earliest opportunity.

- If the taxpayer name that you indicate on Line 1 of your Form W-9 (or, if applicable, W-8) is different from the name to which this mailing is addressed, please write the addressee name at the very top of the tax form you are returning so that we can match the forms we receive to the holders of claims against the Debtors, as listed on the Trust's records.
- Please remember to sign and date your form.

Transmitting the Form

The Trust will accept tax forms (i) by upload to a secure web site hosted by META Advisors LLC, or (ii) by United States mail. Uploading tax forms is strongly encouraged. Please do not fax or email the completed tax form, because those are not secure methods to transmit or receive the form.

To do so, you must create a free account by (i) locating your claim on the META web site; and (ii) establishing an account with a username and login. There is no cost to you in establishing an account. After you upload your form, you should associate the form with your claim.

As noted above, the Trustee must receive your current executed Form W-9 (or, if applicable, Form W-8) within 180 days of the date of this letter. Under the terms and conditions of the trust agreement and the Plan, failure to provide a current executed form by such date will result in a forfeiture of your right to receive any distribution from the Trust under the Plan. Any such forfeited distribution will revert to the Trust for distribution to other creditors that are beneficiaries of the Trust, and your claim will be discharged and barred without further order of the Bankruptcy Court.

Additionally, if your address changes, it is your responsibility to notify the Trust. If a distribution check is returned to the Trust because of an incorrect address and you do not provide a correct address, eventually your right to a distribution will be forfeited under the relevant provisions of the Plan.
