SUPPLEMENTAL DECLARATION OF ART DEJONG IN SUPPORT OF DEBTORS' APPLICATION FOR ENTRY OF AN ORDER TO RETAIN AND EMPLOY ERNST & YOUNG LLP AS TAX SERVICES PROVIDER

I, Art DeJong, hereby declare pursuant to Rule 2014(a) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") as follows:

- 1. I am a Managing Director of EY US LLP. ² I provide this supplemental declaration (the "<u>Supplemental Declaration</u>") on behalf of Ernst & Young LLP ("<u>EY LLP</u>") in support of the application (the "<u>Application</u>") of the above-captioned debtors (the "<u>Debtors</u>") to retain EY LLP as their tax services provider effective as of October 22, 2023 (the "<u>Petition Date</u>"). This Supplemental Declaration supplements my declaration that was filed with this Court on November 14, 2023 [Docket No. 192] (the "<u>Initial Declaration</u>").
- 2. The facts set forth in this Supplemental Declaration are based upon my personal knowledge, upon information and belief, and upon client matter records kept in the ordinary course

of business that were reviewed by me or professionals of EY LLP and EY US LLP or employees of other member firms of EYGL under my supervision and direction.

- 3. After the Initial Declaration was filed, EY LLP continued to follow up with respect to certain Parties in Interest to determine whether any of them are currently engaging or have engaged during the last three years EY LLP or any other EYGL member firm. The disclosure schedule annexed hereto as Exhibit 1 lists the names of all of the Parties in Interest and whether a client engagement has been initiated in the Database during the last three years by EY LLP or any other EYGL member firm.
- 4. To the best of my knowledge, information and belief based on the information set forth in the Database, none of the services rendered to Parties in Interest by EY LLP or any other EYGL member firm have been in connection with the Debtors or these chapter 11 cases, except as otherwise stated herein or in the Initial Declaration.
- 5. Additionally, paragraph 24 of the Initial Declaration disclosed that "In January 2022, EY US LLP, along with Akumin, Inc. and certain Akumin, Inc. officers and directors, were named in a Canadian securities class action filed in the Ontario Superior Court of Justice."
- 6. On November 30, 2023, this Court entered its Findings of Fact, Conclusions of Law, and Order (i) Approving Disclosure Statement on a Final Basis and (ii) Confirming the Joint Prepackaged Chapter 11 Plan of Reorganization of Akumin Inc. and Its Debtor Affiliates [Docket No. 272] (the "Confirmation Order"). Paragraph 24(d) of the Confirmation Order addressed in further detail the aforementioned Canadian securities class action and certain related rights and obligations of the parties thereto, including EY LLP.
- 7. I believe that EY LLP remains disinterested and eligible for retention by the Debtors in these Chapter 11 Cases.

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge, information and belief.
