**SUPPLEMENTAL DECLARATION OF ARI LEFKOVITS
IN SUPPORT OF DEBTORS' APPLICATION FOR ENTRY OF AN
ORDER (A) AUTHORIZING THE EMPLOYMENT AND RETENTION OF
LAZARD FRÈRES & CO. LLC AS INVESTMENT BANKER *NUNC PRO TUNC* TO
THE PETITION DATE, (B) MODIFYING CERTAIN TIME-KEEPING
REQUIREMENTS, AND (C) GRANTING RELATED RELIEF**

I, Ari Lefkovits, declare pursuant to 28 U.S.C. § 1746, under penalty of perjury, to the best of my knowledge, information, and belief, that:

1. I am a Managing Director of the firm of Lazard Frères & Co. LLC ("**Lazard**"), which has its principal office at 30 Rockefeller Plaza, New York, New York, 10020. I am

authorized to execute this declaration (the “**Declaration**”) on behalf of Lazard. Unless otherwise stated in this Declaration, I have personal knowledge of the facts set forth herein.²

2. On December 12, 2023, the Debtors filed the *Application for Entry of an Order (A) Authorizing the Employment and Retention of Lazard Frères & Co. LLC as Investment Banker Nunc Pro Tunc to the Petition Date, (B) Modifying Certain Time-Keeping Requirements, and (C) Granting Related Relief* [ECF No. 44] (the “**Application**”).³

3. In connection with the Application, I submitted an initial declaration (the “**Initial Declaration**”) describing Lazard’s connections to the Debtors and the names of individuals and entities that may be parties in interest in these Chapter 11 Cases (the “**Potential Parties in Interest**”). The Initial Declaration was appended to the Application as Exhibit B and is incorporated by reference. To the extent that certain Potential Parties in Interest (or any of their known or apparent affiliates) entered into any such engagement agreements with Lazard within the last three years, those parties were identified on Schedule 2 to the Initial Declaration.

4. In addition, as described in paragraph 15 of the Initial Declaration, Lazard performed an additional search to cross-reference the list of Potential Parties in Interest with the issuer names listed on the most recent Form 13F Filings of the Asset Management Affiliates. Schedule 3 of the Initial Declaration identifies those issuers of Section 13(f) securities that were included on Form 13F Filings dated as of September 30, 2023, where either that issuer is a Potential Party in Interest and/or a known or apparent affiliate of that issuer is a Potential Party in Interest.

5. Subsequent to the filing of the Initial Declaration, Lazard received a supplement to the Potential Parties in Interest List from the Debtors’ counsel (the “**Supplemental Potential**

Parties in Interest”). Lazard has compared the names of the Supplemental Potential Parties in Interest with the names of current and former investment banking clients that have entered into engagement agreements with Lazard in the last three years. To the extent that this inquiry revealed that any of the Supplemental Potential Parties in Interest (or their apparent affiliates or entities that Lazard believes to be affiliates, as the case may be) are current or former investment banking clients that entered into any such engagement agreements with Lazard within the last three years, Lazard has included such parties on **Schedule 2** attached hereto. To the best of my knowledge, information, and belief, Lazard’s representation of each entity listed on **Schedule 2** (or any of their known or apparent affiliates) was or is only on matters that are unrelated to the chapter 11 cases. Other than as listed on **Schedule 2**, to the best of my knowledge, information, and belief, I am unaware of any engagements that have been entered into by Lazard and the Supplemental Potential Parties in Interest within the last three years.

6. Given the size of Lazard and the breadth of Lazard’s client base and the large volume of the Supplemental Potential Parties in Interest, it is possible that Lazard may have in the past entered into engagement agreements with one or more of the Supplemental Potential Parties in Interest in unrelated matters without my knowledge or may in the future enter into engagement agreements with one or more of the Supplemental Potential Parties in Interest in unrelated matters without my knowledge. Lazard has disclosed all such connections of which it is aware in the Initial Declaration and this Declaration. Upon receipt from the Debtors and their representatives of additional names of individuals and entities that may be potential parties in interest in these chapter 11 cases, I will supplement this Declaration.

7. In addition, Lazard performed an additional search to cross-reference the list of Supplemental Potential Parties in Interest with the issuer names listed on the most recent Form

13F Filings of the Asset Management Affiliates. Attached hereto as **Schedule 3** are those issuers of Section 13(f) securities that were included on Form 13F Filings dated as of September 30, 2023, where either that issuer is a Supplemental Potential Party in Interest and/or a known or apparent affiliate of that issuer is a Supplemental Potential Party in Interest. As such, Lazard confirms that it has performed conflicts check through Lazard's electronic database containing the names of Lazard's current and former investment banking clients and has performed additional cross-reference search of issuers of Section 13(f) securities included in Form 13F Filings of Lazard Asset Management LL, Lazard Freres Gestion SAS, and Edgewater HoldCo LLC.
