ORDER (I) AUTHORIZING THE DEBTORS TO PAY CERTAIN PREPETITION AND POSTPETITION TAXES AND FEES, (II) AUTHORIZING THE PAYMENT OF SERVICE FEES, AND (III) GRANTING RELATED RELIEF

[Relates to the Motion at Docket No. 12]

Upon the emergency motion (the "Motion")² of the Debtors for an order (i) authorizing the Debtors, in their reasonable discretion, to pay (or use tax credits to offset) the Taxes and Fees that accrued prior to the Petition Date, (ii) authorizing the Debtors, in their reasonable discretion, to pay (or use tax credits to offset) the Taxes and Fees that arise or accrue in the ordinary course of business on a postpetition basis, (iii) authorizing the Debtors, in their reasonable discretion, to add any Taxing Authorities to Exhibit A hereto to the extent that the Debtors subsequently identify any additional governmental or quasi-governmental entities to which the Debtors owe Taxes and Fees, (iv) authorizing the payment of any prepetition Service Fees, and (v) granting related relief, all as more fully set forth in the Motion; and the Court having reviewed the Motion and the First Day Declaration; and the Court having determined that the relief requested in the Motion is in the

best interests of the Debtors, their estates, their creditors, and other parties in interest; and the Court having jurisdiction to consider the Motion and the relief requested therein in accordance with 28 U.S.C. § 1334; and the Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2) and that this Court may enter a final order consistent with Article III of the United States Constitution; and the Court having found that venue of this proceeding and the Motion in this district is proper pursuant to 28 U.S.C. § 1408; and the Court having found that the Debtors provided appropriate notice of the Motion and the opportunity for a hearing on the Motion under the circumstances and that no other or further notice is necessary; and the Court having determined that the legal and factual bases set forth in the Motion and the hearing with respect to the Motion establish just cause for the relief granted herein; and after due deliberation thereon; and good and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

- 1. The Debtors are authorized, but not directed, in their reasonable discretion, to (a) remit and pay (or use tax credits to offset) to the Taxing Authorities all amounts owed on account of the Taxes and Fees for the period prior to the Petition Date, and (b) remit and pay (or use tax credits to offset) to the Taxing Authorities all amounts owed on account of the Taxes and Fees that arise or accrue on a postpetition basis, in each case, in the ordinary course of business and solely to the extent that such Taxes and Fees are payable in accordance with applicable law.
- 2. The Debtors are authorized, but not directed, in consultation with the First Lien Ad Hoc Group, to add any Taxing Authorities to Exhibit A attached hereto, to the extent that the Debtors subsequently identify any additional governmental or quasi-governmental entities to which the Debtors owe Taxes and Fees. To the extent that the Debtors have overpaid any Taxes and Fees, the Debtors are authorized to seek a refund or credit.

- 3. The Debtors are authorized, but not directed, to (a) pay prepetition Service Fees to the Payment Processor and to continue to pay postpetition Service Fees in the ordinary course of business, and (b) continue to utilize the Payment Processor to pay certain Taxes and Fees on a postpetition basis consistent with prepetition practices.
- 4. Notwithstanding the relief granted in this Order and any actions taken pursuant to such relief, nothing in the Motion or this Order shall be deemed: (a) an implication or admission as to the amount of, basis for, or validity of any claim against any of the Debtors under the Bankruptcy Code or other applicable nonbankruptcy law; (b) a waiver of any Debtor's or any other party in interest's rights to dispute any claim on any grounds; (c) an assumption, adoption, or rejection of any agreement, contract, or lease under section 365 of the Bankruptcy Code; (d) an implication or admission that any particular claim is of a type specified or defined in the Motion, this Order or any order granting the relief requested by the Motion; (e) an admission as to the validity, enforceability, or perfection of any lien on, security interest in, or other encumbrance on property of any Debtor's estate; (f) a waiver of any Debtor's or any other party in interest's rights under the Bankruptcy Code or any other applicable law; or (g) a waiver of any claims or causes of action which may exist against any entity.
- 5. The banks and financial institutions on which checks were drawn or electronic payment requests made in payment of the prepetition obligations approved herein are authorized to receive, process, honor, and pay all such checks and electronic payment requests when presented for payment, and all such banks and financial institutions are authorized to rely on the Debtors' designation of any particular check or electronic payment request as approved by this Order, and the Debtors are authorized to replace any prepetition checks or electronic transfers relating to the prepetition obligations approved herein that may be dishonored or rejected.

- 6. Notwithstanding anything to the contrary contained in the Motion or this Order, any payment to be made and any relief or authorization granted hereunder shall be subject to the requirements imposed on the Debtors in any orders entered by this Court authorizing the Debtors to obtain postpetition financing and/or use cash collateral (any such order, a "DIP Order"), including, for the avoidance of doubt, the debtor-in-possession financing budget. To the extent of any conflict (but solely to the extent of such conflict) between the terms of this Order and the terms of any DIP Order, the terms of the DIP Order will govern.
- 7. The Debtors shall maintain a matrix/schedule of payments made pursuant to this Order prior to confirmation of a plan of reorganization that includes the following information:

 (a) the names of the payees; (b) the dates of payment; (c) the amount of the payments;

 (c) the category or type of payments; and (d) the Debtor or Debtors that made the payments. The Debtors shall provide a copy of such matrix/schedule to the U.S. Trustee, counsel to the First Lien Ad Hoc Group, counsel to the Second Lien Ad Hoc Group, and any statutory committee appointed in these Chapter 11 Cases on the last day of each month for the prior month's payments.
- 8. Authorizations given to the Debtors in this Order empower but do not direct the Debtors to effectuate the payments specified herein. The Debtors retain the business judgment to make or not make such payments. All payments are subject to the condition that funds are available to effect any payment and in no event shall any person (Debtor, officer, director or otherwise) be personally liable for any amounts authorized for payment herein but not paid.
 - 9. The contents of the Motion satisfy the requirements of Bankruptcy Rule 6003(b).

10. Notice of the Motion as provided therein shall be deemed good and sufficient notice

of such Motion and the requirements of Bankruptcy Rule 6004(a) and the Bankruptcy Local Rules

are satisfied by such notice.

11. Notwithstanding any Bankruptcy Rule to the contrary, this Order shall take effect

immediately upon its entry.

12. The Debtors are authorized to take all reasonable actions necessary to effectuate

the relief granted in this Order in accordance with the Motion.

13. This Court retains exclusive jurisdiction with respect to all matters arising from or

related to the implementation, interpretation, and enforcement of this Order.
