ORDER (I) AUTHORIZING THE DEBTORS TO REJECT CERTAIN EXECUTORY CONTRACTS PURSUANT TO 11 U.S.C. § 365, AND (II) GRANTING RELATED RELIEF

(Related Docket No. 221)

Upon consideration of the motion (the "Motion")² of the above-captioned debtors and debtors in possession (the "Debtors") for entry of an order, pursuant to section 365 of title 11 of the United States Code (the "Bankruptcy Code"), authorizing the Debtors to reject the Rejected Contracts as of the Petition Date; and it appearing that this Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334; and it appearing that this proceeding is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and this Court having found that it may enter a final order consistent with Article III of the United States Constitution; and this Court having found that venue of this proceeding and the Motion in this district is proper pursuant to 28 U.S.C. § 1408 and 1409; and adequate notice of the Motion having been given; and it appearing that no other notice need be given; and after due deliberation and sufficient cause appearing therefore,

IT IS HEREBY ORDERED THAT:

1. The Motion is **GRANTED**.

2. All contracts between the Debtors and the Counterparties identified on **Exhibit A** hereto are hereby deemed rejected, effective as of September 11, 2023.

3. Within three (3) business days after entry of this Order, the Debtors will serve this Order on the Counterparties to each Rejected Contract.

4. The deadline for counterparties to assert any claims related to the rejection of the Rejected Contracts shall be thirty (30) days after entry of this Order.

5. Notice of the Motion and the rejection of the Rejected Contracts as provided for in the Motion shall be deemed good and sufficient notice of the Motion, and all the requirements of the Bankruptcy Code and Bankruptcy Rules have been fully satisfied thereby.

6. The Debtors reserve all rights to contest any such claim and to contest the characterization of each Rejected Contract, as executory or not.

7. The Debtors do not waive any claims that the Debtors may have against the Counterparty to any Rejected Contract, whether or not such claims are related to such Rejected Contract.

8. Notwithstanding the possible applicability of Rules 6004(g), 7062, or 9014 of the Federal Rules of Bankruptcy Procedure, or otherwise, the terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

9. The Debtors are authorized to take all actions necessary or appropriate to effectuate the relief granted pursuant to this Order in accordance with the Motion.
