Upon the motion (the “**Motion**”) of Audacy, Inc. and its affiliated companies (the “**Debtors**”),² on January 31, 2024, the United States Bankruptcy Court for the Southern District of Texas (the “**Bankruptcy Court**”), having jurisdiction over the chapter 11 cases of the Debtors, captioned as *In re Audacy, Inc., et al.*, No. 24-90004 (the “**Chapter 11 Cases**”), entered a final order establishing procedures (the “**Procedures**”) with respect to transfers of, and claims of worthless stock deductions by a Majority Stockholder (as defined herein) with respect to, its beneficial ownership (including direct and indirect ownership) of Class A common stock and/or Class B common stock issued by Audacy, Inc., including options to acquire beneficial ownership of such common stock (collectively, the “**Common Stock**”).

In certain circumstances, the Procedures restrict (i) transactions involving, and require notices of the holdings of and proposed transactions by, any person, group of persons, or entity that is or, as a result of such a transaction, would become a Substantial Stockholder of the Common Stock (including options to acquire beneficial ownership of the Common Stock) and (ii) claims by any Majority Stockholder of a worthlessness deduction under section 165 of the Internal Revenue Code of 1986, as amended, with respect to its beneficial ownership of the Common Stock. For purposes of the Procedures, a “**Substantial Stockholder**” is any person or entity (within the meaning of applicable regulations promulgated by the U.S. Department of the Treasury, including certain persons making a coordinated acquisition of stock) that beneficially owns, directly or indirectly (and/or owns options to acquire) at least 217,878 shares of Common Stock (representing

approximately 4.5% of all issued and outstanding shares of Common Stock, and determined by taking into account shares of Class A common stock and Class B common stock on an aggregate basis), and a **“Majority Stockholder”** is any person that beneficially owns at least 2,420,869 shares of Common Stock (representing approximately 50% of all issued and outstanding shares of Common Stock, and determined by taking into account shares of Class A common stock and Class B common stock on an aggregate basis) or any person that would be a “50-percent shareholder” (within the meaning of section 382(g)(4)(D) of the Internal Revenue Code of 1986, as amended) of Common Stock if such person claimed a worthless stock deduction with respect to its beneficial ownership of such securities. ***Any prohibited acquisition or other transfer of, or claim of a worthless stock deduction with respect to, beneficial ownership of Common Stock (including indirectly or through the grant or transfer of options to acquire beneficial ownership of Common Stock) will be null and void ab initio and may lead to contempt, compensatory damages, punitive damages, or sanctions being imposed by the Bankruptcy Court.***
