THIRD SUPPLEMENTAL DECLARATION OF PATRICK J. NASH, JR. IN SUPPORT OF THE DEBTORS' APPLICATION FOR ENTRY OF AN ORDER AUTHORIZING THE RETENTION AND EMPLOYMENT OF KIRKLAND & ELLIS LLP AND KIRKLAND & ELLIS INTERNATIONAL LLP AS ATTORNEYS FOR THE DEBTORS AND DEBTORS IN POSSESSION EFFECTIVE AS OF AUGUST 6, 2023

- I, Patrick J. Nash, Jr., being duly sworn, state the following under penalty of perjury:
- 1. I am the president of Patrick J. Nash, Jr., P.C., a partner of the law firm of Kirkland & Ellis LLP, located at 300 North La Salle Street, Chicago, Illinois 60654, and a partner of Kirkland & Ellis International, LLP (together with Kirkland & Ellis LLP, collectively, "Kirkland"). I am one of the lead attorneys from Kirkland working on the above-captioned chapter 11 cases. I am a member in good standing of the Bar of the State of Illinois, and I have been admitted to practice in the U.S. Court of Appeals for the Sixth Circuit, the U.S. District Court for the Northern District of Illinois, and the U.S. District Court for the Eastern District of Michigan. There are no disciplinary proceedings pending against me.

- 2. On August 6, 2023, (the "Petition Date"), each of the above-captioned debtors and debtors in possession (collectively, the "Debtors") filed a petition with this Court under chapter 11 of title 11 of the United States Code (the "Bankruptcy Code"). On August 30, 2023, the Debtors filed an application to employ and retain Kirkland as counsel for the Debtors [Docket No. 371] (the "Application") pursuant to sections 327(a) and 330 of the Bankruptcy Code, rules 2014(a) and 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), and rules 2014-1 and 2016-1 of the Local Bankruptcy Rules for the District of Delaware (the "Local Rules").
- 3. My declaration in support of the Application (the "Original Declaration") was attached to the Application as Exhibit B. On September 22, 2023, the Court entered the Order Authorizing the Retention and Employment of Kirkland & Ellis LLP and Kirkland & Ellis International LLP as Attorneys for the Debtors and Debtors in Possession Effective as of August 6, 2023 [Docket No. 639] (the "Retention Order").
- 4. On September 21, 2023, the Debtors filed the First Supplemental Declaration of Patrick J. Nash, Jr. in Support of the Debtors' Application for Entry of an Order Authorizing the Retention and Employment of Kirkland & Ellis LLP and Kirkland & Ellis International LLP as Attorneys for the Debtors and Debtors in Possession Effective as of August 6, 2023 [Docket No. 626] (the "First Supplemental Declaration"). On December 14, 2023, the Debtors filed the Second Supplemental Declaration of Patrick J. Nash, Jr. in Support of the Debtors' Application for Entry of an Order Authorizing the Retention and Employment of Kirkland & Ellis LLP and Kirkland & Ellis International LLP as Attorneys for the Debtors and Debtors in Possession Effective as of August 6, 2023 [Docket No. 1373] (the "Second Supplemental Declaration," and, together with the Original Declaration and the First Supplemental Declaration, the "Prior Declarations").

5. In connection with the Application and the Retention Order, I submit this third supplemental declaration (this "<u>Third Supplemental Declaration</u>") to provide additional disclosures in accordance with Bankruptcy Rules 2014(a) and 2016(b). Unless otherwise stated in this Third Supplemental Declaration, I have personal knowledge of the facts set forth herein.

Additional Disclosures

6. As set forth in the Original Declaration, Kirkland has searched its electronic database of representations for connections to parties in interest in these chapter 11 cases. Certain connections were disclosed in the Prior Declarations. Since the Petition Date, Kirkland has updated those conflicts searches and has searched additional parties as Kirkland has become aware of additional parties in interest in these chapter 11 cases. In addition to the entities searched and disclosed in the Application, Kirkland has searched its electronic database for the entities listed on **Schedule 1**, attached hereto. The following is a list of the additional categories that Kirkland has searched:

7. I have included the results of Kirkland's conflicts searches of the above-listed entities on **Schedule 2** to this Third Supplemental Declaration. Listed on **Schedule 3** to this Third

Kirkland's inclusion of parties in the following schedules is solely to illustrate Kirkland's conflict search process and is not an admission that any party has a valid claim against the Debtor or that any party properly belongs in the schedules or has a claim or legal relationship to the Debtor of the nature described in the schedules.

As referenced in <u>Schedule 2</u> and <u>Schedule 3</u>, the term "current client" means an entity listed as a client in Kirkland's conflicts search system to whom time was posted in the 12 months preceding the Petition Date. As referenced in <u>Schedule 2</u> and <u>Schedule 3</u>, the term "former client" means an entity listed as a client in Kirkland's conflicts search system to whom time was posted between 12 and 36 months preceding the Petition Date. As

Supplemental Declaration are new client connections for entities identified in the Original Declaration. All current and prior representations of the parties identified on <u>Schedule 2</u> and **Schedule 3** are in matters unrelated to the Debtor and these chapter 11 cases.

- 8. Based on the conflicts searches conducted to date, to the best of my knowledge, neither I, Kirkland, nor any partner, of counsel, or associate thereof, insofar as I have been able to ascertain, has any connections with the Debtors or any party in interest in these chapter 11 cases except as disclosed or otherwise described in this Third Supplemental Declaration and in the Prior Declarations.
- 9. Generally, it is Kirkland's policy to disclose entities in the capacity that they first appear in the conflicts search. For example, if an entity has already been disclosed in the Prior Declarations in one capacity (*e.g.*, a customer), and the entity appears in the subsequent conflicts search in a different capacity (*e.g.*, a vendor), Kirkland does not disclose the same entity again in supplemental declarations, unless the circumstances are such in the latter capacity that additional disclosure is required.
- 10. As disclosed on <u>Schedule 2</u> and <u>Schedule 3</u>, Kirkland currently represents, and in the past has represented certain of the Debtors' customers and their affiliates (collectively, the "<u>Customers</u>") on a variety of matters. Kirkland's current and former representations of the Customers have been in matters unrelated to the Debtors or these chapter 11 cases. Kirkland has not represented, and will not represent, any of the Customers in connection with any matter in

referenced in <u>Schedule 2</u> and <u>Schedule 3</u>, the term "closed client" means an entity listed as a client in Kirkland's conflicts search system to whom time was posted in the 36 months preceding the Petition Date, but for which the client representation has been closed. Whether an actual client relationship exists can only be determined by reference to the documents governing Kirkland's representation rather than its potential listing in Kirkland's conflicts search system. The list generated from Kirkland's conflicts search system is over-inclusive. As a general matter, Kirkland discloses connections with "former clients" or "closed clients" for whom time was posted in the last 36 months, but does not disclose connections if time was billed more than 36 months before the Petition Date.

these chapter 11 cases during the pendency of these chapter 11 cases. I do not believe that Kirkland's current or former representation of the Customers precludes Kirkland from meeting the disinterestedness standard under the Bankruptcy Code.

11. Kirkland will continue to review its files periodically during the pendency of these chapter 11 cases to ensure that no conflicts or other disqualifying circumstances exist or arise. If any new relevant facts or relationships are discovered or arise, Kirkland will use reasonable efforts to identify such further developments and will promptly file an additional supplemental declaration, as required by Bankruptcy Rule 2014(a).

Affirmative Statement of Disinterestedness

12. Based on the conflicts search conducted to date and described herein, to the best of my knowledge and insofar as I have been able to ascertain, (a) Kirkland is a "disinterested person" within the meaning of section 101(14) of the Bankruptcy Code, as required by section 327(a) of the Bankruptcy Code, and does not hold or represent an interest adverse to the Debtors' estates, and (b) Kirkland has no connection to the Debtors, their creditors, or other parties in interest, except as may be disclosed herein.
