# ORDER SUSTAINING THE LIQUIDATING TRUSTEE'S FIFTH OMNIBUS CLAIMS OBJECTION TO CERTAIN EQUITY CLAIMS

(Related Docket Nos. 835(sealed) / 837(redacted))

Upon the fifth objection (the "Fifth Objection")<sup>2</sup> of the Liquidating Trustee of the Liquidating Trust of Athenex, Inc., *et al.*, and the request for entry of an order (this "Order") sustaining the *Liquidating Trustee's Fifth Omnibus Claims Objection to Certain Equity Claims*, all as more fully set forth in the Fifth Objection; and upon the Madden Declaration; and this Court having jurisdiction over this matter pursuant to 28 U.S.C. § 1334; and this Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and this Court having found that it may enter a final order consistent with Article III of the United States Constitution; and this Court having found that venue of this proceeding and the Fifth Objection in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that the relief requested in the Fifth Objection is in the best interests of the Debtors' estates, their creditors, and other parties in interest; and this Court having found that the Liquidating Trustee's notice of the Fifth Objection and opportunity for a hearing on the Fifth Objection were appropriate under the circumstances and no other notice need be provided; and this Court having reviewed the Fifth Objection; and this Court having determined that the legal and factual bases set forth in the Fifth Objection establish just

cause for the relief granted herein; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor,

#### IT IS HEREBY ORDERED THAT:

- 1. Each Equity Claim identified on <u>Schedule 1</u> attached hereto is hereby disallowed in its entirety as set forth on <u>Schedule 1</u>.
- 2. The Debtors' claims agent is authorized and directed to update the Claims Register maintained in these Chapter 11 Cases to reflect the relief granted in this Order.
- 3. The Liquidating Trustee's right to object to any claims, including the Equity Claims, as defined in the Fifth Objection, on any and all grounds and/or for any other purposes is hereby expressly preserved. The Liquidating Trustee's right to object to any remaining claims listed on the Schedules or otherwise on any basis is hereby expressly preserved.
- 4. Except as otherwise provided in this Order, nothing in this Order shall be deemed:

  (a) an admission as to the validity of any claim against a Debtor entity or such Debtor entity's estate; (b) a waiver of any party's right, including without limitation, the Debtors' and the Liquidating Trust's right, to dispute any claim on any grounds; (c) a promise or requirement to pay any claim; (d) an implication or admission that any particular claim is of a type specified or defined in the Fifth Objection or any order granting relief requested by this Fifth Objection; (e) a request or authorization to assume any agreement, contract, or lease pursuant to section 365 of the Bankruptcy Code; or (f) a waiver of the Debtors' and/or the Liquidating Trust's rights under the Bankruptcy Code or any other applicable law.
- 5. The Liquidating Trustee's objection to each of the Equity Claims addressed in the Fifth Objection constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014. This Order shall be deemed a separate order with respect to each Equity Claim. Any stay of this

Order pending appeal by any of the claimants subject to this Order shall only apply to the contested

matter which involves such claimant and shall not act to stay the applicability and/or finality of

this Order with respect to the other contested matters covered hereby.

6. Notice of the Objection as provided therein shall be deemed good and sufficient

notice of such Objection, and the requirements of Bankruptcy Rule 6004(a) and the Bankruptcy

Local Rules are satisfied by such notice.

7. The terms and conditions of this Order are immediately effective and enforceable

upon its entry.

8. The Debtors, the Debtors' claims agent, the Liquidating Trustee, and the Clerk of

the Court are authorized to take all actions necessary to effectuate the relief granted pursuant to

this Order in accordance with the Fifth Objection.

9. This Court retains exclusive jurisdiction with respect to all matters arising from or

related to this Order.
