ORDER GRANTING THIRD OMNIBUS MOTION OF DEBTORS TO REJECT EXECUTORY CONTRACTS AND UNEXPIRED LEASES RETROACTIVE TO THE FILING DATE OF THE MOTION

Nothing contained in this Order or Exhibit A hereto, including but not limited to the inclusion of a particular document among the Contracts and Leases listed in the exhibit, is intended to waive or otherwise impair the rights of the Debtors or any parties in interest to (a) contest a claim for damages arising in connection with the rejection of any Contract or Lease, (b) contest any Contract's or Lease's status as executory or unexpired, or (c) contest whether a particular Contract or Lease may be a true lease or secured financing agreement, all such rights being expressly preserved.
