On **February 15, 2024**, the United States Bankruptcy Court for the Southern District of New York (the "<u>Bankruptcy Court</u>") entered an order in the above-captioned chapter 11 cases [Docket No. 2918] (the "<u>Disclosure Statement Order</u>"): (a) approving the *Fifth Modified Disclosure Statement for Fourth Modified First Amended Plan of Reorganization Proposed by The Roman Catholic Diocese of Rockville Centre, New York* [Docket No. 2910] (together with all schedules and exhibits thereto, and as may be modified, amended, or supplemented from time to time, the "<u>Disclosure Statement</u>"); (b) establishing the Record Date,

Voting Deadline, and other related dates in connection with confirmation of the *Fourth Modified First Amended Chapter 11 Plan of Reorganization for The Roman Catholic Diocese of Rockville Centre, New York* [Docket No. 2908] (together with all schedules and exhibits thereto, and as may be modified, amended, or supplemented from time to time, the "<u>Plan</u>");² (c) approving procedures for soliciting, receiving, and tabulating votes on the Plan and for filing objections to the Plan (the "<u>Solicitation Procedures</u>"); and (d) approving the form and manner of notice and other related documents as they relate to the Debtor.

- 2. A hearing to consider the confirmation of the Plan (the "<u>Confirmation Hearing</u>") will be held before the Honorable Martin Glenn, Chief United States Bankruptcy Judge for the Southern District of New York, in a courtroom to be determined, at the United States Bankruptcy Court for the Southern District of New York located at One Bowling Green, New York, New York 10004 (the "<u>Bankruptcy Court</u>") on **May 9, 2024 at 10:00 a.m. (prevailing Eastern Time).**
- 3. On or before **March 15, 2024**, the Debtor intends to file the Assumed Executory Contracts and Unexpired Leases Schedule with the Bankruptcy Court as part of the Plan Supplement contemplated under the Plan. The determination to assume the agreements identified on the Assumed Executory Contracts and Unexpired Leases Schedule is subject to revision.
- 4. You are receiving this notice because the Debtor's records reflect that you are a party to a contract or lease that is or will be listed on the Assumed Executory Contracts and Unexpired Leases Schedule. Therefore, you are advised to review carefully the information contained in this Cure and Assumption Notice and the related provisions of the Plan. The Debtor is proposing to assume the Executory Contract(s) and Unexpired Lease(s) listed on Exhibit A, attached hereto, to which you are a party.³

Section 365(b)(1) of the Bankruptcy Code requires a chapter 11 debtor to cure, or provide adequate assurance that it will promptly cure, any defaults under executory contracts and unexpired leases at the time of assumption. In the event of a dispute, payment of the cure amount would be made following the entry of a final order(s) resolving the dispute and approving the assumption.

Any objection by an Executory Contract or Unexpired Lease counterparty to the assumption, assumption and assignment, the related Cure Amount, or adequate assurance proposed for its Executory Contract or Unexpired Lease, must be filed, served, and actually received by the Debtor no later than **April 24**, **2024 at 5:00 p.m.** (**prevailing Eastern Time**), which is the deadline for filing objections to the Plan (the "Confirmation Objection Deadline"), or such later date as may be provided in the applicable Cure and Assumption Notice; <u>provided</u>, <u>however</u>, that each counterparty to an Executory Contract or Unexpired Lease (a) that the Debtor later determines to assume or (b) as to which the Debtor modifies the applicable Cure Amount, must object to the assumption or Cure Amount, as applicable, by the earlier of: (i) fourteen (14) days after the Debtor serves such counterparty with a corresponding Cure and Assumption Notice; and (ii) the Confirmation Hearing.

- 10. Any counterparty to an Executory Contract or Unexpired Lease that fails to timely object to the proposed assumption of any Executory Contract or Unexpired Lease shall be forever barred, estopped, and enjoined from contesting the Debtor's assumption of the applicable Executory Contract or Unexpired Lease and from requesting payment of a Cure Amount that differs from the amounts paid or proposed to be paid by the Debtor or the Reorganized Debtor, in each case without the need for any objection by the Debtor or the Reorganized Debtor or any further notice to or action, order, or approval of the Bankruptcy Court. The Reorganized Debtor may settle any dispute regarding a Cure Amount without any further notice to or action, order, or approval of the Bankruptcy Court.
- 11. Please be advised that the Confirmation Hearing may be adjourned or continued from time to time by the Bankruptcy Court or the Debtor without further notice other than as indicated in any notice or agenda of matters scheduled for a particular hearing that is filed with the Bankruptcy Court. If the Confirmation Hearing is continued, the Debtor will post the new date and time of the Confirmation Hearing at https://dm.epiq11.com/drvc. The Plan may be modified, if necessary, prior to, during, or as a result of the Confirmation Hearing, without further notice to creditors or other parties in interest, unless such notice is required by the Bankruptcy Code, Bankruptcy Rules, or other applicable law.

Assumption or assumption and assignment of any Executory Contract or Unexpired Lease pursuant to the Plan or otherwise, and payment of any applicable Cure Amount in accordance with the procedures set forth in Article VI of the Plan, shall result in the full release and satisfaction of any Claims or defaults, whether monetary or nonmonetary, including defaults of provisions restricting the change in control or ownership interest composition or other bankruptcy-related defaults, arising under any assumed Executory Contract or Unexpired Lease at any time prior to the effective date of assumption. Any and all Proofs of Claim based upon Executory Contracts or Unexpired Leases that have been assumed in the chapter 11 case, including pursuant to the Confirmation Order, shall be deemed Disallowed and expunged as of the later of (1) the date of entry of an order of the Bankruptcy Court (including the Confirmation Order) approving such assumption; (2) the effective date of such assumption; or (3) the Effective Date, in each case without the need for any objection by the Debtor or the Reorganized Debtor or any further notice to or action, order, or approval of the Bankruptcy Court. If either Class of Abuse Claims entitled to vote rejects the Plan and the chapter 11 case is eventually dismissed, assumed contracts will continue in the Debtor's ordinary course of business.
