**SUPPLEMENT TO  
DEBTORS' OMNIBUS MOTION FOR ENTRY OF AN ORDER (A) AUTHORIZING  
THE DEBTORS TO ASSUME AND ASSIGN CERTAIN CONTRACTS TO  
PURCHASER, AND (B) GRANTING RELATED RELIEF**

**(Hearing on Omnibus Motion is set for March 27, 2024 at 10:00 am)**

The above-captioned debtors and debtors-in-possession (collectively, the “Debtors”), by and through undersigned counsel, pursuant to 11 U.S.C. §§ 365(a) and (f), file this Supplement to the *Debtors’ Motion for Entry of an Order (A) Authorizing the Debtors to Assume and Assign Certain Contracts to Purchaser, and (B) Granting Related Relief* [ECF No. 507] (the “Motion”).

As grounds in support of this Supplement, the Debtors state as follows:

On March 22, 2024, the Debtors filed the Motion, seeking the entry of an order approving the assumption and assignment of contracts listed on Exhibit A of the Motion, which also identified any cure amounts required to the extent of pre-petition defaults, if applicable. Since these contracts were not included in the Debtors’ initial list or corrected supplemental list of available contracts and leases for potential assumption and assignment [ECF Nos. 229 and 421] (collectively, “Available Contracts List”), both of which set forth cure amounts if applicable, the Debtors wanted to provide the non-Debtor parties to these contracts with notice that the Purchaser<sup>2</sup> selected their

contracts for assumption and assignment after the entry of the Sale Order and further advise them of any cure amount to be paid by the Purchaser.

By way of this Supplement, the Debtors seek to notify additional counterparties that their contracts were selected by the Purchaser for assumption and assignment after the entry of the Sale Order (“Additionally Assumed Contracts”). The non-Debtor parties to the Additionally Assumed Contracts, however, were listed in the Available Contracts List and, therefore, received timely notice that their contracts could be potentially assumed and assigned to the Purchaser and were also made aware of any cure amount associated therewith, if applicable. Accordingly, by way of this Supplement and attached **Exhibit “1,”** the Debtors seek to notify the additional counterparties that the Debtors will assume and assign their contracts to the Purchaser on the Sale Closing Date.

As the Purchaser will promptly pay cures, to the extent applicable, and has the ability to continue to perform all obligations required under the Additionally Assumed Contracts listed in **Exhibit “1,”** the Debtors submit that the decision to assume and assign these additional contracts to the Purchaser is made in the sound exercise of the Debtors’ business judgment and will benefit the Debtors’ estates.

**WHEREFORE**, the Debtors respectfully request the entry of an Order in the form attached to the Motion as Exhibit B, as supplemented by this Supplement, including the approval of the assumption and assignment of the Additionally Assumed Contracts on the Sale Closing Date, and granting any such other relief as is just and proper.
