**NOTICE OF RECEIVER'S MOTION FOR APPROVAL

Dear SOFIA RAMZAN:

On February 13, 2024, the court-appointed receiver, Michael F. Thomson (the “Receiver”), filed his *Motion for Approval of Proposed Plan of Distribution* (the “Motion”). You can view a copy of the Motion at <https://dm.epiq11.com/traffic>. The Motion seeks approval of the following relief: (i) the initial distribution of funds to holders of Allowed Claims, in the approximate amount of 77.8% of the Allowed Claim (but excluding holders of Allowed Claims whose distribution amount is less than \$100.00, which holders will not receive a distribution); (ii) the distribution procedures described in the Motion including, but not limited to, the collection of necessary information to make distributions to holders of Allowed Claims and the establishment of procedures for making distributions; and (iii) the *pro rata* distribution methodology for determining the distributions to be made on account of the Allowed Claims.

You are receiving this Notice because you may hold an Allowed Claim in this case and may be entitled to receive a distribution. A list of all Allowed Claims is attached as **Exhibit A** to the Motion. You can determine the amount of your Allowed Claim and the proposed distribution you will receive if the Motion is granted by referencing your claim number on the list attached to the Motion as **Exhibit A**. 

