10 Upon the motion (the “**Motion**”, Docket No. 764)¹ of the above-captioned debtors and
11 debtors in possession for entry of an order (this “**Order**”) (a) extending by 30 days the Exclusive
12 Periods during which only the Debtor may file a chapter 11 plan and solicit acceptances thereof,
13 and (b) granting such other relief as is just and proper, all as more fully set forth in the Motion;
14 and the Court having reviewed the Motion; and the Court having jurisdiction to consider this
15 Motion and the relief requested therein in accordance with 28 U.S.C. §§ 157 and 1334; and
16 consideration of the Motion and the relief requested therein being a core proceeding pursuant to
17 28 U.S.C. § 157(b)(2); and venue being proper in this district pursuant to 28 U.S.C. §§ 1408 and
18 1409; and due and proper notice of the Motion being adequate and appropriate under the particular
19 circumstances; this Court having found and determined that the relief sought in the Motion is in
20 the best interests of the Debtors’ estate, its creditors, and other parties in interest, and that the legal
21 and factual bases set forth in the Motion establishes just cause for the relief granted herein; and
22 upon all of the proceedings had before this Court; and any objections to the relief requested herein
23 are nonexistent, having been withdrawn or overruled on the merits; and after due deliberation and
24 sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

- 25 1. The Motion is granted as set forth herein.

8 enforceable upon its entry.

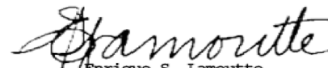
9 6. All time periods set forth in this Order shall be calculated in accordance with Fed.
10 R. Bankr. P. 9006(a).

11 7. The Debtors are authorized to take all actions necessary to effectuate the relief
12 granted pursuant to this Order in accordance with the Motion.

13 8. This Court retains exclusive jurisdiction with respect to all matters arising from or
14 related to the implementation of this Order.
