MOTION OF THE UNITED STATES TRUSTEE TO DISMISS CASES

BLR 9013 NOTICE: THIS MOTION SEEKS AN ORDER THAT MAY ADVERSELY AFFECT YOU. IF YOU OPPOSE THE MOTION, YOU SHOULD IMMEDIATELY CONTACT THE MOVING PARTY TO RESOLVE THE DISPUTE. UNLESS THE PARTIES AGREE OTHERWISE, THE COURT MAY CONSIDER EVIDENCE AT THE HEARING AND MAY DECIDE THE MOTION AT THE HEARING.

TO THE HONORABLE MARVIN ISGUR
UNITED STATES BANKRUPTCY JUDGE:

Kevin M. Epstein, the United States Trustee for Region 7 (the “U.S. Trustee”), moves this Court to dismiss the above-captioned cases (“Bankruptcy Cases”) under 11 U.S.C. § 1112(b) and respectfully represents as follows:

I. SUMMARY OF ARGUMENT

1. This Debtors have disregarded their obligations under the Bankruptcy Code, their Plan, and orders of this Court.² In the nearly 14 months since confirming its Plan, Debtor has failed to timely pay its quarterly fees owing pursuant to 28 U.S.C. § 1930(a)(6) (“Quarterly Fees”) such that Debtors currently have an unpaid balance for Statutory Fees of approximately \$309,414.68³ due and owing as of the date of this Motion. Each of these failures amount to “cause” under 11 U.S.C. § 1112(b) and this Court should dismiss these Bankruptcy Cases.

II. JURISDICTION AND VENUE

2. This Court has jurisdiction to consider this matter pursuant to 28 U.S.C. §§ 157 and 1334. A matter involving a motion to convert or dismiss is a core proceeding pursuant to 28 U.S.C. § 157(b) (2) (A). Venue is appropriate pursuant to 28 U.S.C. § 1408.

3. Kevin M. Epstein is the duly appointed United States Trustee for the Southern District of Texas pursuant to 28 U.S.C. § 581(a)(7). Pursuant to 11 U.S.C. § 307, the U.S. Trustee has standing to appear and be heard on any issue in a case or proceeding under title 11. Pursuant

to 28 U.S.C. § 586(a)(3), the U.S. Trustee is statutorily obligated to monitor the administration of cases commenced under the Bankruptcy Code (the “Code”).

III. FACTUAL BACKGROUND

4. On October 2, 2022 (the “Petition Date”), the above-captioned debtors (“Debtors”) filed voluntary chapter 11 petitions.

5. On October 3, 2022, the Court entered the Order directing joint administration of the Bankruptcy Cases solely for procedural purposes. Dkt. No. 45.

6. On January 13, 2023, the Court entered the Confirmation Order confirming Debtors’ Plan.

7. Pursuant to Fed. R. Bank. P. 2015 and Article XII.C. of the Plan, each Debtor is required to timely file a post confirmation report (“PCR”) on a quarterly basis and pay the Quarterly Fees.

8. On April 14, 2023, pursuant to the *Final Decree Closing Certain of the Chapter 11 Cases* [Dkt. No. 1270] (the “Final Decree”), certain of Debtors’ jointly administered Bankruptcy Cases were closed (the “Closed Cases”).⁴

9. The Final Decree required the Debtors of the Closed Cases to pay the appropriate sum of quarterly fees due and payable under 28 U.S.C. § 1930(a)(6)(A) and (B) with respect to their Closed Cases no later than the later of (i) fourteen days after the date of entry of the Final Decree and (ii) the date on which such quarterly fees are otherwise due. Further, pursuant to the Final Decree, this Court retained jurisdiction to enforce the Quarterly Fees. Final Decree ¶ 7.

10. Debtors presently have an estimated⁵ aggregate balance of \$309,414.68 due for Quarterly Fees relating to these Bankruptcy Cases.⁶

III. ARGUMENT

a. *Legal Framework*

11. Section 1112(b)(1) of the Code provides that the Court must dismiss or convert, whichever is in the best interests of creditors and the estate, if the movant establishes “cause” unless the Court determines that the appointment of a chapter 11 trustee or examiner is in the best interests of creditors and the estate.⁷ 11 U.S.C. § 1112(b)(1).

12. Under § 1112(b)(4), “cause” includes:

- (E) failure to comply with an order of the court;
- (K) failure to pay any fees or charges required under chapter 123 of title 28; [and]
- (N) material default by the debtor with respect to a confirmed plan.

11 U.S.C. § 1112.

13. Debtors must pay quarterly fees pursuant to 28 U.S.C. § 1930(a)(6) in each case under chapter 11 of title 11 ... for each quarter (including for any fraction thereof) until the cases are converted or dismissed, whichever occurs first.

⁷ Prior to the enactment of the Bankruptcy Abuse Prevention and Consumer Protection Act (“BAPCPA”), the decision to convert or dismiss a chapter 11 case upon a showing of cause was discretionary. BAPCPA circumscribed a bankruptcy court’s discretion by replacing “may” with “shall” and expressly mandating that the court dismiss or convert if the movant establishes cause. See 7 Alan N. Resnick, COLLIER ON BANKRUPTCY ¶1112.04[1] (15th ed. rev. 2009); see also *In re Gateway Access Solutions, Inc.*, 364 B.R. 556, 560 (Bankr.M.D.Pa.2007) noting that under BAPCPA, the statutory language “has been changed from permissive to mandatory. The amendments to section 1112 limit the Court’s discretion to refuse to dismiss or convert a chapter 11 case upon a finding of cause.”

b. *The Debtors have Failed to Timely Pay Their Quarterly Fees as Required by Law, Their Plan and the Final Decree.*

14. As set forth above, Debtors currently have significant unpaid Quarterly Fees despite their requirement to pay such fees pursuant to 28 U.S.C. § 1930(a)(6), the Plan, and the Final Decree.

c. *The Court Should Dismiss the Bankruptcy Cases*

15. The Court should dismiss these Bankruptcy Cases to stop the accrual of Quarterly Fees. Debtors have already confirmed a Plan but have failed to pay the Quarterly Fees as required by the Plan, 28 U.S.C. § 1930, and the Final Decree. Debtors should not continue to reap the extraordinary benefits of bankruptcy protection unless they are willing and able to abide by the requirements of being in bankruptcy, including the payment of Quarterly Fees.

IV. CONCLUSION

WHEREFORE, the U.S. Trustee requests that this Court enter an order dismissing these Bankruptcy Cases pursuant to 11 U.S.C. § 1112(b).
