**ORDER GRANTING DEBTORS' SECOND OMNIBUS MOTION
TO REJECT EXECUTORY CONTRACTS**

THIS MATTER having come before the Court for a hearing on March 27, 2024, at 10:00 a.m. in Miami, Florida (“Hearing”) upon the *Debtors’ Second Omnibus Motion to Reject Executory Contracts* [ECF No. 492], *Supplement to Debtors’ Second Omnibus Motion to Reject Executory Contracts* [ECF No. 511], *Second Supplement to Debtors’ Second Omnibus Motion to Reject Executory Contracts* [ECF No. 516] and a modification to ECF No. 516 as announced by Debtors’ counsel on the record at the Hearing (collectively, the “Motion”) filed by the above-

captioned debtors and debtors-in-possession (collectively, the “Debtors”). Except for the contract between Bird Rides, Inc. and Telus International Services, Ltd. (“Manila Contract”), which shall have a rejection date of March 31, 2024, the Motion seeks authority to reject, as of March 22, 2024, the executory contracts identified on Exhibit A to ECF No. 492, as supplemented by ECF Nos. 511 and 516, and as further modified by Debtors’ counsel’s announcement on the record at the Hearing that Bird Rides, Inc.’s permits with the City of San Diego, CA are sought for rejection (collectively, “Bird Rides San Diego Permits”). Having considered the Motion and having heard argument of counsel, the Court finds that: (i) it has jurisdiction over the matters raised in the Motion pursuant to 28 U.S.C. §§ 157 and 1334, (ii) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2)(A), (iii) the relief requested in the Motion is in the best interests of the Debtors, their estates, and their creditors, (iv) proper and adequate notice of the Motion and the hearing thereon has been given and no other or further notice is necessary, and (v) upon review of the record before the Court, including the legal and factual bases set forth in the Motion and the record of the hearing, good and sufficient cause exists to grant the relief requested in the Motion. Accordingly, it is

ORDERED that:

1. The Motion is **GRANTED**.
2. The Debtors’ rejection of the executory contracts listed on attached **Exhibit “1”** (“Contracts”) will benefit the estates, and is a decision made well within the scope of the Debtors’ sound business judgment.
3. The Debtors’ rejection of the Contracts is **APPROVED** pursuant to 11 U.S.C. § 365(a) and the effective date of the rejection of the Contracts (including the Bird Rides San

Diego Permits) is March 22, 2024, except that the effective date of rejection for the Manila Contract is March 31, 2024.

4. **ANY PROOF OF CLAIM FOR DAMAGES ARISING FROM THE REJECTION MUST BE FILED WITH THE COURT ON OR BEFORE THE LATEST OF: (I) THE TIME FOR FILING A PROOF OF CLAIM PURSUANT TO BANKRUPTCY RULE 3003(c)(3); (II) 30 DAYS AFTER THE ENTRY OF THE ORDER COMPELLING OR APPROVING THE REJECTION OF THE CONTRACT OR LEASE; OR (III) 30 DAYS AFTER THE EFFECTIVE DATE OF THE REJECTION OF THE CONTRACT OR LEASE.**

5. Debtors' insurers have a joint or common interest with Debtors, as it relates to the defense of bodily injury and property damage claims. To the extent any engagement or retainer agreement(s) between the Debtors and their counsel is rejected by this Order, copies of counsel's litigation files pertaining solely to the Debtors' representation, if not already provided to the Debtors' insurers, shall be promptly turned over upon demand to the Debtors' insurance counsel. The Court reserves jurisdiction to enter any further orders to compel the turnover of any and all records and files necessary to comply with the obligations under the Debtors' insurance agreements and policies. The foregoing notwithstanding, no attorney client or work product privileges, other than those privileges held by the Debtors, are intended to be waived by this Order.

6. The Court retains jurisdiction over any matter or dispute arising from or relating to the implementation of this Order.
