**STIPULATION AND AGREED ORDER
BETWEEN THE REORGANIZED DEBTORS, MEDPORT, AND
MOVEDOCS REGARDING THE SETTLEMENT OF CERTAIN CLAIMS**

This Stipulation and Agreed Order (the “Stipulation”) is entered into by and among (a) the above-captioned reorganized debtors (collectively, the “Reorganized Debtors,” and prior to the Effective Date,² the “Debtors”), (b) Medport Billing, LLC, and any of its affiliates, subsidiaries, predecessors, successors, or assigns (collectively, “Medport”), and (c) MoveDocs.com, LLC, and any of its affiliates, subsidiaries, predecessors, successors, or assigns (collectively, “MoveDocs,” and together with Medport, “Medport/MoveDocs,” and together with the Reorganized Debtors, the “Parties”). The Parties hereby stipulate and agree as follows:

WHEREAS, the Parties are party to certain agreements including, without limitation, that certain (i) One-Time Purchase Agreement dated August 12, 2022, by and among Akumin Corp. and certain of its direct and indirect subsidiaries and certain of its affiliated professional service affiliates (“Akumin”) (the “OTA”), (ii) Master Purchaser Agreement, dated August 12, 2022, by and among Akumin and Medport (the “MPA”), (iii) Servicing Agreement, dated August 1, 2023,

by and among Akumin, Medport and MoveDocs (the “Medport Servicing Agreement”), and (iv) Servicing Agreement, dated August 1, 2023, by and among MoveDocs and Akumin (the “Akumin Servicing Agreement” and together with the OTA, the MPA, the Medport Servicing Agreement, and any other agreement between any of the Debtors, on the one hand, and Medport and/or MoveDocs, on the other hand, the “Agreements”).

WHEREAS, the Debtors commenced numerous affiliated bankruptcy cases under Chapter 11 of the Bankruptcy Code (the “Chapter 11 Cases”) in the United States Bankruptcy Court for the Southern District of Texas (the “Bankruptcy Court”) on October 22, 2023, pursuant to which the Debtors filed their *Joint Prepackaged Chapter 11 Plan of Reorganization of Akumin Inc. and its Debtor Affiliates* (the “Plan”) [Docket No. 21];

WHEREAS, MoveDocs filed Proof of Claim No. 10085 in the Chapter 11 Cases asserting an unsecured claim against the Debtors in the amount of \$4,600,000.00 (the “Akumin Servicing Agreement Claim”);

WHEREAS, Medport/MoveDocs filed Proof of Claim No. 10086 in the Chapter 11 Cases asserting an unsecured unliquidated claim against the Debtors in the original amount of \$1,050,000.00 (the “Medport Servicing Agreement Claim” and together with the Akumin Servicing Agreement Claim, the “Filed Claims”);

WHEREAS, Medport has asserted certain additional unsecured unliquidated claims against the Debtors in connection with the OTA and MPA (the “OTA and MPA Claims”);

WHEREAS, pursuant to the Plan, the Filed Claims have been disputed as of the Effective Date and may be settled and/or compromised by the Parties in the ordinary course of business as if the Chapter 11 Cases had never been filed and upon the Effective Date all Proofs of Claim filed against the Debtors, regardless of time of filing, and including Proofs of Claim filed after the Effective Date, shall be deemed withdrawn and expunged, except as otherwise provided in the

Plan; and

WHEREAS, by this Stipulation, the Parties seek to settle, compromise and forbear from exercise of remedies with respect to the Filed Claims and the OTA and MPA Claims and any other Claims or Causes of Action held by the Parties.

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, AND UPON APPROVAL BY THE BANKRUPTCY COURT OF THIS STIPULATION, IT IS ORDERED AS FOLLOWS:

1. The foregoing recitals are hereby incorporated by reference into this Stipulation with the same force and effect as if fully set forth hereinafter.

2. In exchange for the agreements and consideration contained herein, the Filed Claims are hereby withdrawn.

3. The Reorganized Debtors shall pay to Medport/MoveDocs \$600,000.00 on or before the last calendar day of April 2024.

4. The Reorganized Debtors shall pay to Medport/MoveDocs \$200,000.00 per month on or before the last calendar day of each month, commencing with April 2024; *provided* that such monthly payments shall not exceed \$4,000,000.00 in the aggregate.

5. All payments made by the Reorganized Debtors pursuant to this Stipulation shall satisfy, release, and forever discharge a proportional amount of the Akumin Servicing Agreement Claim and when such payments are made in full in accordance with the terms of this Stipulation, shall satisfy, release and forever discharge all of the Parties from their respective remaining Claims and Causes of Action which have arisen or which may arise in the future under the terms of the Akumin Servicing Agreement.

6. The Parties shall forbear from the pursuit of and exercise of remedies regarding any Claims or Causes of Action, including, but not limited to the Filed Claims and the MPA and OTA

Claims, with respect to the other Parties for a 24-month period commencing on the first date of payment pursuant to this Stipulation (the “Standstill Period”).

7. To the extent that the Reorganized Debtors have not made a payment pursuant to this Stipulation within five (5) calendar days of the later of (i) the date by which such payment is due hereunder and (ii) the Debtors’ receipt of written notice by Medport/MoveDocs (email being sufficient) regarding such non-payment, Medport/MoveDocs may pursue any remedy available to them at law to enforce the terms and conditions of this Stipulation, including, but not limited to termination of the Standstill Period after giving Akumin thirty (30) days prior written notice of such termination.

8. The Reorganized Debtors shall continue remitting payments to Medport pursuant to Section 2 of the Medport Servicing Agreement and otherwise work in good faith with Medport/MoveDocs to comply with the Reorganized Debtors’ covenants pursuant to Section 2 thereof.

9. The Parties shall negotiate in good faith with respect to the resolution of any Claims and Causes of Action after the expiration of the Standstill Period. In the event that the Parties are unable to reach a resolution of the Claims and Causes of Action by the expiration of the Standstill Period, nothing herein shall prohibit Medport/MoveDocs from pursuing and exercising any remedies which may be available to them regarding the Filed Claims and the OTA and MPA Claims and any other Claims or Causes of Action.

10. Any statute of limitations (or other defense based in whole or in part upon the passage of time including, but not limited to, laches) applicable to any of the Claims and Causes of Action shall be tolled from the date of this Stipulation to the expiration of the Standstill Period.

11. The provisions of this Stipulation shall be binding on the Parties and their successors, heirs, and assigns and shall inure to the benefit of the Parties and their successors and

assigns.

12. This Stipulation constitutes the entire agreement and understanding between the Parties with respect to the subject matter hereof, and there are no representations, understandings, or agreements relative hereto which are not fully expressed herein.

13. This Stipulation may not be modified, altered, or amended in whole or in part except by a written instrument executed by each Party.

14. It is acknowledged that each Party has participated in and jointly consented to the drafting of this Stipulation and that any claimed ambiguity shall not be construed for or against either Party on account of such drafting.



16. This Stipulation shall be effective and enforceable immediately upon entry of this Stipulation, in accordance with its terms.

17. The Bankruptcy Court retains jurisdiction with respect to the implementation of this Stipulation, and the Parties hereby consent to such jurisdiction to resolve any disputes or controversies with respect to this Stipulation .
