AGREED ORDER REGARDING HEARING

(Relates to ECF Nos. 1471, 1540)

On February 29, 2024, the United States Trustee (“**U.S. Trustee**”) filed his *Amended and Supplemental Motion for Relief from Judgment Pursuant to Federal Rule of Civil Procedure 60(b)(6) and Federal Rule of Bankruptcy Procedure 9024 Approving Compensation Applications of Jackson Walker LLP, (2) Sanctions, and (3) Related Relief* [ECF No. 1540] (the “**Amended Rule 60(b)(6) Motion**”).

Pursuant to the *First Amended Comprehensive Scheduling, Pre-Trial & Trial Order* [ECF No. 76] (the “**Scheduling Order**”) entered by Chief Judge Rodriguez in Miscellaneous Proceeding No. 23-00645, Jackson Walker LLP’s (“**Jackson Walker**”) deadline to file a response to the Amended Rule 60(b)(6) Motion is May 15, 2024.

The Scheduling Order governs discovery related to the Amended Rule 60(b)(6) Motion and currently concludes discovery on October 10, 2024.

Based on the foregoing it is ORDERED that

1. The hearing set for August 12, 2024, on the Amended Rule 60(b)(6) Motion is postponed pending further order of this Court.
