On December 20, 2023, Bird Global, Inc., Bird Rides, Inc., Bird US Holdco, LLC, Bird US Opco, LLC, and Skinny Labs, Inc. (collectively, the “Debtors”) filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code (the “Bankruptcy Code”) in the United States Bankruptcy Court for the Southern District of Florida (the “Court”). The Debtors’ address, the case number, proof of claim form, and other relevant information related to this chapter 11 case may be obtained at the website maintained by the Debtor’s claims and noticing agent (<https://dm.epiq11.com/bird>). **Please note that neither the Debtors’ staff or the Debtors’ claims and noticing agent is permitted to give legal advice. Any person who believes that he or she has, or may have, a claim (as defined in section 101(5) of the Bankruptcy Code) resulting from or arising in whole or in part, directly or indirectly from the use, placement, operation, transportation, renting, leasing, and/or recovery of the Debtors’ vehicles (i.e., scooters and bikes) and/or arising out of the operation of the Debtors’ business under any theory of liability, including vicarious liability, product liability, any negligence-based theory,

contribution, indemnity, or any other theory based on any acts or failures to act by the Debtors or any other person or entity for whose acts or failure to act the Debtors is or was allegedly responsible, including but not limited to, claims for bodily injury and wrongful death, against any of the Debtors or any municipality which issued permits or licenses to the Debtors should carefully read this notice.

Under Section 101(5) of the Bankruptcy Code and as used in this Notice, the word “claim” means: (a) a right to payment, whether or not such right is reduced to judgment, liquidated, unliquidated, fixed, contingent, matured, unmatured, disputed, undisputed, legal, equitable, secured, or unsecured; or (b) a right to an equitable remedy for breach of performance if such breach gives rise to a right to payment, whether or not such right to an equitable remedy is reduced to judgment, fixed, contingent, matured, unmatured, disputed, undisputed, secured, or unsecured.

LAST DATE FOR TIMELY FILING

The Court entered an order establishing May 16, 2024 (the “Tort Claims Filing Deadline”) as the last date for each individual with a Tort Claim to timely file a Proof of Claim. “Tort Claim” means a property or bodily injury claim, including wrongful death, against any of the Debtors or any municipality arising out of the use, placement, operation, transportation, renting, leasing, and/or recovery of the Debtors’ vehicles and/or arising out of the operation of the Debtors’ business. The Tort Claims Filing Deadline and the procedures set forth below apply only to Tort Claims occurring prior to December 20, 2023.

Pursuant to Bankruptcy Rule 3003(c)(2), all holders of Tort Claims that fail to timely filing a proof of claim in appropriate form shall (i) be forever barred, estopped, and enjoined from asserting such claims against the Debtors, their property, their estates (or submitting a proof of claim with respect thereto) or any person or entity that may be released under any chapter 11 plan for the Debtors, including but not limited to, the Settling Insurers and the Plan Settling Parties, and (ii) not treated as a creditor with respect to such claim for the purposes of voting and distribution with respect to any chapter 11 plan that may be filed in these cases.

WHO SHOULD FILE

If you believe that you have a Tort Claim, you should file a Proof of Claim to maintain and preserve any claims that you have against the Debtors or any municipality. Even if you have already filed a lawsuit against the Debtors prior to December 20, 2023, you should still file a Proof of Claim to maintain and preserve your rights in the Debtors’ chapter 11 cases.

WHO SHOULD NOT FILE

You should **NOT** file a Proof of Claim if: (a) your claim has already been paid in full or otherwise previously settled; (b) you do not have a Tort Claim; **OR** (c) you already filed a Proof of Claim.

PROCEDURES FOR FILING A PROOF OF CLAIM

To file a Proof of Claim, take the following steps:

Fill out the Proof of Claim form in its entirety.

All proof of claim forms must be **signed** by the claimant or such individual authorized to act on behalf of the claimant. If the claimant is not an individual, an authorized agent of the claimant (such as the claimant's lawyer) must sign the claim form. It must be written in English and be denominated in United States currency.

Return the completed Proof of Claim to the Debtors' claims and noticing agent at the address set forth below. Proofs of Claim will be deemed timely filed only if they are **actually received** by the Debtors' claims and noticing agent by 5:00 p.m. (Prevailing Eastern Time) on May 16, 2024.

If you are returning a Proof of Claim by mail, allow sufficient mailing time so that the Proof of Claim is **received** on or before 5:00 p.m. (Prevailing Eastern Time) on May 16, 2024. Proofs of Claim that are postmarked before that date, i.e., the Tort Claims Filing Deadline, but which are received by the Debtors' claims and noticing agent after the Tort Claims Filing Deadline, will be considered tardy.
