**NOTICE TO CONTRACT PARTIES TO POTENTIALLY

PLEASE TAKE NOTICE that on March 8, 2024, the United States Bankruptcy Court for the District of New Jersey (the “Court”) entered the *Order (I) Approving the Auction and Bidding Procedures, (II) Approving the Debtors’ Entry Into the Stalking Horse Agreement and the Stalking Horse Bid Protections, (III) Scheduling Bid Deadlines and an Auction, (IV) Approving the Form and Manner of Notice Thereof, and (V) Granting Related Relief* [Docket No. 79], which was amended on March 18, 2024 [Docket No. 131] (as amended, the “Bidding Procedures Order”)² in the chapter 11 cases of the above-captioned debtors and debtors in possession (collectively, the “Debtors”).

PLEASE TAKE FURTHER NOTICE that, pursuant to the Bidding Procedures and the terms of the Successful Bid, the Debtors **may** assume and assign to the Successful Bidder the contract or agreement listed on **Exhibit A** to which you are a counterparty. The Debtors have conducted a review of their books and records and have determined that the Cure Payments for unpaid monetary obligations under such Executory Contract or Unexpired Lease is as set forth on **Exhibit A**.³

Bidder”), and the Successful Bidder’s proof of adequate assurance of future performance was attached as Exhibit 2 thereto.

PLEASE TAKE FURTHER NOTICE that on April 15, 2024, the Court entered the *Order (I) Approving the Sale of the Acquired Assets Free and Clear of All Liens, Claims and Encumbrances, (II) Authorizing the Debtors to Enter into and Perform their Obligations Under the Asset Purchase Agreement, and (III) Granting Related Relief* [Docket No. 288] (the “Sale Order”) authorizing the Debtors’ entry into the Asset Purchase Agreement, dated as of March 4, 2024, by and among Debtor BowFlex Inc., its non-debtor affiliate, and Johnson Health Tech Retail, Inc. (“JHT”) and the other parties signatory thereto (together with all schedules, exhibits, and ancillary documents related thereto, in each case, as may be amended, modified or supplemented from time to time in accordance with the terms thereof, collectively, the “APA”)⁴ and consummation of the Sale.

PLEASE TAKE FURTHER NOTICE that, pursuant to the Bidding Procedures Order, JHT could designate or remove contracts to be assumed and assigned from the list of Assigned Contracts up to two business days prior to closing.

PLEASE TAKE FURTHER NOTICE that on April 20, 2024, the Debtors filed the *Notice of Final List of Assigned Contracts* [Docket 308], designating the final list of assigned contracts.

PLEASE TAKE FURTHER NOTICE that on April 22, 2024, the closing of the Sale Transaction occurred in accordance with the Bidding Procedures Order, Sale Order, and APA, and the Debtors filed the *Notice of Closing of Sale Transaction* [Docket 316].
