PLEASE TAKE FURTHER NOTICE that, on November 29, 2023, pursuant to the Rejection Procedures, the Debtors filed the *Debtors’ Third Notice of Rejection of Certain Executory Contracts and Unexpired Leases* [D.I. 1247] (the “Third Rejection Notice”).

PLEASE TAKE FURTHER NOTICE that, on March 8, 2024, Terminal Logistics II South SPE, LLC (“Landlord”) filed the *Objection and Reservation of Rights of Terminal Logistics II South SPE, LLC to Debtors’ Third Notice of Rejection of Certain Executory Contracts and Unexpired Leases* [D.I. 2557] (the “Landlord Objection”).

PLEASE TAKE FURTHER NOTICE that, on March 28, 2024, the Debtors filed the *Debtors’ Reply in Further Support of the Debtors’ Third Notice of Rejection of Certain Executory Contracts and Unexpired Leases* [D.I. 2775].

PLEASE TAKE FURTHER NOTICE that, pursuant to the Rejection Procedures, if one or more objections to the rejection of any Contract(s) listed in the applicable Rejection Notice is timely filed and properly served as specified above and not withdrawn or resolved, the Debtors shall file a notice for a hearing to consider the rejection of the Contract(s) implicated by such objection(s) and shall provide at least seven (7) days’ notice of such hearing to each objecting party and the Objection Service Parties.
