IQHQ-AVENTINE WEST, LP'S STATEMENT OF ISSUES AND DESIGNATION OF RECORD

Pursuant to Rule 8009(a) of the Federal Rules of Bankruptcy Procedure, IQHQ-Aventine West, LP ("<u>IQHQ</u>"), by and through its undersigned proposed counsel, respectfully submits the following statement of issues to be presented on appeal and designation of items for inclusion in the record on appeal in connection with IQHQ's appear from the following order:

STATEMENT OF ISSUES TO BE PRESENTED ON APPEAL

- 1. Whether the Bankruptcy Court erred in granting Debtors' Motion For Entry of An Order (I) Pursuant to Section 365(d)(4) of the Bankruptcy Code Extending Debtors' Time to Assume or Reject Unexpired Leases of Non-Residential Real Property and (II) Granting Related Relief (the "Motion")?
- 2. Whether the Bankruptcy Court erred in determining that the time period to assume or reject unexpired nonresidential real property leases under section 365(d)(4) of the of the Bankruptcy Code was automatically extended upon the filing of the Motion pursuant to the terms of the Bankruptcy Court's Order (I) Establishing Certain Notice, Case Management, and Administrative Procedures and (II) Granting Related Relief (the "Case Management Order") without either (a) bankruptcy court approval or (b) a finding of cause for an extension, prior to the expiration of the 120-day period provided by Bankruptcy Code section 365(d)(4) to assume or reject unexpired nonresidential real property leases?
- 3. Whether the Bankruptcy Court erred in determining that it could approve the extension of time to assume or reject unexpired nonresidential real property leases under section 365(d)(4) of the Bankruptcy Code as requested in the Motion after the original time period to assume or reject had expired?
- 4. Whether, to the extent the Bankruptcy Court determined that cause existed, the Bankruptcy Court erred in finding that cause existed to extend the time to assume or reject unexpired nonresidential real property leases under section 365(d)(4) of the Bankruptcy Code as requested in the Motion after the original time period to assume or reject had expired?

5. Whether the Bankruptcy Court exceeded its jurisdiction by entering the Case Management Order to the extent it, in any way, modified the substantive requirements set forth in Section 365(d)(4) of the Bankruptcy Code to extend the time period to assume or reject unexpired nonresidential real property leases?
