STIPULATION AND AGREED ORDER BETWEEN
THE LIQUIDATING TRUSTEE AND CHARLES IVEY, LTD., *ET AL.*
RESOLVING OBJECTIONS TO PROOF OF CLAIM NO. 14-2
FILED BY CHARLES IVEY, LTD., *ET AL.*
[Relates to Docket Nos. 239, 269 and 328]

This Stipulation and Agreement (the “**Stipulation**”) is entered into by and among (i) Daniel J. Sherman, as the liquidating trustee (the “**Liquidating Trustee**”) for the Liquidating Trust of NOC, Inc. (the “**Liquidating Trust**”) and Charles Ivey, Ltd., Paso Pecan Farms, Rio Bravo Farms, Ltd. and Rancho La Isla, LLC (collectively, the “**Claimant**”) regarding the *Debtor’s Objection to Amended Proof of Claim No. 14-2 Filed by Charles Ivey, Ltd., et al.* [Docket No. 239] (the “**Objection**”). The Liquidating Trustee and Claimant (collectively, the “**Parties**”) hereby stipulate and agree as follows:

WHEREAS, on January 30, 2023 (the “Petition Date”), the Debtor filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code. *See* Voluntary Petition [Doc. No. 1];

WHEREAS, on July 14, 2023, the Court entered the *Findings of Facts, Conclusions of Law, and Order (I) Approving the Disclosure Statement on a Final Basis and (II) Confirming the Debtor’s Amended Plan, as Modified* [Doc. No. 255] (the “**Confirmation Order**”) confirming, as modified therein, the *Amended Plan of Liquidation of NOC, Inc., Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 255] (including any exhibits, schedules and supplements thereto and as may be further amended, supplemented, or modified, the “**Confirmed Plan**”);

WHEREAS, on July 28, 2023, the Debtor filed that certain *Notice of (I) Entry of Confirmation Order and (II) Occurrence of Effective Date*, setting forth that, *inter alia*, the Effective Date occurred on July 28, 2023 (the “**Effective Date**”);

WHEREAS, on the Effective Date, Daniel J. Sherman was appointed to serve as the liquidating trustee of the Liquidating Trust of NOC, Inc. pursuant to the Confirmed Plan;

WHEREAS, on April 26, 2023, Claimant filed the proof of claim identified as Claim Number 14-2 (the “**Ivey Proof of Claim**”);

WHEREAS, on June 28, 2023, the Debtor filed the Objection;

WHEREAS, the Parties have agreed, subject to the approval of the Bankruptcy Court, to resolve the Objection and to compromise and settle the Objection to the Ivey Proof of Claim as set forth herein.

NOW, THEREFORE, after good-faith, arms-length negotiations, in consideration of the foregoing, it is hereby **STIPULATED AND AGREED**, and upon approval by the Bankruptcy Court of this Stipulation, it is so **ORDERED** that the Ivey Proof of Claim is fully and finally resolved as follows:

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED AS FOLLOWS:

1. The foregoing recitals are hereby incorporated by reference into this Stipulation with the same force and effect as if set forth fully herein.

2. The Objection is hereby sustained.

3. The Ivey Proof of Claim is disallowed entirely with respect to the Debtor, the Debtor's bankruptcy estate, the Liquidating Trustee and the Liquidating Trust of NOC, Inc., and the Claimant shall have no recovery or distributions from the Debtor, the Debtor's bankruptcy estate, the Liquidating Trustee nor the Liquidating Trust of NOC, Inc.

4. This Stipulation is intended by the Parties to be binding upon their successors, agents and assigns, including bankruptcy trustees and estate representatives, and any parent, subsidiary and affiliated entities.

5. The Liquidating Trustee and the Clerk of the Court are authorized to take all actions necessary to effectuate the relief granted pursuant to this Stipulation in accordance with the Objection and as further set forth herein.

6. The Court shall retain jurisdiction to interpret, implement and enforce the provisions of this Stipulation.

WHEREFORE, this Stipulation has been executed and delivered as of the day and year first written below.
