PLEASE TAKE NOTICE that on May 10, 2024, the above-captioned debtors and debtors in possession (the “Debtors”) filed the *Debtors’ Motion for Entry of Orders (I) (A) Approving Bidding Procedures and Breakup Fee, (B) Approving the Stalking Horse Purchase Agreement, (C) Scheduling an Auction and Sale Hearing, (D) Approving the Form and Manner of Notice Thereof, (E) Establishing Procedures for the Assumption and Assignment of Contracts and Leases and (II)(A) Approving the Asset Purchase Agreement, (B) Authorizing the Sale of Assets, and (C) Authorizing the Assumption and Assignment of Contracts and Leases* [Docket No. 47] (the “Motion”)² with the United States Bankruptcy Court for the District of New Jersey (the “Court”) seeking, among other things, entry of an order (the “Sale Order”) authorizing and approving: (a) a sale (the “Sale”) of all or substantially all of the Debtors’ Assets or any portion thereof free and clear of all Encumbrances, except as set forth in the Stalking Horse APA or an alternative asset
