**WHEREAS**, the Parties seek to resolve the Claim by this Stipulation and Order.

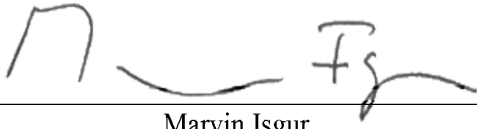
**IT IS THEREFORE STIPULATED BY THE PARTIES AND HEREBY ORDERED THAT:**

1. The foregoing recitals are hereby incorporated by reference in this Stipulation and Order.
2. The Claim is allowed as a General Unsecured Claim in the liquidated amount of \$107,236.95.
3. This Stipulation and Order is intended by each of the Parties to be binding upon their successors, agents, and assigns.
4. The undersigned hereby represent and warrant that they have full authority to execute this Stipulation and Order on behalf of their respective Parties.
5. The Stipulation and Order shall not be modified, altered, amended, or vacated without Bankruptcy Court approval.
6. The Bankruptcy Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Stipulation and Order, and the Parties hereby consent to such jurisdiction to resolve any disputes or controversies arising from or related to this Stipulation and Order.

7. Notwithstanding the applicability of Rule 6004(h) of the Federal Rules of Bankruptcy Procedure, the terms and conditions of this Stipulation and Order shall be immediately effective and enforceable upon entry of an Order approving the Stipulation and Order by the Bankruptcy Court.
