DISCUSSION

The parties requested, and the court granted, time to discuss the pending matters. The parties engaged in discussions regarding the pending matters and informed the court that they had reached an agreement. The agreement was summarized in open court and includes payment terms for Straddle Claims, Medicaid and Medicare over and underpayments, and Hospital Parking claims. The same will be filed on or before July 3, 2024, at 5:00 PM.

The court stated that there is no controversy as to the applicable law or the contractual basis on the pending issue, and that the dispute lies in the compliance with the asset purchase agreement and the sale order (Lead Case No. 23-2510, dkt. #476). It therefore behooves the parties to engage in good faith discussions to resolve or minimize the facts in controversy. Failure to do so will lead to unnecessary costs and expenses that may have to be borne by the party that is accountable for the controversy.

Attorney Schechter, counsel for the Committee, stated that time was of the essence, particularly as to events leading to the plan confirmation, and that the Committee would cooperate to reduce costs and expenses.

2 **ORDER**

4 of amounts owed on or before July 3, 2024, at 5:00 PM.
