**PLEASE TAKE NOTICE** that a status conference on *Republic-Vanguard Insurance Company's Motion to Compel the GUC Trust to Provide for the Payment of Defense Costs* [ECF No. 2352] and *Motion of the NPC International GUC Trust for Entry of an Order (I) Approving Distributions to Holders of Allowed General Unsecured Claims; (II) Approving Abandonment of Remaining GUC Trust Assets; and (III) Discharging the GUC Trust and Related Parties* [ECF No. 2353] will be held on **July 18, 2024 at 9:30 a.m. (CT)**.

**PLEASE TAKE FURTHER NOTICE** that the hearing will be held virtually only, instructions for virtual appearance are detailed below.

(6451); NPC International Holdings, LLC; (8234); NPC Restaurant Holdings, LLC (9045); NPC Operating Company B, Inc. (6498); and NPC Quality Burgers, Inc. (6457) (collectively, the "**Debtors**"). On June 25, 2021, the Court entered a final decree closing each of the chapter 11 cases other than NPC's chapter 11 case [Docket No. 1785]. Commencing on June 25, 2021, all motions, notices and other pleadings relating to any of the Debtors shall be filed in NPC's chapter 11 case. The Debtors' corporate headquarters and service address is 720 W. 20th Street, Pittsburg, KS 66762.

Once the code is entered, you will be connected live to the courtroom. You will be able to hear persons speaking in the courtroom and other persons on the call addressing the Court. You will be able to address the Court directly. The Court will hear all sound on your line. PLEASE mute your line if you are not addressing the Court.

If there are multiple parties on the call, the Court may activate the “hand raise” feature. The system will announce that this feature has been activated. If the hand raise feature has been activated, you will not be able to address the Court until the Court addresses you or you request to speak and the Court grants the request. If you wish to address the Court, you must press 5\*. Within 5 seconds, the Court will receive a signal that you wish to speak. When the Court calls on you, you will hear a recorded message that you have been recognized. When you are done, the Court will again mute your call.
