**MOTION FOR ADMISSION OF BRIAN W. HOCKETT TO APPEAR *PRO HAC VICE*  
AND ATTACHED DESIGNATION OF LOCAL COUNSEL**

Brian W. Hockett of Thompson Coburn LLP (“Movant”), pursuant to Local Rule 2090-1, moves this Court for admission to appear pro hac vice, in this case, and any related adversary proceedings, as counsel for Charter Communications Operating, LLC (“Charter”), and states as follows:

1. Movant is an attorney licensed to practice law and is a member of good standing of the state bar in Missouri and Illinois.
2. Movant is also admitted to practice before and is in good standing with the United States District Court for the Eastern and Western Districts of Missouri, the Northern, Central and Southern Districts of Illinois, Western District of Wisconsin, and the District of Kansas.
3. Movant designates L. Todd Budgen, a resident Florida attorney with Budgen Law, who is qualified to practice in this Court and who consents to designation as local counsel. Local counsel’s written designation and consent to act is attached as Exhibit A.

6. Movant certifies further that he will make himself familiar with and shall be governed by the local rules of this Court, the rules of professional conduct, and all other requirements governing the Middle District of Florida District Court and the Orlando Division of the United States District Court.

Within fourteen days from the date of an order granting this motion, Movant shall pay to the Clerk of the United States District Court for the Middle District of Florida an Attorney Special Admissions Fee in the amount of \$150.00 accompanied by a copy of the Court's order. Upon payment of the fee, Movant shall file a Notice of Compliance with the Clerk of the United States Bankruptcy Court.

WHEREFORE, Movant respectfully requests entry of an order authorizing his admission to practice and represent Charter Communications Operating, LLC in this case and any related proceedings.
