Please take notice that on May 5, 2024, the above-captioned debtor (the “Debtor”) filed a voluntary petition for relief under chapter 11 of title 11 of the U.S. Code, 11 U.S.C. §§ 101 *et seq.* (the “Bankruptcy Code”) with the United States Bankruptcy Court for the District of Delaware (the “Court”).

Please take further notice that on July 8, 2024, the Court entered an order (the “Bar Date Order”)² establishing: (i) **September 3, 2024 at 5:00 p.m. (prevailing Eastern Time)** (the “General Bar Date”) as the last date and time for each person or entity to file a Proof of Claim in this Chapter 11 Case, including claims arising under section 503(b)(9) of the Bankruptcy Code;³ (ii) **September 3, 2024 at 5:00 p.m. (prevailing Eastern Time)** (the “Administrative Claims Bar Date”) as the deadline for each person or entity that asserts a request for payment of administrative expense claims (collectively, the “Administrative Expense Claims”) arising between the Petition Date and the Closing Date (the “Administrative Claims Deadline”) to file a request for payment of such Administrative Claims; and (iii) and **November 1, 2024 at 5:00 p.m. (prevailing Eastern Time)** (the “Governmental Bar Date”) as the date by which all governmental units holding claims (whether secured, unsecured priority, or unsecured non-priority) that arose (or are deemed to have arisen) before the Petition Date must file Proofs of Claim, including claims for unpaid taxes,

whether such claims arose from prepetition tax periods or prepetition transactions to which the Debtor was a party. For your convenience, enclosed with this Notice is a Proof of Claim form (the “Proof of Claim Form”) and Administrative Claim request form (the “Administrative Claim Request Form”).

THE FACT THAT YOU HAVE RECEIVED THIS NOTICE DOES NOT MEAN THAT YOU HAVE A CLAIM AGAINST THE DEBTOR OR THAT THE DEBTOR BELIEVES THAT YOU HAVE A CLAIM AGAINST THE DEBTOR.

Please take further notice that the Bar Date Order and the procedures set forth therein and herein for the filing of (i) Proofs of Claim apply to all Claims (the holder of any such Claim, a “claimant”) that arose, or are deemed to have arisen, prior to the Petition Date, regardless of their character or nature, whether secured or unsecured, priority or non-priority, liquidated or unliquidated, fixed or contingent, including, without limitation, Claims entitled to administrative priority status under section 503(b)(9) of the Bankruptcy Code, no matter how remote or contingent and (ii) requests for payment of administrative claims arising between the Petition Date and the Closing Date (the “Administrative Claims Deadline”).

As used in this Notice, the term “creditor” has the meaning given to it in section 101(10) of the Bankruptcy Code, and includes all persons, entities, estates, trusts, governmental units and the United States Trustee. In addition, the terms “persons,” “entities” and “governmental units” are defined in sections 101(41), 101(15) and 101(27) of the Bankruptcy Code, respectively.

As used in this Notice, the term “Claim” or “Claims” has the meaning given to it in section 101(5) of the Bankruptcy Code, and includes as to or against the Debtor: (a) any right to payment, whether or not such right is reduced to judgment, liquidated, unliquidated, fixed, contingent, matured, unmatured, disputed, undisputed, legal, equitable, secured or unsecured; or (b) any right to an equitable remedy for breach of performance if such breach gives rise to a right to payment, whether or not such right to an equitable remedy is reduced to judgment, fixed, contingent, matured, unmatured, disputed, undisputed, secured or unsecured.

ALL CLAIMS

A. PROOFS OF CLAIM AND ADMINISTRATIVE CLAIM REQUEST FORMS AND MANNER OF FILING

i. Proofs of Claim and Administrative Claim Request Forms

Except as otherwise provided herein, any person or entity that has or seeks to assert a Claim which arose, or is deemed to have arisen, prior to the Petition Date, **including, without limitation, a Claim under section 503(b)(9) of the Bankruptcy Code**, **MUST FILE A PROOF OF CLAIM SO THAT IT IS ACTUALLY RECEIVED ON OR BEFORE THE APPLICABLE BAR DATE.** For the avoidance of doubt, pursuant to Bankruptcy Rule 3003(c)(2), any claimant who asserts a Claim that arose, or is deemed to have arisen, prior to the Petition Date and whose Claim is either (a) not listed on the Debtor’s Schedules or (b) is listed on the Schedules as disputed, contingent, or unliquidated, shall be required to file a Proof of Claim so that it is actually received on or prior to the applicable Bar Date in order to potentially share in the Debtor’s estate. Under the Bar Date Order, the filing of an original, written Proof of Claim Form, or the electronic

submission of a Proof of Claim Form shall be deemed to satisfy the procedural requirements for the assertion of administrative priority Claims under section 503(b)(9) of the Bankruptcy Code. **CLAIMS UNDER SECTION 503(B)(9) OF THE BANKRUPTCY CODE MUST BE FILED SO THAT SUCH PROOFS OF CLAIM ARE ACTUALLY RECEIVED BY THE GENERAL BAR DATE.**⁴ Acts or omissions of the Debtor that occurred or arose before the Petition Date may give rise to Claims that must be filed by the applicable Bar Date, notwithstanding that such Claims may not have matured, are contingent, or have not become fixed or liquidated prior to or as of the Petition Date. Any person or entity that has or seeks to assert an Administrative Expense Claim which arose after the Petition Date and prior to the Administrative Claims Deadline **MUST FILE AN ADMINISTRATIVE CLAIM REQUEST FORM SO THAT IT IS ACTUALLY RECEIVED ON OR BEFORE THE ADMINISTRATIVE CLAIMS BAR DATE.**

1. Claims for Which a Proof of Claim or Administrative Claim Request Form Need Not be Filed

Notwithstanding the above, holders of the following Claims are not required to file a Proof of Claim or Administrative Claim Request Form on or before the applicable Bar Date solely with respect to such claim:

- a) any person or entity that already has filed a Proof of Claim, in a form substantially similar to Official Bankruptcy Form B 410, or Administrative Claim Request Form against the correct Debtor with Epiq or the Clerk of the Court;
- b) any person or entity whose claim is listed on the Debtor's Schedules or any amendments thereto; *unless* (i) the claim is scheduled as "disputed," "contingent," or "unliquidated;" or (ii) the claimant disagrees with the amount, nature and/or priority of the claim as set forth in the Schedules. In the case of any of (i) or (ii), a Proof of Claim must be filed on or before the applicable Bar Date;
- c) an administrative expense claim for postpetition fees and expenses incurred by any professional retained by the Debtor's estate and allowable under sections 330, 331, and 503(b) of the Bankruptcy Code;
- d) an administrative expense claim allowable under sections 503(b) and 507(a)(2) of the Bankruptcy Code as an expense of administration (other than any claim allowable under section 503(b)(9)) that arose after the Administrative Claim Deadline;
- e) a claim on account of indemnification, contribution or reimbursement by an officer, director or employee of the Debtor who held such position as of the

Petition Date; *provided, however*, that any director, officer, or employee of the Debtor as of the Petition Date that resigns, is terminated from their employment with the Debtor, or otherwise leaves the employment of the Debtor following the Petition Date must file a Proof of Claim by the later of (i) the General Bar Date or (ii) thirty (30) days following such resignation or termination of employment if such director, officer, or employee of the Debtor asserts a contingent or unliquidated claim against the Debtor for indemnification, contribution, or for reimbursement related to the foregoing;

- f) a holder of a claim that has previously been allowed by order of the Court;
- g) a holder of a claim that has been paid in full by the Debtor or any other party;
- h) a holder of a claim for which a specific deadline to file a Proof of Claim or Administrative Claim Request Form previously has been fixed by the Court;
- i) any person or entity who holds an equity interest in the Debtor, which interest exclusively is based upon the ownership of common or preferred stock, membership interests, partnership interests, or warrants, options, or rights to purchase, sell, or subscribe to such a security or interest; *provided* that if any such holder asserts a claim (as opposed to an ownership interest) against the Debtor (including a claim relating to an equity interest or the purchase or sale of such equity interest), a Proof of Claim or an Administrative Claim Request Form, as applicable, must be filed on or before the applicable Bar Date pursuant to the procedures set for the herein;
- j) any counterparty to a lease of nonresidential real property or executory contract that asserted an Administrative Expense Claim for a cure amount in connection with an objection to the assumption and assignment of a lease or contract by the Debtor; *provided* that, any counterparty that previously asserted an unliquidated cure amount that has become liquidated or that seeks to assert amounts accrued subsequent to the filing of the cure objection must file an Administrative Claim Request Form for such additional amount;
- k) any fees payable to the Office of the United States Trustee for the District of Delaware under 28 U.S.C. § 1930;
- l) a current employee of the Debtor, if an order of this Court authorized the Debtor to honor such claim in the ordinary course of business as a wage, commission, or benefit and the Debtor have in fact honored such claim; *provided, however*, that a current or former employee must submit a Proof of Claim by the General Bar Date for all other claims, including claims for wrongful termination, discrimination, harassment, hostile work environment, retaliation, claims covered by the Debtor's workers' compensation insurance, or any other litigation or pre-litigation claim; and

- m) any person or entity that is not required to file a Proof of Claim pursuant to the *Final Order (I) Authorizing the Debtor to (A) Obtain Postpetition Financing and (B) Utilize Cash Collateral, (II) Granting Adequate Protection to Prepetition Secured Parties, (III) Modifying the Automatic Stay, and (IV) Granting Related Relief* [Docket No. 163] (the “Final DIP Order”), with respect to claims arising under, or related to, as applicable, the DIP Loan Documents (as defined under the Final DIP Order), including the Prepetition Secured Notes Agent, the Prepetition Secured Noteholders, the DIP Administrative Agent, and DIP Lenders.

Please take notice that any claimant exempted from filing a Proof of Claim or Administrative Claim Request Form, as applicable, for a claim as described in the list above must still properly and timely file a Proof of Claim or Administrative Claim Request Form, as applicable, for any other claim that does not fall within the exemptions described in the list above.

ii. Claims Arising from Rejected Executory Contracts or Unexpired Leases

Any person or entity that holds a Claim that arises from the rejection of an executory contract or unexpired lease must file a Proof of Claim based on such rejection by the later of (a) the General Bar Date and (b) thirty (30) days after service of an order authorizing the rejection of an executory contract or unexpired lease (the “Rejection Bar Date”).

iii. Schedules and Amendments thereto

You may be listed as the holder of a Claim in the Schedules. The Schedules are available free of charge on Epiq’s website at <https://dm.epiq11.com/Ambri>. If you rely on the Schedules, it is your responsibility to determine that your Claim is accurately listed in the Schedules. As described above, if (a) you agree with the nature, amount and status of your Claim as listed in the Schedules, and (b) your Claim is NOT described as “disputed,” “contingent,” or “unliquidated,” then you are not required to file a Proof of Claim in this Chapter 11 Case with respect to such Claim. Otherwise, or if you decide to file a Proof of Claim, you must do so before the applicable Bar Date in accordance with the procedures set forth in this Notice and the Bar Date Order.

If the Debtor amends its Schedules, then the Bar Date for those creditors affected by any such amendment shall be the later of (a) the General Bar Date or (b) 5:00 p.m. (Prevailing Eastern Time) on the date that is twenty-one (21) days from the date that the Debtor provided written notice to the affected creditor that the Schedules have been amended (the “Amended Schedules Bar Date” and, together with the General Bar Date, the Administrative Claim Bar Date, Governmental Bar Date, and Rejection Bar Date, the “Bar Dates,” and each a “Bar Date”).

B. WHEN AND WHERE TO FILE PROOFS OF CLAIM

All claimants must submit (by overnight mail, courier service, hand delivery, regular mail or in person) an original, written Proof of Claim that substantially conforms to the Official Bankruptcy Form No. B 410 or the enclosed Proof of Claim Form or an Administrative Claim Request Form, as applicable, so as to be **actually received** by Epiq by no later than 5:00 p.m. (prevailing Eastern Time) on or before the applicable Bar Date at the following address:

Alternatively, claimants may submit a Proof of Claim or Administrative Claim Request Form electronically through the electronic Claims filing system available at <https://dm.epiq11.com/Ambri>.

Proofs of Claim and Administrative Claim Request Forms will be deemed timely filed only if actually received by Epiq on or before the applicable Bar Date. Proofs of Claim and Administrative Claim Request Forms may **not** be delivered by facsimile, telecopy, or electronic mail transmission. Any facsimile, telecopy, or electronic mail submissions will **not** be accepted and will **not** be deemed filed until a Proof of Claim or Administrative Claim Request Form, as applicable, is submitted to Epiq by overnight mail, courier service, hand delivery, regular mail or in person or through the electronic filing system described above. Claimants wishing to receive acknowledgment that their original, written Proofs of Claim or Administrative Claim Request Forms, as applicable, were received by Epiq must submit (i) a copy of the Proof of Claim or Administrative Claim Request Form and (ii) a self-addressed, stamped envelope (in addition to the original form sent to Epiq).

C. CONTENTS OF A PROOF OF CLAIM OR ADMINISTRATIVE CLAIM REQUEST FORM

i. Proofs of Claim

As noted above, the Debtor is enclosing a Proof of Claim Form and Administrative Claim Request Form for use in this Chapter 11 Case, or you may use another proof of claim form that substantially conforms to Official Bankruptcy Form No. B 410. The Proof of Claim Form and Administrative Claim Request Form are available free of charge on Epiq's website at <https://dm.epiq11.com/Ambri>.

If your Claim is listed in the Debtor's Schedules, the Proof of Claim Form sent to you will indicate how the Debtor has scheduled your Claim in the Schedules, including (a) the amount of the scheduled Claim, if any; (b) whether the Claim is listed as disputed, contingent, or unliquidated; and (c) whether the Claim is listed as a secured, unsecured priority, or unsecured non-priority Claim.

To be valid, your Proof of Claim or Administrative Claim Request Form **MUST**: (a) be signed by the claimant (which, if submitted electronically, may be satisfied by electronic signature through the electronic Claims filing system described above); (b) be written in the English language; (c) be denominated in lawful currency of the United States; (d) conform substantially to the enclosed Proof of Claim Form or Official Form B 410, or Administrative Claim Request Form, as applicable; (e) set forth with specificity the legal and factual basis for the alleged Claim; and (f) include supporting documentation or an explanation as to why such documentation is not

available. You should redact any sensitive information from your supporting documentation prior to filing your Proof of Claim or Administrative Claim Request Form.

If you are filing a Claim under section 503(b)(9) of the Bankruptcy Code, which must be filed by the General Bar Date, you must indicate in the Proof of Claim Form the amount of the Claim that arises under section 503(b)(9) of the Bankruptcy Code. For each Claim under section 503(b)(9) of the Bankruptcy Code, you must also (i) set forth with specificity: (1) the date of shipment of the goods the claimant contends the Debtor received in the twenty (20) days before the Petition Date; (2) the date and place of delivery of the goods the claimant contends the Debtor received in the twenty (20) days before the Petition Date; (3) the value of the goods the claimant contends the Debtor received in the twenty (20) days before the Petition Date; and (4) whether the claimant timely made a demand to reclaim such goods under section 546(c) of the Bankruptcy Code; (ii) attach any documentation identifying the particular invoices for which a claim under section 503(b)(9) of the Bankruptcy Code is being asserted; and (iii) attach documentation of any reclamation demand made to the Debtor under section 546(c) of the Bankruptcy Code (if applicable).

D. CONTINGENT CLAIMS

Acts or omissions of or by the Debtor that occurred, or that are deemed to have occurred, prior to the Petition Date, including, without limitation, acts or omissions related to any indemnity agreement, guarantee, services provided to or rendered by the Debtor, or goods provided to or by the Debtor, may give rise to Claims against the Debtor and its estate notwithstanding the fact that such Claims (or any injuries on which they may be based) may be contingent or may not have matured or become fixed or liquidated prior to the Petition Date. Therefore, any person or entity that holds a Claim or potential Claim against the Debtor and its estate, no matter how remote, contingent, or unliquidated, **MUST** file a Proof of Claim on or before the applicable Bar Date.

CONSEQUENCES FOR FAILURE TO FILE A PROOF OF CLAIM OR ADMINISTRATIVE CLAIM REQUEST FORM

Any claimant that is required to file a Proof of Claim or Administrative Claim Request Form, as applicable, in this Chapter 11 Case pursuant to the Bankruptcy Code, the Bankruptcy Rules or the Bar Date Order with respect to a particular Claim, but that fails to do so properly by the applicable Bar Date, (a) may be forever barred, estopped, and enjoined from asserting such claim against the Debtor, its estate, or property of the Debtor, or thereafter filing a Proof of Claim or Administrative Claim Request Form with respect thereto in the Chapter 11 Case, unless otherwise ordered by the Court; (b) shall not, with respect to such claim, be treated as a Creditor of the Debtor for the purposes of voting upon any plan in the proceeding; and (c) shall not receive or be entitled to receive any payment or distribution of property from the Debtor or its successors or assigns with respect to such claim, without further order of this Court.

RESERVATION OF RIGHTS

Nothing contained in this Notice or the Bar Date Order is intended or should be construed as a waiver of any of the Debtor's rights, including without limitation, their rights to: (a) dispute, or assert offsets or defenses against, any filed Claim or any Claim listed or reflected in the Schedules

as to the nature, amount, liability or classification thereof; (b) subsequently designate any scheduled Claim as disputed, contingent or unliquidated; or (c) otherwise amend or supplement the Schedules. In addition, nothing contained herein is intended or should be construed as an admission of the validity of any Claim or an approval, assumption or rejection of any agreement, contract or lease under section 365 of the Bankruptcy Code. All such rights and remedies are reserved.

Administrative expense: Generally, an expense that arises after a bankruptcy case is filed in connection with operating, liquidating, or distributing the bankruptcy estate. 11 U.S.C. § 503.

Claim: A creditor's right to receive payment for a debt that the debtor owed on the date the debtor filed for bankruptcy. 11 U.S.C. §101 (5). A claim may be secured or unsecured.

Claim Pursuant to 11 U.S.C. §503(b)(9): A claim for the value of any goods that were sold to the Debtors in the ordinary course of its business and were received by the Debtors within 20 days before the date of commencement of the above case. Attach documentation supporting such claim.

Creditor: A person, corporation, or other entity to whom a debtor owes a debt that was incurred on or before the date the debtor filed for bankruptcy. 11 U.S.C. §101 (10).

Debtor: A person, corporation, or other entity who is in bankruptcy. Use the debtor's name and case number as shown in the bankruptcy notice you received. 11 U.S.C. § 101 (13).

Evidence of perfection: Evidence of perfection of a security interest may include documents showing that a security interest has been filed or recorded, such as a mortgage, lien, certificate of title, or financing statement.

Information that is entitled to privacy: A Proof of Claim form and any attached documents must show only the last 4 digits of any social security number, an individual's tax identification number, or a financial account number, only the initials of a minor's name, and only the year of any person's date of birth. Proof of claim: A form that shows the amount of debt the debtor owed to a creditor on the date of the bankruptcy filing. The form must be filed in the district where the case is pending.

Redaction of information: Masking, editing out, or deleting certain information to protect privacy. Filers must redact or leave out information entitled to **privacy** on the Proof of Claim form and any attached documents.

Secured claim under 11 U.S.C. §506(a): A claim backed by a lien on particular property of the debtor. A claim is secured to the extent that a creditor has the right to be paid from the property before other creditors are paid. The amount of a secured claim usually cannot be more than the value of the particular property on which the creditor has a lien. Any amount owed to a creditor that is more than the value of the property normally may be an unsecured claim. But exceptions exist; for example, see 11 U.S.C. § 1322(b) and the final sentence of 1325(a).

Examples of liens on property include a mortgage on real estate or a security interest in a car. A lien may be voluntarily granted by a debtor or may be obtained through a court proceeding. In some states, a court judgment may be a lien.

Certain entities purchase claims for an amount that is less than the face value of the claims. These entities may contact creditors offering to purchase their claims. Some written communications from these entities may easily be confused with official court documentation or communications from the debtor. These entities do not represent the bankruptcy court, the bankruptcy trustee, or the debtor. A creditor has no obligation to sell its claim. However, if a creditor decides to sell its claim, any transfer of that claim is subject to Bankruptcy Rule 3001(e), any provisions of the Bankruptcy Code (11 U.S.C. § 101 et seq.) that apply, and any orders of the bankruptcy court that apply.
