**FIRST AND FINAL APPLICATION FOR
COMPENSATION OF GENESIS CREDIT PARTNERS LLC AS FINANCIAL
ADVISOR TO THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS**

Genesis Credit Partners LLC (“GCP” or “Applicant”), as financial advisor to the Official Committee of Unsecured Creditors (the “Committee”) in the bankruptcy cases of the above-captioned debtors and debtors-in-possession (collectively, the “Debtors”) hereby files this application (the “Application”) for an order, pursuant to sections 328 and 330 of title 11 of the United States Code (the “Bankruptcy Code”), Rule 2016 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), and Rule 2016-1 of the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the Middle District of Florida (the “Local Rules”), and consistent with the *Procedure Manual for the United States Bankruptcy Court for the*

Middle District of Florida (the “Procedure Manual”), authorizing and approving the compensation for fees for services rendered and costs incurred by the Applicant for the period of June 4, 2024 through September 5, 2024 (the “Compensation Period”) on a final basis. In support of the Application, the Committee respectfully represents as follows:

Background

1. On May 19, 2024 (the “Petition Date”), the Debtors filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Middle District of Florida (the “Bankruptcy Court”), commencing these chapter 11 cases (the “Chapter 11 Cases”).

2. The Debtors continue to operate their business and manage their affairs as debtors-in-possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

3. No trustee or examiner has been appointed in the Chapter 11 Cases.

4. On May 31, 2024, the Office of the United States Trustee appointed the Committee pursuant to section 1102(a)(1) of the Bankruptcy Code [Docket No. 250]. The Committee is comprised of nine (9) members: (i) Warner Bros. Discovery, Inc., on behalf of itself and its subsidiaries; (ii) Kenneth O. Lester Company, Inc. d/b/a Performance Food Group; (iii) Gordon Food Service Canada Ltd.; (iv) PepsiCo Sales, Inc.; (v) George Parker; (vi) Realty Income Corporation; (vii) Credera Enterprises Company, LLC; (viii) Rubin Postaer and Associates; and (ix) Provender Hall I, LLC and Provender Hall IV, LLC.

5. On June 3, 2024, the Committee selected Pachulski Stang Ziehl & Jones LLP (“PSZ&J”) to serve as its lead counsel. On June 4, 2024, the Committee selected Pack Law to serve as its Florida counsel and Genesis Credit Partners LLC to serve as its financial adviser in the Chapter 11 Cases.

6. On July 25, 2024, this Court approved the employment and retention of GCP as financial advisor to the Committee [Docket No. 666] (the “GCP Retention Order”) and the application therefor [Docket No. 490] (the “GCP Retention Application”).

7. On July 19, 2024, the Debtors proposed the *Joint Chapter 11 Plan of Red Lobster Management LLC and Its Debtor Affiliates* [ECF. No. 631] (as may be amended, modified or supplemented, including as revised in Docket No. 733, the “Plan”). On July 29, 2024, this Court entered an order [Docket No. 736] (the “Confirmation Scheduling Order”) setting a hearing for September 5, 2024 at 10:00 a.m. (ET) to consider confirmation of the Plan (the “Confirmation Hearing”). The Court further ordered, “[t]o be considered at the Confirmation Hearing, fee applications (with all exhibits) must (a) be timely filed and served by the deadline listed above on (i) the Debtors; (ii) all committees that have been appointed; (iii) any chapter 11 trustee or examiner that has been appointed; and (iv) the U.S. Trustee, and (b) include an estimate of additional time and costs to be incurred from the end of the application period through the date of the Confirmation Hearing.” Docket No. 736, ¶ 51.

Jurisdiction and Venue

8. The Bankruptcy Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334. The Committee and the Applicant confirm their consent, pursuant to Bankruptcy Rule 7008, to the entry of a final order by the Bankruptcy Court in connection with this Application to the extent that it is later determined that the Bankruptcy Court, absent consent of the parties, cannot enter final orders or judgments in connection herewith consistent with Article III of the United States Constitution.

9. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

Duties of the Applicant

10. The professional services of the Applicant, as approved by the GCP Retention Order, included:

- a. Familiarizing the Committee and its counsel with and analyzing the Debtor's budget, assets and liabilities, and overall financial condition;
- b. Reviewing financial and operational information furnished by the Debtor;
- c. Facilitating or assisting in monitoring any and all sale processes; analysis of marketing efforts, outreach and potential supplementation as requested; reviewing bidding procedures, stalking horse bids, indications of interest received, schedules of cures and asset purchase agreements, and assessing the economics thereof; interfacing with the Debtor's professionals; and advising the Committee regarding the process;
- d. Scrutinizing the economic terms of various agreements;
- e. Monitoring and updating the Committee on Debtors' proposed turnaround and operational improvement plans and analyzing any forecast economics and financials;
- f. Assessing the Debtors' proposed store lease rejections, including analysis of store economics, economic potential and remedies available;
- g. Assessing the Debtors' various pleadings and proposed treatment of unsecured creditor claims therefrom;
- h. Preparing, or reviewing as applicable, avoidance action and claim analyses and other investigative analyses as requested by the Committee and counsel;
- i. Investigation and assessment of various past financial and other transactions by the Debtors and the management team;
- j. Assisting the Committee in reviewing the Debtors' financial reports, including, but not limited to, statements of financial affairs, schedules of assets and liabilities, DIP budgets, and monthly operating reports;
- k. Advising the Committee on the current state of these chapter 11 cases;
- l. Advising the Committee in negotiations with the Debtors and third parties as necessary;
- m. If necessary, participating as a witness in hearings before the Court with respect to matters upon which GCP has provided advice; and

- n. Other activities as are approved by the Committee, the Committee's counsel, and as agreed to by GCP.

Indexing of Tasks by Activity Code

11. As set forth in the Exhibits to this Application, the Applicant has organized its time records by activity codes in accordance with the applicable guidelines. Accordingly, each of the time entries of the professionals of the Applicant have been indexed into such categories, the most relevant of which are listed below and summarized in the sections that follow:

- i. Business Analysis / Operations;
- ii. Committee Activities;
- iii. Plan & Disclosure Statement;
- iv. Litigation;
- v. Sale Process; and
- vi. Claims Analysis and Objections.

I. Business Analysis / Operations:

12. During the Compensation Period, the Applicant's professionals analyzed and assessed diligence materials provided by the Debtors; benchmarked debtor-in-possession economics, professional and transaction fees, and sale process economics; engaged with the Debtors' advisors regarding materials provided; analyzed the four-wall profitability by store locations, rejection or retention rationales, and benchmarking metrics; monitored the progress of rent restructurings, analyzed and created scenarios with respect to concessions, and engaged with Debtors' advisors regarding such; met with Debtors' management team and advisors; analyzed the Debtors' 13 week cashflow budgets and long-range plan financial models; investigated underlying projection assumptions and created sensitized forecasts based on key business drivers; monitored and analyzed the Debtors' financial performance during the case; investigated the solvency of the

Debtors at various points in time and analyzed certain corporate actions; and assessed historical performance and future prospects for and benchmarked the Debtors' business, its key comparables and competitors, and the industry in which they operate for multiple purposes including plan feasibility and informing parties in interest of the credit quality of the reorganized Debtors.

13. The Applicant expended 1,265.1 hours in this category and is requesting \$715,420.00 for the services rendered in this category.

II. Committee Activities:

14. During the Compensation Period, the Applicant's professionals prepared Committee update presentations and other materials including those related to case strategies; participated in regularly scheduled meetings with the Committee and its professionals, and the Debtors and their professionals; investigated issues of interest and created analyses as requested; analyzed and assessed various settlement proposals, their impacts on DIP financing, and estimated potential recovery scenarios; and conferred with Committee counsel on numerous issues of interest.

15. The Applicant expended 297.9 hours in this category and is requesting \$188,230.00 for the services rendered in this category.

III. Plan & Disclosure Statement:

16. During the Compensation Period, the Applicant's professionals analyzed ongoing drafts of the plan of reorganization and disclosure statement; assessed recovery scenarios with respect to valuation and liquidation analyses; assessed plan feasibility and other elements of interest with respect to unsecured creditors; and performed other research and analysis of the plan and disclosure statement data relative to comparable peers.

17. The Applicant expended 42.7 hours in this category and is requesting \$32,515.00 for the services rendered in this category.

IV. Litigation:

18. During the Compensation Period, the Applicant's professionals researched and analyzed pre-petition events which led to the Debtors' chapter 11 filing; compiled a detailed request list of focus items to be produced by the Debtors and assisted the Committee's counsel in their investigation into causes of action, which remains ongoing.

19. The Applicant expended 47.9 hours in this category and is requesting \$27,350.00 for the services rendered in this category.

V. Sale Process:

20. During the Compensation Period, the Applicant's professionals participated in weekly scheduled meetings with the Debtors' investment bankers; monitored the sale process; and analyzed proposed sale process procedures.

21. The Applicant expended 30.9 hours in this category and is requesting \$19,350.00 for the services rendered in this category.

VI. Claims Analysis and Objections:

22. During the Compensation Period, the Applicant's professionals analyzed initial lease rejection lists, estimated and verified rejection damage claims; reviewed and analyzed proofs of claim to indicatively assess initial pool sizing estimates; assessed potential employee liability claims and sized the range of potential scenarios; and worked to understand underlying assumptions with respect to estimated claims pool and other calculations.

23. The Applicant expended 59.4 hours in this category and is requesting \$45,345.00 for the services rendered in this category.

Professional Compensation

24. As set forth in the GCP Retention Application, the Committee desired to employ GCP and compensate GCP with reasonable fees to be determined by the Court. GCP received no retainer in these cases to represent the Committee. GCP's standard hourly rates, as set forth in the GCP Retention Application are:

Evaluation of Services Rendered

25. This Application has presented a summary of the nature and extent of the professional services the Applicant has rendered in connection with its representation of the Committee for which the Applicant seeks compensation. A mere reading of the time summary annexed hereto alone cannot completely reflect the full range of services the Applicant rendered and the complexity of the issues and the pressures of time and performance which have been placed on the Applicant in connection with the Chapter 11 Cases.

26. Section 330 of the Bankruptcy Code authorizes the Bankruptcy Court to award reasonable compensation for actual, necessary, services rendered by professionals employed by a committee appointed pursuant to section 1102. Courts in the Eleventh Circuit have determined "reasonableness" with reference to the twelve factors¹ set forth in *Johnson v. Georgia Highway*

¹ The 12 factors set forth in *Johnson* are: (1) the time and labor required; (2) the novelty and difficulty of the legal questions presented; (3) the skill required to perform the legal services properly; (4) the preclusion from other employment by the professional due to acceptance of the case; (5) the customary fee for similar work in the community; (6) whether the fee is fixed or contingent; (7) the time limitations imposed by the client or circumstances; (8) the amount involved and results obtained; (9) the experience, reputation and ability of the professionals; (10) the undesirability of the case; (11) the nature and length of the professional relationship with the client; and (12) awards in similar cases. See *Johnson* 488 F.2d at 717-19.

Express, Inc., 488 F.2d 714, 717–19 (5th Cir. 1974).² See *Grant v. George Schumann Tire & Battery Co.*, 908 F.2d 874, 877–78 (11th Cir. 1990); *In re Rosenberg*, Case No. 09-13196-BKC-AJC, 2018 WL 3933661, at *4–5 (July 5, 2018); *In re Warner*, 141 B.R. 762, 765 (M.D. Fla. 1992); *In re Blue Stone Real Estate*, 487 B.R. 573, 576 (Bankr. M.D. Fla. 2013). However, given the 1994 and 2005 amendments to the Bankruptcy Code, some of the *Johnson* factors are now subsumed or overlapped by the statute. *Id.*

27. Based on the standards set forth in section 330 of the Bankruptcy Code, the *Johnson* factors, relevant practice and case law in the Eleventh Circuit, and considering the nature, extent, and value of the Applicant’s services, taking into account all relevant factors, the Applicant believes that the fair and reasonable value of its services rendered during the Compensation Period is \$1,139,085.00 for 1,906.5 hours worked, plus the actual and reasonable expenses incurred by Applicant necessary to perform its services in the amount of \$11,740.61.

28. Alternatively, the Applicant notes that the services rendered herein were “reasonably likely to benefit” the Committee at the time the services were rendered. Accordingly, under the “reasonable at the time” standard, the fees and costs sought herein should be approved. See *In re Woerner*, 783 F.3d 266, 276 (5th Cir. 2015).

29. The Time Spent on Such Services. The foregoing summary, together with the Exhibits attached hereto, details the time and extent of the professional services rendered by the Applicant for the benefit of the Committee during the Compensation Period. The total number of hours expended, 1,906.5, reveals the extensive time devoted to this matter by the Applicant on a vast spectrum of legal issues which arose in the Chapter 11 Cases during Compensation Period.

² The Eleventh Circuit has adopted as binding precedent all cases decided by the former Fifth Circuit prior to the close of business on September 30, 1981. See *Bonner v. Prichard*, 661 F.2d 1206, 1209 (11th Cir. 1981).

30. The Rates Charged for Services. The compensation which the Applicant requests comports with the mandate of the Bankruptcy Code, which directs that services be evaluated in light of comparable services performed in non-bankruptcy cases in the community. The hourly rates charged by the Applicant, as set forth in the Exhibits attached hereto, range from \$300.00 to \$1,000.00 per hour, which is customary for professionals Florida of similar skill and experience.

31. Time Commensurate with Complexity, Importance, and Nature of the Tasks. The Applicant has devoted 1,906.5 hours of work in rendering services to the Committee, as more fully described in the Exhibits attached hereto. The fees requested represent a blended hourly rate of \$597.47. The Applicant respectfully submits that, in light of the results obtained, complexity of the issues addressed, importance of the tasks completed, and quality of the work product provided to the Committee and paper filed with the Bankruptcy Court, the aforementioned time is wholly commensurate with the tasks rendered and the rate applicable to such time is wholly reasonable.

32. Skill and Expertise. The Applicant is a financial advising firm that has demonstrated, both in the Chapter 11 Cases and others of like complexity, its skill and expertise in the practice of bankruptcy law. As the GCP Retention Application makes clear and states in greater detail, the relief requested herein is commensurate with the skill and expertise of the Applicant.

33. Preclusion from Other Employment. As set forth above and in the Exhibits attached hereto, the Applicant has devoted 1,906.5 hours of work in rendering services to the Committee. While the Applicant is aware of no other specific employment that was precluded wholesale as a result of the Applicant accepting these Chapter 11 Cases, had the Applicant not accepted employment in the Chapter 11 Cases, the 1,906.5 hours spent in the Chapter 11 Cases would have been spent on other matters that would pay an hourly compensation at the same rates as those discussed herein.

34. Reasonable Compensation when Compared to Non-Chapter 11 Cases. As set forth above and in the Exhibits attached hereto, the hourly rates charged by the Applicant range from \$300.00 to \$1,000.00 per hour, which is customary for (if not less than) professionals Florida of similar skill and experience.

Estimating Fees and Expenses to be Incurred
Between the Date Hereof and the Confirmation Hearing

35. Consistent with the terms of the Confirmation Scheduling Order, the Applicant estimates that it shall incur approximately \$21,500.00 for services rendered and out-of-pocket expenses incurred on behalf of the Committee between the date hereof and the Confirmation Hearing. The Applicant shall submit to this Court, prior to the Confirmation Hearing, a supplement to this Application documenting time expended and expenses incurred during such period.

WHEREFORE, the Applicant respectfully requests the Bankruptcy Court enter an order (i) awarding the Applicant, on a final basis, the sum of \$1,139,085.00, as compensation for services rendered during the Compensation Period, and the sum of \$11,740.61, as reimbursement for actual and necessary expenses incurred during the Compensation Period, plus such other amounts as may be supplemented hereto prior to the Confirmation Hearing; (ii) authorizing and directing the Debtors' estates to pay to the Applicant, upon entry of an Order awarding the fees and expenses requested in this Application, all such fees and expenses; and (iii) granting such other and further relief as the Bankruptcy Court deems appropriate.

- e. in providing a reimbursable expense, the Applicant does not make a profit on that expense, whether the service is performed by the Applicant in-house or through a third party;
