SECOND SUPPLEMENTAL DECLARATION OF JONATHAN TIBUS IN SUPPORT OF THE EMERGENCY APPLICATION OF THE DEBTORS PURSUANT TO 11 U.S.C. §§ 105(a) AND 363(b) TO (I) RETAIN ALVAREZ & MARSAL NORTH AMERICA, LLC TO PROVIDE THE DEBTORS A CHIEF EXECUTIVE OFFICER, A CHIEF RESTRUCTURING OFFICER, AND CERTAIN ADDITIONAL PERSONNEL, (II) DESIGNATE JONATHAN TIBUS AS CHIEF EXECUTIVE OFFICER, AND (III) DESIGNATE NICHOLAS HAUGHEY AS CHIEF RESTRUCTURING OFFICER FOR THE DEBTORS, IN EACH CASE, EFFECTIVE AS OF THE PETITION DATE

I, Jonathan Tibus, hereby state as follows:

1. I am a Managing Director with Alvarez & Marsal North America, LLC (together with employees of its professional service provider affiliates (all of which are wholly owned by its parent company and employees), its wholly owned subsidiaries and independent contractors, “A&M”), a restructuring advisory services firm with numerous offices throughout the world. I submit this second supplemental declaration on behalf of A&M (the “Second Supplemental Declaration”) in further support of the *Emergency Application of the Debtors Pursuant to 11 U.S.C. §§ 105(a) and 363(b) to (I) Retain Alvarez & Marsal North America, LLC to Provide the Debtors a Chief Executive Officer, and Chief Restructuring Officer, and Certain Additional Personnel, (II) Designate Jonathan Tibus as Chief Executive Officer, and (III) Designate Nicholas Haughey as Chief Restructuring Officer for the Debtors, in Each Case Effective as of the Petition Date* (the “Application”)² [ECF No. 11] and to supplement my prior declarations that were submitted in connection with A&M’s retention in these chapter 11 cases. Unless otherwise stated herein, I have personal knowledge of the facts set forth herein or have been informed of such matters by professionals of A&M.

2. On May 19, 2024, (the “Petition Date”), Red Lobster Management LLC and its affiliated debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the “Debtors”) commenced these cases by filing voluntary petitions for relief under chapter 11 of title 11 of the United States Code in the United States Bankruptcy Court for the District of the Middle District of Florida, Orland Division (the “Court”).

3. On May 19, 2024, the Debtors filed the Application and my attached declaration in support of the Application (the “Original Declaration”).

4. On May 31, 2024, the Debtors filed their First Supplemental Declaration in support of the Application (the “First Supplemental Declaration” and together with the Original Declaration, the “Prior Declarations”).

5. On June 14, 2024, the Court entered an *Order Approving Application to Employ/Retain Alvarez & Marsal North America, LLC to Provide the Debtors a Chief Executive Officer, A Chief Restructuring Officer, and Certain Additional Personnel, (II) Designate Jonathan Tibus as Chief Executive Officer, and (III) Designate Nicholas Haughey as Chief Restructuring Officer for the Debtors, in each case, Effective as of the Petition Date.* [ECF No. 384].

6. I submit this Second Supplemental Declaration to disclose certain additional information that has become available to A&M since the filing of the Prior Declarations.

ADDITIONAL POTENTIAL PARTIES IN INTEREST

7. In connection with its proposed retention by the Debtors in these cases, A&M has undertaken an ongoing analysis to determine whether any material relevant facts or relationships have arisen or been discovered. In connection therewith, it has come to A&M’s attention that the entities identified on Schedule A hereto (“New Parties”) are parties involved in the Debtors’ chapter 11 cases who were not identified on Schedule A to the Prior Declarations. The New Parties together with the parties identified on Schedule A to the Prior Declarations are hereinafter referred to as the “Potential Parties in Interest”.

8. Based on the Firm Procedures described in the Original Declaration, the relationships with the New Parties are identified on Schedule B hereto.

9. Based on the results of its review, to the best of my knowledge, except as set forth in the Prior Declarations or herein, A&M does not have an active relationship with any of Potential Parties in Interest in matters relating to the Debtors' chapter 11 cases.

10. In addition to the connections noted on Schedule B hereto, I note the following:

- (a) A&M personnel hold de minimis investments, representing not more than 0.01% of the equity interests in the related entity, in various Potential Parties in Interest, including but not limited to Amazon.com, AT&T Corp., Banc of America Merchant Services LLC, Barclays Bank Plc, Equinix Inc, Hewlett-Packard Company, JP Morgan Chase Bank NA, Uber Technologies Inc, and Verizon.
- (b) JPMorgan Chase Bank, N.A., together with certain of its affiliates (collectively, "JPMC"), are Potential Parties in Interest. Under a credit facility (the "Credit Facility") to A&M's parent company Alvarez & Marsal Holdings, LLC ("A&M Holdings"): JPMC is a lender and the syndication agent and one of the joint lead arrangers and joint book runners. JPMC receives certain customary and negotiated fees and reimbursement of expenses in connection with the listed roles under the Credit Facility.

11. To the extent any information disclosed herein requires amendment or modification upon A&M's completion of further review or as additional party-in-interest information becomes available to it, a further supplemental declaration reflecting such amended or modified information will be submitted to the Court.
