**PLEASE TAKE NOTICE** that Atlantic Neurosurgical Specialists, P.A., ANS Newco LLC (together, “ANS” or the “ANS Debtors”), and Hanover Hills Surgery Center LLC (“Hanover Hills,” and together with the ANS Debtors, the “Debtors” and each a “Debtor”), each debtors and debtors in possession in the above-captioned chapter 11 cases. On June 5, 2024, the ANS Debtors filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. §§ 101-1532 (the “Bankruptcy Code”) in the United States Bankruptcy Court for the District of New Jersey (the “Court”), and on July 12, 2024, Hanover Hills filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code in the Court.

**PLEASE TAKE FURTHER NOTICE** that on August 2, 2024, the Debtors filed the *Debtors' Motion for Entry of an Order (I) Setting Bar Dates for Filing Proofs of Claim, Including Requests for Payment Under Section 503(b)(9), (II) Setting a Bar Date for the Filing of Proofs of Claim by Governmental Units, (III) Establishing Amended Schedules Bar Date and Rejection Damages Bar Date, (IV) Approving the Form and Manner for Filing Proofs of Claim, (V) Approving Notice of Bar Dates, and (VI) Granting Related Relief* [Docket No. 105] (the "Bar Date Motion") with the Court. On August 27, 2024, the Court entered an order approving the Bar Date Motion [Docket No. 154] (the "Bar Date Order") and establishing certain dates (each, a "Bar Date," and collectively, the "Bar Dates") by which parties holding claims against the Debtors arising prior to the date of the applicable Debtor's bankruptcy filing, and claims arising under section 503(b)(9) of the Bankruptcy Code must file proofs of claim against the Debtors. - A. General Information About the Debtors' Cases.** The Debtors' cases are being jointly administered under case number 24-15726(VFP). No request for the appointment of a trustee or examiner has been made in these chapter 11 cases (these "Chapter 11 Cases").
- B. - C. Schedules of Assets and Liabilities.** On July 2, 2024, the ANS Debtors filed their statements of financial affairs, schedules of assets and liabilities, schedules of current income and expenditures, and schedules of executory contracts and unexpired leases with the Court (collectively, the "Schedules"), and on August 16, 2024, Hanover Hills filed their Schedules. The Debtors' Schedules may be examined and inspected by interested parties during regular business hours at (a) the offices of Fox Rothschild LLP at 49 Market Street, Morristown, New Jersey 07960, or during posted hours at (b) the Clerk of the Bankruptcy Court, United States Bankruptcy Court, District of New Jersey, 400 Cooper Street,

<b>Hanover Hills Governmental Bar Date:</b>	<b><u>January 8, 2025 at 4:00 p.m. prevailing Eastern Time</u></b> is the date by which all governmental units holding claims (whether secured, unsecured priority, or unsecured nonpriority) must file proofs of claim, including claims for unpaid taxes, whether such claims arise from prepetition tax years or periods, or prepetition transactions to which Hanover Hills was a party.

**Parties Required to File Claim Forms**

- A. Definition of Claim.** Under section 101(5) of the Bankruptcy Code and as used herein, the word “claim” means: (i) a right to payment, whether or not such right is reduced to judgment, liquidated, unliquidated, fixed, contingent, matured, unmatured, disputed, undisputed, legal, equitable, secured, or unsecured; or (ii) a right to an equitable remedy for breach of performance if such breach gives rise to a right to payment, whether or not such right to an equitable remedy is reduced to judgment, fixed, contingent, matured, unmatured, disputed, undisputed, secured, or unsecured.
- B. Parties Who Must File Claim Forms.** Except as otherwise set forth herein, any person or entity that holds claims against the Debtors that arose (or are deemed to have arisen) before the date of the applicable Debtor’s bankruptcy filing must file proofs of claim on or before the applicable Bar Date.
- C. Parties Who Do Not Need to File Claim Forms.** Certain parties are not required to file proofs of claim. The Court may, however, enter one or more separate orders at a later time requiring holders of claims to file proofs of claim and setting related deadlines. If the Court does not enter such an order, you will receive notice of it.

The following persons or entities holding claims that would otherwise be subject to the applicable Bar Date need not file proofs of claim:

- a. any person or entity who already has filed a signed proof of claim against the respective Debtor(s) with the Clerk of the Court or with Epiq in a form substantially similar to Official Form 410;
- b. any person or entity whose claim is listed on the Schedules if: (i) the claim is not scheduled as any of “disputed,” “contingent,” or “unliquidated;” (ii) such person or entity agrees with the amount, nature, and priority of the claim as set forth in the Schedules; and (iii) such person or entity does not dispute that its claim is an obligation only of the specific Debtor against which the claim is listed in the Schedules;
- c. any person or entity whose claim has previously been allowed by order of the Court;
- d. any person or entity whose claim has been paid in full by the Debtors pursuant to the Bankruptcy Code or in accordance with an order of the Court;

- e. a holder of a claim for which a specific deadline to file a claim previously has been fixed by the Court;
- f. any Debtor or non-Debtor subsidiary having a claim against another Debtor;
- g. any person or entity whose claim is solely against any of the Debtors' non-Debtor affiliates;
- h. a current employee of the Debtors, if an order of this Court authorized the Debtors to honor such claim in the ordinary course of business; provided that a current employee must submit a proof of claim by the General Bar Date for all other claims arising before the date of the applicable Debtor's bankruptcy filing, including, but not limited to, claims for wrongful termination, discrimination, harassment, hostile work environment, and/or retaliation;
- i. any counterparty to an executory contract or unexpired lease whose contract or lease is assumed or assumed and assigned by the Debtors;
- j. any entity that holds a claim allowable under sections 503(b) and 507(a)(2) of the Bankruptcy Code as an administrative expense (other than any claim allowance under section 503(b)(9) of the Bankruptcy Code);
- k. any person or entity holding a claim for which a separate deadline is fixed by the Court; and
- l. holders of claims for fees and expenses of professionals retained in these chapter 11 cases.

#### **Instructions for Filing Claim Forms**

- A. Contents of Claim Form.** Each Claim Form must (i) be written in English; (ii) include a claim amount denominated in United States dollars (and to the extent such claim is converted to United States dollars, the conversion rate used in such conversion); (iii) conform substantially to the Claim Form provided by the Debtors; and (iv) be signed by the holder of the claim or by an authorized agent of the holder of the claim (along with documentation of such authorization);
- B. Original Signatures Required.** Only (i) original Claim Forms or (ii) Claim Forms submitted using the electronic filing interface available at <https://dm.epiq11.com/case/atq/info> will be deemed acceptable for purposes of claims administration. Copies of Claim Forms or Claim Forms sent by facsimile or electronic mail will **not** be accepted;



- C. Identification of the Debtor Entity.** Except as otherwise required by the Bar Date Order, each Claim Form must clearly identify the Debtor against which a claim is asserted, including the individual Debtor's case number;
- D. Claim Against Multiple Debtor Entities.** Except as otherwise required by the Bar Date Order, each Claim Form must state a claim against only one Debtor and clearly indicate the Debtor against which the claim is asserted. **To the extent that more than one Debtor is listed on the Claim Form, such claim will be treated as if filed only against the first-listed Debtor;**
- E. Supporting Documentation.** Each Claim Form must include supporting documentation in accordance with Bankruptcy Rules 3001(c) and 3001(d);
- F. - G. Receipt of Service.** Claimants wishing to receive acknowledgment that their Claims Forms were received by Epiq must submit (i) a copy of the Claim Form, and (ii) a self-addressed, stamped envelope.

**Consequences of Failing to Timely File Your Claim Form**

Pursuant to the Bar Date Order and in accordance with Bankruptcy Rule 3003(c)(2), if you or any party or entity who is required, but fails, to file a proof of claim in accordance with the Bar Date Order on or before the applicable Bar Date, please be advised that (absent the consent of the Debtors, in their sole discretion):

- **YOU WILL BE FOREVER BARRED, ESTOPPED, AND ENJOINED FROM ASSERTING SUCH CLAIM AGAINST THE DEBTORS (OR FILING A PROOF OF CLAIM WITH RESPECT THERETO);**
- **YOU WILL NOT RECEIVE ANY DISTRIBUTION IN THESE CHAPTER 11 CASES ON ACCOUNT OF THAT CLAIM; AND**
- **YOU WILL NOT BE PERMITTED TO VOTE ON ANY CHAPTER 11 PLAN OR PLANS FOR THE DEBTORS ON ACCOUNT OF THAT CLAIM OR RECEIVE FURTHER NOTICES REGARDING SUCH CLAIM.**

**Amendments to the Debtors' Schedules**

- A. Amendments to Schedules.** In the event that the Debtors amend their Schedules after the date of this notice, the Debtors will provide holders of claims that are affected by any such amendment notice of the amendment, and such parties will be given an opportunity to file proofs of claim before a new deadline that will be specified in that future notice.
- B. Amended Schedules Bar Date.** The Court has approved the later of (i) the General Bar Date or, if applicable, the ANS Governmental Bar Date or the Hanover Hills Governmental Bar Date (as applicable); and (ii) thirty (30) days from the date on which the Debtors provide notice of the amendment to the Schedules as the date by which holders of claims affected by the amendment must file proofs of claim with respect to such claims.

**Parties to the Debtors' Leases and Executory Contracts**

- A. Rejection of Leases and Contracts.** The Bankruptcy Code provides that Debtors may, at any time before a plan of reorganization is confirmed by the Court, choose to reject certain executory contracts or unexpired leases. If your contract or lease is rejected, you may have a claim resulting from that rejection.
- B. Rejection Damages Bar Date.** The deadline to file a proof of claim for damages relating to the rejection of the contract or lease is the later of (i) the General Bar Date or, if applicable, the ANS Governmental Bar Date or the Hanover Hills Governmental Bar Date (as applicable); and (ii) thirty (30) days after the date of service of a Court order authorizing such rejection.

**Reservation of Rights**

Nothing contained in this notice is intended to or should be construed as a waiver of the Debtors' right to: (a) dispute, or assert offsets or defenses against, any filed claim or any claim listed or reflected in the Schedules as to the nature, amount, liability, or classification thereof; (b) subsequently designate any scheduled claim as disputed, contingent, or unliquidated; or (c) otherwise amend or supplement the Schedules.

#### **Understand the terms used in this form**

**Administrative expense:** Generally, an expense that arises after a bankruptcy case is filed in connection with operating, liquidating, or distributing the bankruptcy estate. 11 U.S.C. § 503.

**Claim:** A creditor's right to receive payment for a debt that the debtor owed on the date the debtor filed for bankruptcy. 11 U.S.C. §101 (5). A claim may be secured or unsecured.

**Claim Pursuant to 11 U.S.C. §503(b)(9):** A claim for the value of any goods that were sold to the Debtor in the ordinary course of its business and were received by the Debtor within 20 days before the date of commencement of the above case. Attached documentation supporting such claim.

**Creditor:** A person, corporation, or other entity to whom a debtor owes a debt that was incurred on or before the date the debtor filed for bankruptcy. 11 U.S.C. §101 (10).

**Debtor:** A person, corporation, or other entity who is in bankruptcy. Use the debtor's name and case number as shown in the bankruptcy notice you received. 11 U.S.C. § 101 (13).

**Evidence of perfection:** Evidence of perfection of a security interest may include documents showing that a security interest has been filed or recorded, such as a mortgage, lien, certificate of title, or financing statement.

**Information that is entitled to privacy:** A *Proof of Claim* form and any attached documents must show only the last 4 digits of any social security number, an individual's tax identification number, or a financial account number, only the initials of a minor's name, and only the year of any person's date of birth. If a claim is based on delivering health care goods or services, limit the disclosure of the goods or services to avoid embarrassment or disclosure of confidential health care information. You may later be required to give more information if the trustee or someone else in interest objects to the claim.

**Priority claim:** A claim within a category of unsecured claims that is entitled to priority under 11 U.S.C. §507(a). These claims are paid from the available money or property in a bankruptcy case before other unsecured claims are paid. Common priority unsecured claims include alimony, child support, taxes, and certain unpaid wages.

**Proof of claim:** A form that shows the amount of debt the debtor owed to a creditor on the date of the bankruptcy filing. The form must be filed in the district where the case is pending.

**Redaction of information:** Masking, editing out, or deleting certain information to protect privacy. Filers must redact or leave out information entitled to **privacy** on the *Proof of Claim* form and any attached documents.

**Secured claim under 11 U.S.C. §506(a):** A claim backed by a lien on particular property of the debtor. A claim is secured to the extent that a creditor has the right to be paid from the property before other creditors are paid. The amount of a secured claim usually cannot be more than the value of the particular property on which the creditor has a lien. Any amount owed to a creditor that is more than the value of the property normally may be an unsecured claim. But exceptions exist; for example, see 11 U.S.C. § 1322(b) and the final sentence of 1325(a).

Examples of liens on property include a mortgage on real estate or a security interest in a car. A lien may be voluntarily granted by a debtor or may be obtained through a court proceeding. In some states, a court judgment may be a lien.

**Setoff:** Occurs when a creditor pays itself with money belonging to the debtor that it is holding, or by canceling a debt it owes to the debtor.

**Uniform claim identifier:** An optional 24-character identifier that some creditors use to facilitate electronic payment.

**Unsecured claim:** A claim that does not meet the requirements of a secured claim. A claim may be unsecured in part to the extent that the amount of the claim is more than the value of the property on which a creditor has a lien.

#### **Offers to purchase a claim**

Certain entities purchase claims for an amount that is less than the face value of the claims. These entities may contact creditors offering to purchase their claims. Some written communications from these entities may easily be confused with official court documentation or communications from the debtor. These entities do not represent the bankruptcy court, the bankruptcy trustee, or the debtor. A creditor has no obligation to sell its claim. However, if a creditor decides to sell its claim, any transfer of that claim is subject to Bankruptcy Rule 3001(e), any provisions of the Bankruptcy Code (11 U.S.C. § 101 et seq.) that apply, and any orders of the bankruptcy court that apply.
