STIPULATION REGARDING MARKETING AND SALE OF CERTAIN EQUIPMENT AS REQUIRED BY THE SENIOR SECURED SUPERPRIORITY DEBTOR-IN-POSSESSION CREDIT AGREEMENT

Debtors Nitro Fluids, LLC ("<u>Fluids</u>"), NFH Leasing, LLC, and Straitline Pumps, LLC ("<u>Straitline</u>," and collectively with Fluids and NFH Leasing, LLC, the "<u>Debtors</u>"), as debtors and debtors-in-possession in the above-captioned bankruptcy cases (collectively, the "<u>Bankruptcy</u> <u>Case</u>"), together with the Official Committee of Unsecured Creditors (the "<u>Committee</u>"), Crescent Pass Energy, LLC ("<u>Crescent</u>") and Simmons Bank ("<u>Lender</u>," and collectively with the Debtors, Crescent and the Committee, the "<u>Parties</u>"), have agreed to this stipulation (this "<u>Stipulation</u>"). In support of the Stipulation, the Parties represent as follows:

RECITALS

WHEREAS, the Court entered the Final Order (a) Authorizing the Debtors to Obtain

Postpetition Financing; (b) Authorizing the Debtors to Use Cash Collateral, (c) Granting Liens

and Providing Claims with Superpriority Administrative Expense Status, (d) Granting Adequate Protection, and (e) Modifying the Automatic Stay [Docket No. 146] (the "Final DIP Order");

WHEREAS, the Court entered the *Stipulation and Agreed Order Authorizing Modification* to Senior Secured Superpriority Debtor-In-Possession Credit Agreement [Docket No. 268] (the "<u>DIP Loan Modification</u>" and together with the Final DIP Order, the "<u>DIP Orders</u>");

WHEREAS, the DIP Orders contain certain milestones for the sale of assets of the Debtors (the "<u>Milestones</u>");

WHEREAS, Straitline desires to perform additional work for Crescent under that certain Master Service Agreement dated September 27, 2022, as modified and amended (the "<u>Crescent MSA</u>"), attached hereto as <u>Exhibit A</u>; and

WHEREAS, Crescent has requested assurance from: (i) the Debtors that they will not sell certain equipment; and (ii) Simmons that it will not require the sale of the same equipment to be used by the Debtors to perform the additional work (the "Equipment"), as set forth in Exhibit B attached hereto, as long as Crescent and Straitline are performing under the Crescent MSA;

NOW, THEREFORE, the Parties enter into this Stipulation with respect to the Milestones.

STIPULATION

1. Pursuant to this Stipulation, the Debtor agree that they will not sell the Equipment and Simmons agrees that it will not require Debtors to sell the Equipment as long as Crescent and Straitline are performing under the Crescent MSA.

2. All Milestones associated with the Equipment shall be extended and shall not be considered a default under the DIP Orders so long as Crescent and Straitline continue to perform under the Crescent MSA and there is not otherwise a breach or termination of the Crescent MSA.

3. In the event Crescent or Straitline cease to perform under the Crescent MSA, or

there is a breach or termination of the Crescent MSA, the Equipment may be immediately marketed

for sale.
