ORDER STRIKING PORTION OF DEFENDANT KIRAN SHARMA’S FILING FOR VIOLATION OF ORDER CONCERNING FURTHER FILING OF MOTION

Plaintiff in this action is Howard M. Ehrenberg, in his capacity as Liquidating Trustee of Orion Healthcorp Inc., Constellation Healthcare Technologies, Inc. and certain of their affiliated debtors and debtors-in-possession in the above-captioned chapter 11 cases (“Plaintiff”).

On August 9, 2021, defendant Kiran Sharma (“Sharma”) appeared *pro se* in this adversary proceeding by filing a motion to dismiss the adversary proceeding [dkt. 343].

Since that initial filing, Sharma has submitted numerous *pro se* filings and hundreds of pages to the Court for consideration [dkt. items 343, 344, 345, 349, 467, 471, 473, 474, 520, 521, 524, 586, 587, 591, 595, 597, 599, 607, 612].

Sharma has two applications pending before this Court: (1) a demand for a jury trial of this adversary proceeding; and (2) a Motion for an Order to Show Cause Why Sanctions, Including Dismissal With Prejudice Should Not be Imposed Due to Plaintiff’s Willful and Bad Faith Failure

to Comply with Discovery Obligations, and Request for Attorney's Fees and Costs ("Sharma Discovery Motion").

On August 30, 2024, Sharma filed a letter pursuant to Rule 38 of the Federal Rules of Civil Procedure ("Federal Rules"), as incorporated by Rule 9015 of the Federal Rules of Bankruptcy Procedure ("Bankruptcy Rules"), to request a jury trial on all counts and allegations brought against her (the "Jury Demand") [dkt. item 591].

On September 19, 2024, the Court issued an Order setting a briefing scheduling on the Jury Demand (the "Jury Demand Scheduling Order") [dkt. item 593].

Pursuant to the Jury Demand Scheduling Order, the issue of Jury Demand shall be under submission with the Court as of December 19, 2024.

On October 1, 2024, Sharma filed the Sharma Discovery Motion [dkt. item 596].
On October 22, 2024, the Court entered a Scheduling Order Regarding Discovery Disputes in connection with the Sharma Discovery Motion (the "Discovery Dispute Scheduling Order") [dkt. item 604].

Pursuant to the Discovery Dispute Scheduling Order, the Sharma Discovery Motion and all responses and replies thereto shall be under submission as of December 3, 2024.

On November 4, 2024, the Court entered an Order Concerning Filing of Motions [dkt. item 610] which ordered that for ninety (90) days Sharma be barred from any more filings unless the filings were submitted in response to a Court order on the above-referenced pending matters, or in response to any later motion filed on behalf of any other party (the "Filing Bar Order"). The Filing Bar Order is in effect until February 3, 2025 and is intended to allow the Court to address the already pending matters without the Court or the parties expending additional resources before the above matters are decided.

Since the Filing Bar Order was entered, no party has submitted a new motion nor has the Court entered an order requiring Sharma's response. Notwithstanding, on November 19, 2024, Sharma filed a Response to Plaintiffs' Objection to Demand for Jury Trial, Motion for Withdrawal of the Reference, and in the alternative, Request for Leave to File Motion for Summary Judgment ("New Sharma Filing") [dkt. item 612].

The portion of the New Sharma Filing which responds to Plaintiffs' objection to the Jury Demand is compliant with the briefing schedule this Court set in the Jury Demand Scheduling Order. However, the portion of the New Sharma Filing seeking a request for withdrawal of the reference or leave to file motion for summary judgment is filed directly in violation of the Filing Bar Order.

It is axiomatic that "the bankruptcy court has the inherent power to 'tak[e] any action or mak[e] any determination necessary or appropriate to enforce or implement court orders or rules'" in carrying out the provisions of the Bankruptcy Code and Bankruptcy Rules. *Modica v. Ozone Park Funding Assocs.*, 442 B.R. 189, 192-93 (E.D.N.Y. 2010) (quoting 11 U.S.C. § 105(a)); *see In re Kalikow*, 602 F.3d 82, 96-97 (2d Cir. 2010).

Bankruptcy Rule 9011 allows the imposition of "appropriate sanctions upon the attorneys, law firms, or parties that have violated [Bankruptcy Rule 9011(b)] or are responsible for the violation. FED. R. BANKR. P. 9011(c).

Upon consideration of the foregoing, and sufficient cause appearing therefor, it is hereby


ORDERED, the Motion for Withdrawal of the Reference, and in the alternative, Request for Leave to File Motion for Summary Judgment portion of the New Sharma Filing is stricken as a violation of this Court's Filing Bar Order and the Court will not consider such portion of the New Sharma Filing; and it is further

ORDERED, that should Sharma fail to comply with this Order, the Court may issue an order to show cause as to why Sharma should not be held in contempt, as well as issue further sanctions against Sharma for continued failure to comply; and it is further

ORDERED, that the Clerk of Court shall serve a copy of this Order on Sharma and all parties to the adversary proceeding within three (3) business days of entry of this Order.
