Upon consideration of the Motion for Relief from Automatic Stay Pursuant to 11 U.S.C. § 362(d) filed on behalf of Sabrina Kurani, Individually and as Executrix of the Estate of Harish Kurani, and any objections thereto, and cause having been found under Section 362(d) of the Bankruptcy Code to grant the relief in the Motion, and the Debtor having consented to the form and entry of the within Order it is hereby ORDERED that:

1. The Motion is GRANTED as set forth herein.
2. The automatic stay is hereby lifted to permit Movant to continue the State Court Action against Debtor Atlantic Neurosurgical Specialists, pending in the Superior Court of New Jersey, Morris County, Docket No. MRS-L-793-23 to final judgment against the Debtor and any other individuals and non-debtor entities, including any subsequent appeals, and to permit Movant to enforce any judgment, including any alternative dispute resolution award, mediation, or settlement obtained in the State Court Action, against only any applicable insurance policies or non-debtor parties; provided that Movant shall enforce such claims only against third-party non-debtors, including but not limited to any applicable insurance carriers and third parties and their insurance carriers. Without limiting the foregoing, any insurance carrier is authorized to pay any judgment, award or settlement applicable to claims against the Debtors on account of the State Court Action.
3. The Automatic Stay is further modified to permit the State Court to enter final judgment against the Debtor and any other individuals or non-debtor entities.

4. The Movant shall not pursue collection activities against the Debtor or the Debtor's estate. Collection actions and recoveries if any shall be limited to the proceeds of applicable insurance policies in effect at the time of the incident subject of the Complaint.

5. This Order shall become immediately effective upon entry by the Court and is not subject to the fourteen-day stay provided in Federal Rule of Bankruptcy Procedure 4001(a)(3).

6. The Court shall retain jurisdiction over any and all issues arising from or related to the implementation and interpretation of this Order.
