**LETTER IN SUPPORT OF PLAN  
FROM THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS  
OF FAIRPORT BAPTIST HOMES**

**TO:** All Holders of General Unsecured Claims against Fairport Baptist Homes, and its affiliates (collectively, the “Debtors”)<sup>1</sup>

**FROM:** The Official Committee Of Unsecured Creditors of Fairport Baptist Homes (the “Committee”)

---

On December 11, 2024, the Bankruptcy Court for the Western District of New York (the “Court”) approved the *Amended Joint Disclosure Statement in Support of the Joint Plan of Liquidation*. The *Amended Joint Disclosure Statement* (the “Disclosure Statement”) and the *Amended Joint Plan of Liquidation* (the “Plan”) are filed with the Court at Docket No. 944.

The Disclosure Statement explains the distributions that will be made to creditors of the Debtors under the Plan. You are receiving this letter because you are a Holder<sup>2</sup> of a General Unsecured Claim against one or more of the Debtors and entitled to vote on the Plan.

On October 3, 2022 the Debtors conducted an auction for the sale of substantially all of their assets. The Court later approved the Sale, and on May 17, 2024, the Sale closed. The Plan proposes to distribute the proceeds of the Sale, along with certain other assets, to Holders of Allowed Claims in satisfaction of such claims. The Plan is based upon extensive negotiations between the Debtors, the Committee and various other parties in interest in these Chapter 11 Cases including the Debtors’ parent company Fairport Baptist Homes Caring Ministries (“FBHCM”). Those negotiations allowed the Committee to either recover additional assets or reduce claim amounts in order to maximize recoveries to Holders of Allowed Claims. FBHCM has agreed to contribute the Contributed Assets to the Liquidating Trust for the benefit of creditors in exchange for the opportunity to receive a non-debtor release through the Plan. FBHCM’s contribution of the Contributed Assets will result in a meaningful additional recovery for Holders of General Unsecured Claims that are Allowed Claims.

Accordingly, given the above, the Committee supports confirmation and consummation of the Plan and recommends that each Holder of a General Unsecured Claim receiving this letter (i) vote to **accept** the Plan in Item 2 on the Ballot, (ii) **opt into** the release in Item 3 on the Ballot, and (iii) return a completed and signed Ballot in accordance with the voting instructions described in the Disclosure Statement and on the Ballot.

**Your Ballot must be received by no later than February 14, 2025, at 5:00 p.m. (Eastern Time) in order to be counted.**
