EX PARTE MOTION TO AMEND FINAL JUDGMENT NUNC PRO TUNC

Plaintiff, 1 Global Capital, LLC, by and through undersigned counsel, hereby seeks to amend the Final Judgment pursuant to Fed.R.Civ.P. 60(a), made applicable by Fed.R.Bank.P. 9042 and in support thereof, states as follows:

1. This Court entered Final Judgment on May 22, 2020 [D.E. 21 and D.E. 22].
2. Subsequently, Plaintiff discovered that the Judgment Debtor's name was incorrectly spelled on the Final Judgment as a result of an accidental scrivener's error.
3. Specifically, the Judgment Debtor's name was incorrectly typed "Nicole Boyd", but the correct spelling is "Nicolle Boyd."
4. Fed.R.Civ.P. 60(a) in pertinent part provides:

The court may correct a clerical mistake or a mistake arising from oversight or omission whenever one is found in a judgment, order, or

other part of the record. The court may do so on motion or on its own, with or without notice.

5. An Amended Final Judgment to correct the clerical mistake would not change the substance of the record, and is proper under the circumstances.

WHEREFORE, Plaintiff respectfully requests that the Court enter an Amended Final Judgment, *nunc pro tunc*, thereby correcting the Judgment Debtor's name to read as "Nicolle Boyd", and for such other relief as this Court deems proper.
