## SECOND SUPPLEMENT TO MOTION TO APPROVE COMPROMISE AND SETTLEMENT, INCLUDING FREE AND CLEAR ASSIGNMENT OF THE ASSIGNED CLAIMS

James Studensky, in his capacity as Chapter 7 Trustee of Little River Healthcare Holdings, LLC ("Trustee"), files this Second Supplement ("Second Supplement") to his *Motion to Approve Compromise and Settlement Including Free and Clear Assignment of the Assigned Claims* ("9019 Motion") [Docket No. 1506].

- 1. On January 17, 2025, the Trustee filed his 9019 Motion, seeking to approve a settlement agreement with Blue Cross (the "Settlement").
- 2. On January 21, 2025, UnitedHealthcare Insurance Company and UnitedHealthcare of Texas, Inc. ("<u>United</u>") filed its *Preliminary Objection to Motion to Approve Compromise and Settlement* ("<u>Objection</u>") [Docket No. 1511] and a subsequent Supplemental *Objection to the Trustee's Motion to Approve Compromise and Settlement and Request for an Accounting* ("Supplemental Objection") [Docket No. 1517].
