**ORDER PARTIALLY GRANTING AND PARTIALLY DENYING BADCOCK
DEALERS' EMERGENCY MOTION TO COMPEL DEBTORS TO PAY
POSTPETITION DEALER COMPENSATION**

Upon the motion (the "Motion")² of the Ad Hoc Group of Badcock Dealers to compel the debtors and debtors-in-possession in the above-captioned chapter 11 cases (the "Debtors") to pay the Dealer Compensation, including the Bonus, all as more fully set forth in the Motion; and this Court having jurisdiction over this matter pursuant to 28 U.S.C. § 1334; and this Court having found that it may enter a final order consistent with Article III of the United States Constitution; and this Court having found that venue of this proceeding and the Motion in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that notice of the Motion and opportunity for a hearing on the Motion were appropriate and no other notice need be provided; and this Court having reviewed the Motion, the objections thereto, and the testimony and evidence presented at the hearing on the Motion on December 9, 2024 (the "Hearing"); and the Court having issued an oral ruling at the Hearing partially granting and partially denying the relief requested in

the Motion; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

1. The Motion is PARTIALLY GRANTED and PARTIALLY DENIED.
2. The Debtors' dealers (the "Dealers") are awarded an administrative expense claim for the Bonus owed in the amounts and to the dealers set forth on Exhibit 1 hereto (the "Administrative Expense Claims"). Notwithstanding the foregoing, this Order shall not preclude any of the Dealers, on an individual basis, from filing a motion for allowance of administrative expenses in the Debtors' chapter 11 cases.
3. To the extent payment of the Administrative Expense Claims is not authorized by the DIP Order or further order of this Court, the Debtors shall file a motion to surcharge the collateral of their Prepetition 2L Secured Parties (as defined in the DIP Order) under section 506(c) of the Bankruptcy Code and prosecute such motion before the Court.
4. Nothing herein shall prejudice the parties with respect to any and all rights to setoff under any of the prepetition Dealer Agreements, and all rights with respect to such setoff are hereby expressly reserved.
5. Nothing contained in the Motion, Order, or any actions taken by the parties pursuant to the relief granted in the Order shall be construed as: (i) an admission as to the validity of any claim against the Debtors, or (ii) a waiver or limitation of the parties' rights under the Bankruptcy Code and other applicable law.
6. Notice of the Motion as provided therein shall be deemed good and sufficient notice of such Motion under the circumstances and the requirements of Bankruptcy Rule 6004(a) and the Bankruptcy Local Rules are satisfied by such notice.

7. Notwithstanding Bankruptcy Rule 6004(h), the terms and conditions of this Order are immediately effective and enforceable upon its entry.

8. The Debtors are authorized to take all actions necessary to effectuate the relief granted in this Order in accordance with the Motion.

9. The Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation of this Order.
