NOTICE OF PRIMARY AUCTION RESULTS

PLEASE TAKE NOTICE OF THE FOLLOWING:

1. On July 24, 2024, the above-captioned debtor and its debtor affiliates as debtors and debtors in possession (collectively, the "Debtors") in the above-captioned chapter 11 cases, filed with the United States Bankruptcy Court for the District of Delaware (the "Court") the *Motion of the Debtors and Debtors in Possession for Entry of Orders (I)(A) Approving Bidding Procedures for the Sale of Substantially All of the Debtors' Assets, (B) Authorizing the Debtors to Enter into One or More Stalking Horse Agreements and to Provide Bidding Protections Thereunder, (C) Scheduling an Auction and Approving the Form and Manner of Notice Thereof, (D) Approving Assumption and Assignment Procedures, (E) Scheduling a Sale Hearing and Approving the Form and Manner of Notice Thereof and (F) Granting Related Relief; and (II)(A) Approving the Sale of the Debtors' Assets Free and Clear of Liens, Claims, Interests and Encumbrances, (B) Approving the Assumption and Assignment of Executory*

2. On August 13, 2024, the Debtors filed with the Court the *Supplement to Motion of the Debtors and Debtors in Possession for Entry of Orders (I)(A) Approving Bidding Procedures for the Sale of Substantially All of the Debtors' Assets, (B) Authorizing the Debtors to Enter into One or More Stalking Horse Agreements and to Provide Bidding Protections Thereunder, (C) Scheduling an Auction and Approving the Form and Manner of Notice Thereof, (D) Approving Assumption and Assignment Procedures, (E) Scheduling a Sale Hearing and Approving the Form and Manner of Notice Thereof and (F) Granting Related Relief; and (II)(A) Approving the Sale of the Debtors' Assets Free and Clear of Liens, Claims, Interests and Encumbrances, (B) Approving the Assumption and Assignment of Executory Contracts and Unexpired Leases and (C) Granting Related Relief* [Docket No. 126] (the "Supplement").

3. On August 21, 2024, the Court entered the *Order (I) Approving Bidding Procedures for the Sale of Substantially All of the Debtors' Assets, (II) Authorizing the Debtors to Enter into One or More Stalking Horse Agreements and to Provide Bidding Protections Thereunder, (III) Scheduling an Auction and Approving the Form and Manner of Notice Thereof, (IV) Approving Assumption and Assignment Procedures, (V) Scheduling a Sale Hearing and Approving the Form and Manner of Notice Thereof and (VI) Granting Related Relief* [Docket No. 181] (the "Bidding Procedures Order"), which, among other items, approved the bidding procedures attached thereto as Exhibit 1 (the "Bidding Procedures").

4. On August 23, 2024, the Debtors filed with the Court the *Motion of the Debtors and Debtors in Possession for Entry of an Order (I) Authorizing the Debtors to Enter into the Additional Stalking Horse Agreements and Provide Bidding Protections in Accordance with the Bidding Procedures and the Additional Stalking Horse Agreements and (II) Granting Related Relief* [Docket No. 191] (the "Second Stalking Horse Motion"). On August 29, 2024, the Court entered an order approving the Second Stalking Horse Motion [Docket No. 210] (the "Second Stalking Horse Order").

5. On August 28, 2024, the Debtors filed with the Court the *Third Motion of the Debtors and Debtors in Possession for Entry of an Order (I) Authorizing the Debtors to Enter into Stalking Horse Agreements and Provide Bidding Protections Thereunder in Accordance with the Bidding Procedures and (II) Granting Related Relief* [Docket No. 206] (the "Third Stalking Horse Motion"). On September 3, 2024, the Court entered an order approving the Third Stalking Horse Motion [Docket No. 265] (the "Third Stalking Horse Order").

6. Copies of relevant documents, including the Motion, the Supplement, the Second Stalking Horse Motion, the Third Stalking Horse Motion, the Bidding Procedures Order, the Second Stalking Horse Order and the Third Stalking Horse Order are available on the website of the Debtors' claims and noticing agent, Epiq Corporate Restructuring, LLC, at the following address: <https://dm.epiq11.com/VintageWine>.

7. In accordance with the Motion, the Supplement, the Second Stalking Horse Motion, the Third Stalking Horse Motion, the Bidding Procedures Order, the Second Stalking Horse Order and the Third Stalking Horse Order, on September 17, 2024, the Debtors held the Primary Auction for the Primary Assets. At the conclusion of the Primary Auction,

the Debtors, in consultation with the Consultation Parties, selected (a) the bidders listed below in Table 1 as the successful bidders (collectively, the "Successful Bidders" and the bids submitted by such Successful Bidders, the "Successful Bids") for the Primary Assets; and (b) the bidders listed below in Table 2 as the backup bidders (collectively, the "Backup Bidders" and the bids submitted by such Backup Bidders, the "Backup Bids") for the Primary Assets. Attached hereto as Exhibits A-1 through A-2 are copies of the asset purchase agreements executed in connection with the Successful Bids for the Primary Assets (the "Successful Bid APAs"). Attached hereto as Exhibit B-1 through B-2 are copies of the form of asset purchase agreements to be executed in connection with the Backup Bids for the Primary Assets (the "Backup Bid APAs").

Attached hereto as Exhibits C-1 through C-6 are copies of the asset purchase agreements executed in connection with the Non Auction Bids (collectively, the "Non Auction APAs" and together with the Successful APAs, the "Primary APAs"). The Debtors, in consultation with the Consultation Parties, determined that an Auction for the Non Auction Assets was not necessary, and, thus, cancelled the Auction for such Non Auction Assets.

9. The Primary Sale Hearing to consider approval of the Primary APAs will be held on **September 24, 2024, at 10:30 a.m.** (prevailing Eastern Time) before the Honorable Mary F. Walrath, United States Bankruptcy Judge, in the United States Bankruptcy Court for the District of Delaware, located at 824 North Market Street, Wilmington, Delaware 19801.

10. Any Objections to the conduct of the Primary Auction and/or the particular terms of the Successful Bid APAs must be (a) in writing and state, with specificity, the legal and factual bases thereof and include any appropriate documentation in support thereof; (b) be filed with the Court; and (c) served on the Objection Notice Parties by no later than **September 20, 2024 at 4:00 p.m.** (prevailing Eastern Time).

11. Attached hereto as Exhibit D is the schedule of contracts that could potentially be assumed by the Successful Bidders (the "Schedule of Contracts"). The Debtors provided notice of all Contracts that could potentially be assumed and assigned in connection with the sale process to all Counterparties (as defined in the Bidding Procedures) [Docket Nos. 188 & 279] (collectively, the "Assumption and Assignment Notices"). Pursuant to the Assumption and Assignment Notices, the Cure Objection Deadline was September 3, 2024, and the Supplemental Cure Objection Deadline is **September 20, 2024, at 4:00 p.m.** (prevailing Eastern Time). The Schedule of Contracts lists each Contract related to an Asset that was sold during the Primary Auction that could potentially be assumed by and assigned to the applicable Successful Bidder.

12. Any Counterparty to a Contract listed on the Schedule of Contracts that wishes to object to the potential assumption and assignment of the Contract, the subject of which objection is such Successful Bidder's (or any other relevant assignee's) proposed form of adequate assurance of future performance with respect to the Contract (each, such objection, a
