**FOURTH NOTICE OF ADJOURNMENT OF HEARING TO CONSIDER
CONFIRMATION OF THE DEBTORS’ SECOND AMENDED JOINT
CHAPTER 11 PLAN AND RELATED VOTING AND OBJECTION DEADLINES**

PLEASE TAKE NOTICE that, on November 22, 2024, the United States Bankruptcy Court for the District of Delaware (the “Bankruptcy Court”) entered an order [Docket No. 5024] (the “Disclosure Statement Order”) (a) authorizing Yellow Corporation and its affiliated debtors and debtors in possession (collectively, the “Debtors”) to solicit votes on the *Second Amended Joint Chapter 11 Plan of Yellow Corporation and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 5028] (as may be altered, amended, modified, or supplemented from time to time, the “Plan”);² (b) approving the *Second Amended Disclosure Statement for the Second Amended Joint Chapter 11 Plan of Yellow Corporation and Its Debtor Affiliates Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 5027] (as may be amended, supplemented, or modified from time to time, the “Disclosure Statement”) as containing “adequate information” pursuant to section 1125 of the Bankruptcy Code; (c) approving the solicitation materials and documents to be included in the solicitation packages (the “Solicitation Packages”); and (d) approving procedures for soliciting, receiving, and tabulating votes on the Plan.

PLEASE TAKE FURTHER NOTICE that, on February 28, 2025, the Debtors, in consultation with the Committee, filed and served the *Third Notice of Adjournment of Hearing to Consider Confirmation of the Debtors’ Second Amended Joint Chapter 11 Plan and Related Voting and Objection Deadlines* [Docket No. 5822] (the “Third Adjourned Confirmation Hearing Notice”)³ providing notice that the Voting, Opt-In, and Plan Objection Deadlines had been amended to March 10, 2025 and the Voting Report Deadline to March 12, 2025.

PLEASE TAKE FURTHER NOTICE that the Debtors, in consultation with the Committee, have further adjourned the Confirmation Hearing and certain other dates and deadlines related to confirmation and solicitation to a date to be determined.

PLEASE TAKE FURTHER NOTICE that the dates and deadlines related to confirmation and solicitation set forth below shall supersede the dates and deadlines set forth in the Third Adjourned Confirmation Hearing Notice and be incorporated by reference into the Disclosure Statement Order and Solicitation Packages as if fully set forth therein.

Event	Date	Description
Voting Deadline, Opt-In Deadline	To be determined	The deadline by which all Ballots and Opt-In Forms must be properly executed, completed, and submitted so that they are <i>actually received</i> by Epiq Corporate Restructuring, LLC.
Plan Objection Deadline	To be determined	The deadline by which parties in interest may file objections to confirmation of the Plan.
Deadline to File Voting Report	To be determined	The date by which the report tabulating the voting on the Plan shall be filed with the Bankruptcy Court.
Confirmation Brief and Reply Deadline	To be determined	The deadline by which the Debtors shall file their brief in support of confirmation of the Plan and reply to objections to confirmation of the Plan.
Confirmation Hearing Date	To be determined	The date of the Confirmation Hearing.

PLEASE TAKE FURTHER NOTICE that the Debtors will file an updated notice with the Bankruptcy Court setting forth the dates and deadlines relating to confirmation and solicitation once such dates have been determined; *provided* that the Debtors will file such notice at least 30 days in advance of any deadline.

PLEASE TAKE FURTHER NOTICE that copies of the Plan, the Disclosure Statement, the Disclosure Statement Order, and all other documents filed in these Chapter 11 Cases are available free of charge by visiting the Debtors' restructuring website at <https://dm.epiq11.com/YellowCorporation>.
