In accordance with the *Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Retained Professionals* [Docket No. 521] (the “Interim Compensation Order”), Skadden, Arps, Slate, Meagher & Flom LLP (“Skadden”), Special Litigation Counsel to Red River Talc LLC as debtor (the “Debtor”), submits its *Third Monthly Statement of Fees and Expenses Incurred by Skadden, Arps, Slate, Meagher & Flom LLP as Special Litigation Counsel for the Debtor for the Period from January 1, 2025 through February 28, 2025* (the “Third Monthly Fee Statement”).

Itemization of Services Rendered and Expenses Incurred

Skadden requests compensation for professional services rendered in the amount of \$469,387.70 (the “Fees”), and for reimbursement of out-of-pocket expenses incurred in the amount of \$18,103.46 (the “Expenses”), during the Application Period. Eighty percent (80%) of the Fees equals \$375,510.16 and one hundred percent (100%) of the Expenses equals \$18,103.46 for a total requested amount of \$393,613.62.³

For the period covering January 1, 2025 through January 31, 2025 (the “January Period”), summaries of the calculations for the Fees by project category and Expenses are attached hereto as Exhibit A and Exhibit B, respectively. A summary of the time expended by Skadden’s professionals and paraprofessionals, together with their respective hourly rates, for the January Period is attached hereto as Exhibit C.

For the period covering February 1, 2025 through February 28, 2025 (the “February Period”), a summary of the calculations for the Fees by project category is attached

³ Consistent with its own internal policies and to comply with the “reasonableness” requirements of section 330 of the Bankruptcy Code, Skadden has reviewed its monthly service descriptions and expense detail and has determined that certain Fees and Expenses should not be charged to the Debtor. In particular, Skadden has voluntarily determined that \$32,865.10 in Fees and \$7,001.40 in Expenses will not be charged to the Debtor. This Monthly Fee Statement reflects these adjustments.

hereto as Exhibit D. Skadden is not seeking reimbursement of any Expenses for the February Period. A summary of the time expended by Skadden's professionals and paraprofessionals, together with their respective hourly rates, for the February Period is attached hereto as Exhibit E.

Skadden's invoices for the Application Period are attached hereto as Exhibit F (for the January Period) and Exhibit G (for the February Period).

Status of Retainer and LLT Payment

Prior to the formation of the Debtor and the Petition Date, on August 19, 2024, LLT Management LLC ("LLT") paid Skadden \$10,754,621.52 for actual and estimated fees and expenses relating to pre-petition talc-related litigation services provided by Skadden through August 31, 2024 (the "LLT Payment"). In addition, prior to the Petition Date, on August 20, 2024, the Debtor paid Skadden a retainer of \$500,000 for professional services and expenses to be provided to the Debtor (the "Red River Retainer").

As of the date of the Retention Application, the combined balance of the LLT Payment and the Red River Retainer was \$2,788,527.64. At the time of Skadden's second monthly fee statement [Docket No. 1063], the combined balance of the LLT Payment and the Red River Retainer was \$1,513,065.10. Upon further reconciliation of Skadden's prepetition fees, including factoring in actual August fees, the balance was reduced by \$653,294.40, resulting in a combined balance of \$859,770.70. Applying Skadden's total requested amount of \$393,613.62 for this Application Period results in a Retainer balance of \$466,157.08 for future statements.
