**DEBTORS’ SECOND NOTICE OF CLAIMS SATISFIED IN FULL**

The above-captioned debtors and debtors in possession (collectively, the “Debtors”)<sup>2</sup> hereby respectfully submit this notice (the “Notice”) identifying certain claims, as defined by section 101(5) of chapter 11 of title 11 of the United States Code (the “Bankruptcy Code”), which have been satisfied in full by the Debtors (each a “Satisfied Claim,” and such claimants, the “Satisfied Claimants”). In support of this Notice, the Debtors respectfully state as follows:

**Background**

1. On August 6, 2023 (the “Petition Date”), each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code. These chapter 11 cases have been consolidated for procedural purposes only and are being jointly administered pursuant to Bankruptcy Rule 1015(b) [Docket No. 169]. The Debtors are managing their businesses and their

properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. On August 16, 2023, the United States Trustee for the District of Delaware (the “U.S. Trustee”) appointed an official committee of unsecured creditors [Docket No. 269] (the “Committee”). No trustee or examiner has been appointed in these chapter 11 cases.

2. On August 9, 2023, the Court entered an order [Docket No. 170] authorizing the retention of Epiq Corporate Restructuring, LLC as claims and noticing agent (the “Claims Agent”). As such, Epiq Corporate Restructuring, LLC is to, among other things, receive, maintain, docket, and otherwise administer Proofs of Claim filed in the Debtors’ chapter 11 cases (the “Claims Register”).

3. On September 13, 2023, the Court entered the *Order (I) Setting Bar Dates for Filing Proofs of Claim, Including Requests for Payment Under Section 503(b)(9), (II) Establishing Amended Schedules Bar Date and Rejection Damages Bar Date, (III) Approving the Form of and Manner For Filing Proofs of Claim, Including Section 503(B)(9) Requests, and (IV) Approving Form and Manner of Notice Thereof* [Docket No. 521] (the “Bar Date Order”) establishing certain dates and deadlines for filing proofs of claim (collectively, the “Proofs of Claim”) in these chapter 11 cases. Among other things, the bar date established: (a) November 13, 2023 (the “Claims Bar Date”), as the final date and time for all persons and entities holding claims against the Debtors (except in the cases of governmental units and certain other exceptions explicitly set forth in the Bar Date Order) that arose or are deemed to have arisen prior to the Petition Date, to file Proofs of Claim in these chapter 11 cases (except for claims specifically exempt from complying with the applicable bar dates as set forth in the Bar Date Order) for: (i) requests for payment under section 503(b)(9) of the Bankruptcy Code; (ii) secured claims; (iii) unsecured priority claims; (iv) unsecured non-priority claims; (v) contingent claims;

(vi) unliquidated claims; (vii) disputed claims; and (viii) rejection damage claims for executory contracts and unexpired leases that have already been rejected by order of the Court in these chapter 11 cases;<sup>3</sup> and (b) February 5, 2024 (the “Governmental Bar Date”) as the final date and time for all governmental units (as defined in section 101(27) of the Bankruptcy Code) holding claims (whether secured, unsecured priority, or unsecured non-priority) against the Debtors that arose or are deemed to have arisen prior to the Petition Date, to file Proofs of Claim in these chapter 11 cases.<sup>4</sup>

4. Notice of the Claims Bar Date was provided by mail and publication in accordance with the procedures outlined in the Bar Date Order.

5. On September 11, 2023, the Debtors filed their schedules of assets and liabilities (the “Schedules”) and statements of financial affairs (the “Statements” and, together with the Schedules, collectively, as amended, modified, or supplemented, the “Schedules and Statements”) [Docket Nos. 445–481]. On September 12, 2023, the Debtors filed corrected versions of certain of the Schedules and Statements [Docket Nos. 501, 502].

6. In the ordinary course of business, the Debtors maintain books and records (the “Books and Records”) that reflect, among other things, the nature and amount of the liabilities

owed to their creditors as of the Petition Date. As part of these chapter 11 cases, the Debtors filed their Schedules and Statements reflecting the obligations owed to their creditors as of the Petition Date. To date, approximately 16,030 Proofs of Claim have been filed. The Debtors, together with their advisors, have been engaging in a systematic review of the Proofs of Claim, working diligently to review, compare, and reconcile the Proofs of Claim against the Debtors' Books and Records.

### **The Satisfied Claims**

7. In connection with the review of their books and records, the Proofs of Claim filed in these chapter 11 cases, and the Claims on the Debtors' Schedules, the Debtors, with the assistance of their advisors, have determined that the 172 Satisfied Claims, as set forth on **Exhibit A** hereto, have been satisfied and that no further distributions are required on account of such Satisfied Claims. The Satisfied Claims consist of claims for obligations that were asserted and due and owing as of the Petition Date, but have been fully satisfied after the Petition Date. Specifically, the Debtors submit that all amounts due and owing as of the Petition Date to each of the Satisfied Claimants have been paid or satisfied pursuant to the Debtors' *Final Order (I) Authorizing the Debtors to (A) Pay Prepetition Wages, Salaries, Other Compensation, and Reimbursable Expenses and (B) Continue Employee Benefits Programs, and (II) Granting Related Relief* [Docket No. 532].

8. Accordingly, as no amounts are owed by the Debtors on account of the Satisfied Claims and to ensure the accuracy of the Claims Register, absent compliance with the procedures listed below, each Satisfied Claimant will be deemed to have consented to this Notice and the Debtors' determination with respect to their Satisfied Claim. The Claims Agent will then be

immediately authorized to update the Claims Register with respect to each of the Satisfied Claims in conformity with this Notice without further notice or order of the Court.

**Responses to the Notice**

9. By this Notice, the Debtors request that any Satisfied Claimant who disputes the Debtors' determination that their Claim has been satisfied in full must file a written response (the "Response") with the Office of the Clerk of the United States Bankruptcy Court for the District of Delaware (the "Clerk"), 824 North Market Street, Wilmington, Delaware 19801 and serve its Response upon the following parties, so as to be **actually received** no later than **April 4, 2025, at 4:00 p.m. (prevailing Eastern Time)** (the "Response Deadline"): counsel to the Debtors, (i) Kirkland & Ellis LLP, 333 West Wolf Point Plaza Chicago, Illinois 60654 (Attn: Patrick J. Nash Jr., P.C. (patrick.nash@kirkland.com) and David Seligman, P.C. (david.seligman@kirkland.com)); (ii) Kirkland & Ellis LLP, 601 Lexington Avenue New York, New York 10022 (Attn: Allyson B. Smith (allyson.smith@kirkland.com)); and (iii) Pachulski Stang Ziehl & Jones LLP, 919 North Market Street, 17th Floor P.O. Box 8705 (Attn: Laura Davis Jones (ljones@pszjlaw.com), Timothy P. Cairns (tcairns@pszjlaw.com), Peter J. Keane (pkeane@pszjlaw.com), and Edward Corma (ecorma@pszjlaw.com)).

10. Every Response must contain, at a minimum, the following information:
- a. a caption setting forth the name of the Court, the name of the Debtor, the lead case number, and the title of the Notice to which the Response is directed;
  - b. the name of the Satisfied Claimant, the claim number or scheduled number, and a description of the basis for the amount of the Satisfied Claim that the Satisfied Claimant is contesting has not been satisfied, if applicable;
  - c. the specific factual basis and supporting legal argument upon which the party will rely in opposing this Notice;

- d. all documentation and other evidence in support of the Satisfied Claim, not previously filed with the Court or the Claims agent, upon which the Satisfied Claimant will rely in opposing this Notice; and
- e. the name, address, telephone number, fax number and/or email address of the person(s) (which may be the Satisfied Claimant or the Satisfied Claimant's legal representative) with whom counsel for the Debtors should communicate with respect to the Satisfied Claim or the Notice and who possesses authority to reconcile, settle, or otherwise resolve any issues relating to the Satisfied Claim on behalf of the Satisfied Claimant.

11. Upon the Debtors' receipt of a Response, the Debtors will determine whether there is a basis upon which to sustain the Satisfied Claimant's assertion that its Satisfied Claim has not in fact been satisfied. In the event the parties are unable to reach a resolution, the Debtors may schedule a hearing on the Satisfied Claim. The Debtors reserve the right to contest any new assertions of liability against the Debtors made by Satisfied Claimants with respect to their Satisfied Claims.

12. If a Satisfied Claimant fails to file and serve a timely Response by the Response Deadline, (a) the Satisfied Claimant is deemed to have consented to this Notice and the Debtors' determination with respect to its Satisfied Claim, as set forth herein, and (b) the Claims Agent shall immediately, and without further notice to any party (including the Satisfied Claimant), mark such Satisfied Claim as fully satisfied on the Claims Register.

#### **Reservation of Rights**

13. The Debtors hereby reserve their right to (a) amend, modify, and supplement this Notice, and (b) file additional objections to any Claims in these chapter 11 cases that have been or may be asserted against the Debtors on any grounds.

14. Nothing contained in this Notice or the attached exhibit shall be construed as a waiver of any rights that the Debtors may have: (a) to bring avoidance actions under the applicable

provisions of the Bankruptcy Code against the holder of any disputed claim, or (b) to exercise their rights of setoff against the holders of such claims relating to such avoidance actions.
