**PLEASE TAKE NOTICE** that on April 9, 2025, the Plan Administrator became aware that phishing emails from donotreply@ra-kroll.com purporting to be the Plan Administrator’s notice and claims agent, Kroll, were being sent requesting creditors to provide wallet details and additional information to complete their Crypto Loss Claim submission. A copy of such email is attached to this notice as **Exhibit A**.

**PLEASE TAKE FURTHER NOTICE** that these emails are ***not an authorized message from the Plan Administrator’s notice and claims agent Kroll and are likely a phishing scam.***

**PLEASE TAKE FURTHER NOTICE** that the only valid website domains for the submission of Crypto Loss Claims are claims.terra.money and https://register-terra.issuer-cloud.com. Valid e-mails from Kroll use the domain “ra.kroll.com”—not “ra-kroll.com.”
