ORDER SUSTAINING LIQUIDATING TRUSTEE'S FIRST OMNIBUS OBJECTION TO THE ALLOWANCE OF CERTAIN EMPLOYEE CLAIMS (RECLASSIFY CERTAIN EMPLOYEE CLAIMS)

THIS MATTER came before the Court to consider the Liquidating Trustee's First Omnibus Objection to the Allowance of Certain Employee Claims (Reclassify Certain Employee Claims) [Dkt. No. 300] (the "Objection") filed on March 5, 2025, by Katie S. Goodman (the "Liquidating Trustee"), in her capacity as the liquidating trustee of the Envistacom Liquidating Trust created pursuant to the confirmed Debtor's Second Modified First Amended Combined Disclosure Statement and Chapter 11 Plan of Liquidation [Dkt. No. 197] (the "Plan") in the

above-styled Chapter 11 case (the "Bankruptcy Case"). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Objection.

Pursuant to the procedures established under this Court's Second Amended and Restated General Order No. 24-2018, the claimants listed on Exhibit A hereto (collectively, the "Claimants") were provided with due and proper notice of the Objection, the deadline of April 4, 2025 (the "Response Deadline"), to file a response in opposition thereto, and the hearing scheduled for April 17, 2025, to consider the Objection and any timely filed response thereto. It appears from the record that no response to the Objection was filed prior to the Response Deadline by any of the Claimants. Therefore, after considering the Objection and all other matters of record, including the lack of any response filed in opposition to the Objection, the Court finds that no further notice or hearing on the Objection is required, and that good cause exists to grant the relief sought in the Objection. Accordingly, it is hereby ORDERED, ADJUDGED, AND DECREED, as follows:

- 1. The Objection is SUSTAINED, as set forth herein.
- 2. The priority unsecured claims (the "Claims") listed on Exhibit A in the amounts shown on Exhibit A filed by the Claimants (designated with the claim numbers shown on Exhibit A as reflected on the claims docket maintained by Epiq Corporate Restructuring, LLC, the claims agent appointed in the Bankruptcy Case, which Claims were not filed on the Bankruptcy Court's ECF Claims Docket), are hereby ALLOWED IN PART as priority unsecured claims in the amounts shown on Exhibit A and shall be treated as Class 1 Claims under the Plan in such amounts, and RECLASSIFIED IN PART AND ALLOWED as general unsecured claims in

the amounts shown on Exhibit A and shall be treated as Class 4 Claims under the Plan in such amounts.

3. This Court shall retain jurisdiction to hear and determine all matters arising from or related to the implementation, interpretation or enforcement of this Order.
