DECLARATION OF EMILY YOUNG, ON BEHALF OF EPIQ CORPORATE RESTRUCTURING, LLC, REGARDING SOLICITATION AND TABULATION OF BALLOTS CAST IN CONNECTION WITH ITS FIRST AMENDED JOINT CHAPTER 11 PLAN OF REORGANIZATION OF WELLPATH HOLDINGS, INC. AND CERTAIN OF ITS DEBTOR AFFILIATES

I, Emily Young, hereby declare as follows under penalty of perjury that the following is true and correct to the best of my knowledge, information, and belief:

1. I am a Director of Epiq Corporate Restructuring, LLC ("Epiq") located at 777 Third

Avenue, 12th Floor, New York, New York 10017. I am over the age of 18 years. I do not have a direct interest in the above-captioned chapter 11 cases and should be considered an impartial party.

2. I submit this declaration (the "<u>Declaration</u>") with respect to the solicitation and tabulation of votes cast in connection with the *First Amended Joint Chapter 11 Plan of Reorganization of Wellpath Holdings, Inc. and Certain of its Debtor Affiliates* [Docket No. 2376] (including all appendices, exhibits, schedules, and supplements (including any Plan Supplement) thereto, the "<u>Plan</u>").²

3. Except as otherwise indicated herein, all facts set forth herein are based upon my personal knowledge or my review of relevant documents. I am authorized to submit this Declaration on behalf of Epiq. If I were called upon to testify, I could and would testify competently as to the facts set forth herein.

4. Pursuant to the (a) Order Authorizing the Employment and Retention of Epiq Corporate Restructuring, LLC as Claims, Noticing, and Solicitation Agent [Docket No. 29] (the "Epiq Retention Order") and (b) Order (I) Approving the Adequacy of the Disclosure Statement on a Conditional Basis, (II) Approving the Solicitation and Notice Procedures with Respect to Confirmation of the Debtors' Proposed Joint Plan of Reorganization, (III) Approving the Forms of Ballots and Notices in Connection Therewith, (IV) Scheduling Certain Dates with Thereto, (V) Granting Related Relief [Docket 1867] Respect and No. (the "Disclosure Statement Order"), Epiq was appointed and authorized to assist the Debtors with, among other things, soliciting, receiving, reviewing, determining the validity of, and tabulating Ballots cast in connection with the Plan by Holders of Claims in the Voting Classes (as defined herein).

5. As set forth in the Disclosure Statement Order, the Bankruptcy Court established March 11, 2025 as the record date (the "<u>Voting Record Date</u>") for determining which Holders of Claims within the Voting Classes were entitled to vote on the Plan. Holders of Claims that filed a Proof of Claim after the Voting Record Date, but on or prior to 4:00 p.m. (prevailing Central Time) on April 7, 2025 (the "<u>General Bar Date</u>"), were distributed a Solicitation Package as soon as reasonably practicable after receipt of such Proof of Claim.

6. Pursuant to the Plan, only Holders of Claims in the following Classes (together, the "<u>Voting Classes</u>") were entitled to vote to accept or reject the Plan:

Class	Description
Class 3	First Lien Secured Claims
Class 5	Second Lien Deficiency Claims
Class 6	General Unsecured Claims

7. The procedures for the solicitation and tabulation of votes on the Plan are outlined in the Disclosure Statement Order (collectively, the "<u>Solicitation Procedures</u>"). Epiq was instructed by the Debtors to solicit, review, determine the validity of, and tabulate Ballots submitted with respect to the Plan by the Holders of Claims in the Voting Classes in accordance with the Disclosure Statement Order. In addition, Epiq consulted with the Debtors and their counsel, as appropriate, to ensure compliance with the Disclosure Statement Order. I supervised the solicitation and tabulation performed by Epiq's employees.

8. In accordance with the Disclosure Statement Order, starting on March 20, 2025, Epiq caused to be served the (a) Confirmation Hearing Notice on the parties listed in the creditor matrix and all other parties entitled to receive such notice pursuant to the Disclosure Statement Order, (b) Solicitation Packages on Holders of Claims in the Voting Classes as of the Voting Record Date, (c) Disputed Claims Notices on Holders of General Unsecured Claims in Class 6 that are subject to a pending objection by the Debtors,³ and (d) Non-Voting Status Notices on Holders of Claims and Interest in Class 1 (Other Secured Claims), Class 2 (Other Priority Claims), Class 9 (Existing Parent Interests), and Class 10 (Section 510(b) Claims). Epiq filed the *Revised Certificate of Service* on March 26, 2025 [Docket No. 1993], *Supplemental Certificate of Service* on March

31, 2025 [Docket No. 2037], *Certificate of Service* on April 8, 2025 [Docket No. 2121], and the *Supplemental Certificate of Service* on April 18, 2025 [Docket No. 2315].

9. Each Ballot received by Epiq was date-stamped upon receipt, scanned (if submitted on paper), assigned a ballot number, entered into Epiq's voting database, and processed in accordance with the Disclosure Statement Order.

10. Epiq received, reviewed, determined the validity of, and tabulated the Ballots submitted to vote on the Plan. In order for a Ballot to be counted as valid, the Ballot must have been (a) properly completed in accordance with the Disclosure Statement Order, (b) executed by the relevant Holder or such Holder's authorized representative, (c) returned to Epiq via an approved method of delivery as set forth in the Disclosure Statement Order, and (d) received by Epiq, the Debtors, or the Bankruptcy Court by no later than 4:00 p.m. (prevailing Central Time) on April 22, 2025 (the "<u>Voting Deadline</u>").⁴

11. All validly executed and completed Ballots cast by Holders of Claims in the Voting Classes received by Epiq on or before the Voting Deadline were tabulated in accordance with the Solicitation Procedures. I declare that the results of the voting by Holders of Claims in the Voting Classes are as set forth in <u>Exhibit A</u> hereto, which is a true and correct copy of the final tabulation of votes cast by timely and properly executed and completed Ballots received by Epiq, the Debtors, or the Bankruptcy Court.

12. A report of all Ballots received but not included in the tabulation prepared by Epiq, as well as the reasons for exclusion of such Ballots, is attached as **Exhibit B** hereto.

13. The Ballots (for Voting Classes) and Opt Out Forms (for Non-Voting Classes) also included instructions regarding how to elect to opt out of the releases set forth in the Plan by checking the box in Item 2 of the Ballot or Item 1 of the Opt Out Form (the "<u>Opt Out Election</u>"). Attached hereto as <u>Exhibit C</u> is a report of parties that (a) checked the Opt Out Election box on their submitted Ballot, (b) returned an Opt Out Form that included a checked Opt Out Election box, (c) returned an Opt Out Form without checking the Opt Out Election box, or (d) elected to opt out of the releases via another mechanism as set forth in the Plan as of the Voting Deadline.⁵ A total of 969 Holders of Claims or Interests returned their Ballot or Opt Out Form, as applicable, with the Opt Out Election box checked. In addition, 312 individuals affirmatively opted out of the Third-Party Release via another mechanism as set forth in the Plan. Thus far, of the 1,291 parties that elected to opt out of the releases, 351 are incarcerated individuals.

14. Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing information concerning the distribution, submission, and tabulation of Ballots in connection with the Plan is true and correct to the best of my knowledge, information, and belief.
