**CERTIFICATE OF NO OBJECTION TO ENTRY OF A FINAL ORDER ON
NITRO DOWNHOLE, LLC’S EMERGENCY MOTION FOR ENTRY OF INTERIM
AND FINAL ORDERS AUTHORIZING (A) THE MAINTENANCE OF THE CASH
MANAGEMENT SYSTEMS; (B) MAINTENANCE OF THE EXISTING BANK
ACCOUNTS; (C) CONTINUED USE OF EXISTING BUSINESS FORMS; AND
(D) GRANTING RELATED RELIEF

On April 8, 2025, Nitro Downhole, LLC (“Downhole” or the “Debtor”) filed its *Emergency Motion for Entry of Interim and Final Orders Authorizing (a) the Maintenance of the Cash Management Systems; (b) Maintenance of the Existing Bank Accounts; (c) Continued Use of Existing Business Forms; and (d) Granting Related Relief* [Docket No. 8 in Case No. 25-60027] (the “Motion”).

On April 10, 2025, following an emergency hearing on the Motion, this Court entered the *Interim Order Authorizing (a) the Maintenance of the Downhole Cash Management System; (b) Maintenance of the Existing Downhole Bank Accounts; (c) Continued Use of Existing Business Forms of Downhole; and (d) Granting Related Relief* [Docket No. 511 in Case No. 24-60018].
