ROMAN CATHOLIC ARCHBISHOP OF BALTIMORE'S RESPONSE TO THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS' EXPEDITED MOTION FOR (I) RELIEF FROM THE AUTOMATIC STAY PURSUANT TO 11 U.S.C. § 362(d)(1) AND (II) AN ORDER ESTABLISHING THE DATE ON WHICH PROOFS OF CLAIM INITIATED OR COMMENCED A PROCEEDING UNDER MARYLAND'S CVA

The Roman Catholic Archbishop of Baltimore (the "Debtor"), by and through its undersigned counsel, files this response to The Official Committee of Unsecured Creditors' Expedited Motion for (I) Relief From the Automatic Stay Pursuant to 11 U.S.C. § 362(d)(1) and (II) an Order Establishing the Date on Which Proofs of Claim Initiated or Commenced a Proceeding Under Maryland's CVA (Dkt. No. 1043) (the "Motion") and, in response to the Motion, the Debtor respectfully states as follows:

## **BACKGROUND**

- 1. On September 29, 2023 (the "*Petition Date*"), the Debtor commenced the above-captioned chapter 11 proceeding by filing a voluntary petition for relief in this Court.
- 2. On the Petition Date, the Debtor filed the *Debtor's Motion for Entry of an Order,*Pursuant to Sections 105(a) and 362 of the Bankruptcy Code, Extending the Automatic Stay (Dkt.

  No. 12) (the "Extend Stay Motion").

- 3. On October 4, 2023, this Court entered the *Interim Order, Pursuant to Sections* 105(a) and 362 of the Bankruptcy Code, Clarifying the Extent of the Automatic Stay With Respect to Certain Related Entities and Insurance Coverage (Dkt. No. 52) (the "First Interim Stay Order").
  - 4. The First Interim Stay Order provides, in relevant part:

The Debtor's insurance policies are property of the Debtor's estate.

Pursuant to section 362(a)(3) of the Bankruptcy Code, the automatic stay operates as a stay, applicable to all entities, of any act to obtain possession of property of the Debtor's estate or of property from the Debtor's estate or to exercise control over property of the Debtor's estate.

Therefore, any action taken by a third party, including without limitation parties asserting Abuse Action(s), that could have an effect on property of the Debtor's estate, including without limitation any action that triggers or would otherwise diminish coverage under the Debtor's insurance policies, is hereby stayed by the automatic stay pursuant to sections 105(a) and 362(a)(3) of the Bankruptcy Code until the conclusion of the Final Hearing, as defined herein.

Any party seeking to file an Abuse Action against any entity or individual that is not the Debtor may provide the names of the intended defendant(s) to counsel for the Debtor. Within two (2) business days of receiving the identities of any intended defendant(s), counsel for the Debtor will provide notice of whether the Debtor believes such intended defendant(s) are covered by the Debtor's insurance policies.

(Dkt. No. 52,  $\P$  2–4.) (emphasis added).

- 5. On November 6, 2023, this Court entered the Second Interim Order, Pursuant to Sections 105(a) and 362 of the Bankruptcy Code, Extending the Automatic Stay to Certain Related Entities (Dkt. No. 173) (the "Second Interim Stay Order"), which provided the same relief as the First Interim Stay Order.
  - 6. As of the date of this response, the Second Interim Stay Order is still in effect.

## ARGUMENT

7. For the reasons set forth below, the relief from stay sought in the Motion is overbroad, unnecessary, and should not be granted.

## I. Cause does not exist for relief from the automatic stay or Second Interim Stay Order.

8. Cause does not exist in this case for at least three reasons: (a) section 502 of the Bankruptcy Code establishes the date as of which claims are valued; (b) section 108(c) of the Bankruptcy Code stays the running of any deadlines established under nonbankruptcy law for claims that are affected by the automatic stay; and (c) the Second Interim Stay Order already provides adequate protections for creditors.

## A. <u>Section 502 of the Bankruptcy Code governs valuation of all Abuse Claims.</u>

9. Section 502 of the Bankruptcy Code governs the valuation of any claims filed in a bankruptcy proceeding:

[I]f [an] objection to a claim is made, the court, after notice and a hearing, shall determine the amount of such claim in lawful currency of the United States as of the date of the filing of the petition . . . .

11 U.S.C. § 502(b) (emphasis added). *See also In re USGen New England, Inc.*, 429 B.R. 437 (Bankr. Md. 2010) ("Section 502(b) prevents the value of a claim from fluctuating by freezing the claim as of the petition date and converting it to United States dollars." (quoting *In re Aaura, Inc.*, 2006 WL 2568048, \*4 n.5 (Bankr. N.D. Ill. Sept. 1, 2006))).

10. As a result of the language in section 502 of the Bankruptcy Code, the subsequent passage of a law changing the applicable law as of the Petition Date has no impact on the valuation of claims in this bankruptcy proceeding.

## B. Section 108(c) of the Bankruptcy Code extends any nonbankruptcy law deadlines.

11. Section 108(c) of the Bankruptcy Code provides:

Except as provided in section 524 of this title, if applicable nonbankruptcy law, an order entered in a nonbankruptcy proceeding, or an agreement fixes a period for commencing or continuing a civil action in a court other than a bankruptcy court on a claim against the debtor . . . and such period has not expired before the date of the filing of the petition, then such period does not expire until the later of—

- (1) the end of such period, including any suspension of such period occurring on or after the commencement of the case; or
- (2) 30 days after notice of the termination or expiration of the stay under section 362, 922, 120, or 1301 of this title, as the case may be, with respect to such claim.

## 11 U.S.C. § 108(c).

- 12. By its plain language, section 108(c) would extend the period of time set forth in the amendment to the CVA with respect to the Debtor.
- 13. Similarly, section 108(c) extends the deadlines of any other claims stayed by application of the automatic stay under, among other provisions, section 362(a)(3) of the Bankruptcy Code, regardless whether those claims involve the Debtor or only property of the Debtor (i.e., the Debtor's insurance). *See, e.g., Valley Transit Mix of Ruidoso, Inc. v. Miller*, 928 F.2d 354, 356 (10th Cir. 1991) (holding the automatic stay applied to stay a mechanics' lien foreclosure claim against owners of property leased by the debtor and, correspondingly, that section 108(c) tolled such claims again the nondebtor parties as well as the debtor).
- 14. Accordingly, any deadlines applicable to claims that are stayed under the Second Interim Stay Order would be tolled by operation of section 108(c) of the Bankruptcy Code.

## C. The Second Interim Stay Order already provides necessary protections.

15. Since entry of the Second Interim Stay Order, any party seeking to file an Abuse Action against any entity or individual that is not the Debtor was permitted to provide the names of the intended defendant(s) to counsel for the Debtor with counsel for the Debtor indicating

whether such entity or individual is or is not protected by the automatic stay by virtue of its participation in the Debtor's insurance programs.

16. To date, the Debtor has responded to numerous such inquiries, in each instance providing responses as to whether certain entities and individuals were protected by the automatic stay.

## D. The Debtor has provided substantial information regarding entities subject to the Second Interim Stay Order.

- 17. In addition, on March 28, 2024, the Debtor caused to be filed an adversary complaint (the "Insurance Complaint") and subsequently an amended adversary complaint (the "Amended Insurance Complaint"), commencing an adversary proceeding, which was docketed as adversary proceeding number 24-00072.
- 18. In each of the Insurance Complaint and Amended Insurance Complaint, the Debtor identified the parishes, schools, and other affiliated entities the Debtor believed at that time either were participating in the Debtor's insurance program or at some point in the past had participated in the Debtor's insurance program.
- 19. More specifically, the Debtor identified in paragraphs 4 through 199 of the Insurance Complaint and paragraphs 10 through 205 of the Amended Insurance Complaint the entities the Debtor believed at that time either were participating in the Debtor's insurance program or at some point in the past had participated in the Debtor's insurance program.
- 20. In addition, since at least October 1, 2024, the Debtor has made available to the Committee and all other parties to the mediation a schedule of all claims the Debtor believes implicate entities that are not related to the Debtor.
- 21. With respect to claims the Debtor does not believe assert claims against the Debtor, the Debtor indicated, among other things, one or more of the following:

- a. the alleged abuser was the claimant's family member;
- b. the alleged abuser was a friend of the family and the abuse did not occur at a location that was not associated with the Debtor and was not insured by the Debtor; or
- c. the alleged abuser was not an agent of the Debtor or any entity related to the Debtor and the abuse did not occur at a location associated with or insured by the Debtor.
- 22. With respect to claims the Debtor believes implicate other individuals or entities that are not related to the Debtor, the Debtor indicated, among other things, one or more of the following:
  - a. the alleged abuser was not an agent of the Debtor or an entity related to the
    Debtor, but the abuse is alleged to have occurred at a location insured by
    the Debtor; or
  - b. the alleged abuser was an agent of the Debtor or an entity related to the Debtor, but the abuse is alleged to have occurred at a location unrelated to and not insured by the Debtor.
- 23. In addition, on January 24, 2025, the Debtor updated the foregoing analysis, providing it again to the Committee and all parties to the ongoing mediation.
- 24. Further, since at least February 9, 2024, the Debtor has provided to the Committee a schedule of all parish corporations and the names of all schools and school corporations associated with the Debtor.
- 25. Finally, the Debtor filed on the Petition Date an information brief identifying a number of other entities related to the Debtor.

- 26. While the Debtor is entirely uncertain from where the Committee derived its list of individuals and entities the Committee attached to the Motion,<sup>2</sup> attached to this response as:

  (a) Schedule A is the most updated schedule of claims the Debtor has currently identified as not asserting claims against the Debtor, in full or part; and (b) Schedule B is the most updated schedule of claims the Debtor has currently identified as asserting claims against entities potentially jointly liable with the Debtor but which do not participate in the Debtor's insurance program.
- 27. Similarly, attached to this response: (a) as <u>Schedule C</u> is the schedule of parish corporations provided to the Committee by the Debtor; and (b) as <u>Schedule D</u> is the schedule of schools and school corporations provided to the Committee by the Debtor.
- 28. To the extent any claimant identified on <u>Schedule A</u> or <u>Schedule B</u> desires to commence an action before the June 1, 2025 deadline, or any claimant seeks to commence an action against an entity not identified in the Insurance Adversary Complaint, Amended Insurance Adversary Complaint, <u>Schedule C</u>, <u>Schedule D</u>, or the *Informational Brief of the Roman Catholic Archbishop of Baltimore* (Dkt. No. 5), such claimant may utilize the procedures that have been available for more than five hundred seventy (570) days to determine whether the commencement of such action is affected by the automatic stay in this case.
- 29. Finally, attached as **Schedule E** to this response is a schedule of entities the Debtor has previously identified as not being covered by the Debtor's insurance program and therefore not protected by the automatic stay in this case.

## II. The alternative relief sought is unnecessary.<sup>3</sup>

- 30. Notwithstanding the inappropriate nature of combining the additional request for relief with a request for relief from the automatic stay, the additional relief is unnecessary for the same reasons relief from the automatic stay is unwarranted: (a) section 502 of the Bankruptcy Code governs the valuation of any claims in this bankruptcy proceeding; and (b) section 108(c) of the Bankruptcy Code provides for the extension of any nonbankruptcy law deadlines during all times the automatic stay is in effect.
- 31. Accordingly, insofar as the alternative relief relates to claims asserted against the Debtor, the Debtor does not oppose the relief sought in Paragraph 57 of the Motion.
- 32. More specifically, the Debtor does not oppose a finding by this Court that Survivors (as defined in the Motion) who file an action in Maryland's courts within thirty (30) days after the termination of the automatic stay or dismissal of this case are entitled to treatment as if they filed their action prior to the June 1, 2025 effective date of the CVA Amendment (as defined in the Motion).

## **CONCLUSION**

33. For the reasons set forth above, cause does not exist to lift the stay, permitting the filing of untold numbers of civil actions that will almost certainly never be pursued but will cost untold amounts in time and money for Survivors, the Debtor, and entities related to the Debtor.

<sup>&</sup>lt;sup>3</sup> The alternative relief sought is also inappropriately combined with the request for relief from the automatic stay in the Motion. Local Bankruptcy Rule 4001-1(a) provides that a motion for relief from the automatic stay may not be combined with a request for any other relief, except for adequate protection, for relief from the co-debtor stay under 11 U.S.C. § 1201(a) or § 1301(a), to extend the bar date after foreclosure as permitted by Local Bankruptcy Rule 4001-3(b), or for prospective relief under (a)(2) below. L.B.R. 4001-1(a)(1). Therefore, the alternative relief sought in the Motion does not comply with Local Bankruptcy Rule 4001-1(a).

- 34. While the Committee has inappropriately requested additional relief in the Motion, the Debtor is not opposed to the more appropriate and limited relief providing that Survivors whose claims are currently stayed get the benefit of section 108(c) of the Bankruptcy Code.
- 35. Any additional relief, however, would be overbroad, unnecessary, and will divert significant time and resources away from the resolution of this case.
